They noted that approximately 75 estates were due to be taken in charge and that the process needs to be accelerated with additional funding required to do this. The A/Director, Planning, Environment and Place-Making confirmed that the cost of taking in charge of individual estates varied across the city and county. She also confirmed that a new inspection programme was being introduced in relation to this and that a regular update would be provided to the Members at Metropolitan and Municipal District level.

The allocations were noted by the Council.

7. Community, Tourism and Culture

(a) Grants under the Arts Act

Circulated, report of the Arts Officer dated 15th March, 2023, seeking the Council's approval to recommended grants, as set out in the report, under the Arts Act, 2003.

Proposed by Councillor O'Sullivan;
Seconded by Councillor O'Hanlon;
And Resolved:

"That, the approval of the Council be and is hereby given to the payment of grants under the Arts Act, 2003, as recommended, and as set out in the report of the Arts Officer dated 15th March, 2023."

Some Members agreed that it was important that an appropriate balance in the distribution of funding be maintained between the City and County to ensure full access to support funding by all involved in the arts.

(b) Local Community Development Committee Annual Report 2022

Circulated, report of the LCDC Chief Officer, Community, Tourism and Culture Directorate, dated 9th March, 2023, enclosing 2022 Annual Report of the Limerick Local Community Development Committee.

The LCDC Annual Report was noted by the Members.

QUESTION

The Reply to the following Question on the agenda was circulated to all Members prior to the Meeting and the Question was therefore considered as having been dealt with:

9. Question submitted by Councillor J. Scanlan

I will ask at the next Meeting how many people are qualified for housing within each Municipal District; also, what the total number for our Authority now stands at.

REPLY: The total number of qualified social housing applicants for Limerick City and County Council is 5,843 as at 28th February, 2023. This figure includes those currently in HAP/RAS accommodation and those on the Council's transfer list.

The number of qualified social housing applicants for Limerick City and County Council net of HAP/RAS and Council Transfers is 2,301.

All applicants for social housing support can select a maximum number of three Areas of Choice and make their selection on the housing application form. The areas of choice are listed on the application form under the relevant Municipal District/Metropolitan District.

The number of people qualified who have selected their areas of choice under the various Municipal Districts is set out below as per their First Area of Choice and is based on the net number of qualified applicants (not all applicants wish to select three areas) -

NOTICES OF MOTION

10. Notice of Motion submitted by Councillor L. Galvin

I will move at the next Meeting that, in view of the 50% vacant commercial rate demand, this Council (a) facilitates that in situations where property owners have converted a property from commercial to residential without planning, that they will be permitted to do the reverse {i.e. convert from residential to commercial without planning} should there be demand for commercial properties in the future; and (b) in situations where commercial property owners convert their vacant commercial properties to residential units, either a

grant be made available or tax relief be applied to defray a portion of the costs involved in the conversion of the property by the Department of Housing.

The Motion was proposed by Councillor Galvin and seconded by Councillor Teskey.

REPLY: (a) Exemptions that exist in relation to change of use of a premises from commercial to residential use is set out in the Planning and Development Regulations 2001 (as amended) and enacted by the Minister for Housing, Local Government and Heritage. Accordingly, the Local Authority has no powers in relation to amending this legislation.

(b) The Local Authority operates a number of schemes to support property owners to redevelop existing properties, any new scheme proposed, would require support from the Department, to enable the Local Authority to implement.

Councillor Galvin proposed an amendment to the Motion to read as follows:

I will move at the next Meeting that Limerick City and County Council call on the Minister for Housing, Local Government and Heritage to review planning legislation in view of the 50% vacant commercial rate demand to (a) facilitate that in situations where property owners have converted a property from commercial to residential without planning, that they will be permitted to do the reverse {i.e. convert from residential to commercial without planning} should there be demand for commercial properties in the future; and (b) in situations where commercial property owners convert their vacant commercial properties to residential units, either a grant be made available or tax relief be applied to defray a portion of the costs involved in the conversion of the property by the Department of Housing.

The amended Motion was seconded by Councillor Keary and agreed.

11. Notice of Motion submitted by the Municipal District of Newcastle West - Councillors J. Sheahan (Proposer), M. Collins, F. Foley, J. Scanlan, L. Galvin, T. Ruddle

We will move at the next Meeting that Limerick City and County Council call on the Minister for Housing, Local Government and Heritage to review the Croí Cónaithe Scheme to include derelict units that will be refurbished and made ready for the rental market and not just principal places of residence for the owner.

At the request of Councillor J. Sheahan and with the agreement of the Meeting, this Motion was withdrawn.

12. Notice of Motion submitted by Councillor S. Keary

I will move at the next Meeting that as a result of this Authority deciding to change its mind on the intended use of the former Bank of Ireland building which it recently purchased at

Askeaton, Co. Limerick, from Community/Commercial use to Residential use to facilitate approximately 22 no. Ukrainian Citizens at this location - I am satisfied that this building will be refurbished and used as temporary residential accommodation for a period of two years as stated by a member of the Council Executive. But, I am requesting that the process to prepare a feasibility study to establish its future community use and the preparation of a Part 8 Planning Application for a change of use to its intended use would commence immediately and be shovel-ready for inclusion for grant applications under Town and Village Renewal Programmes and other sources of funding. I also request that the study include the Bank of Ireland building in Abbeyfeale.

The Motion was proposed by Councillor Keary and seconded by Councillor Sheahan (K).

REPLY: The Council will progress with the procurement of Consultants to undertake a feasibility study for the Askeaton Bank Building as soon as possible.

The Council has already gone out to tender for Consultants to undertake the feasibility study for the Abbeyfeale Bank Building and the tender assessment will be undertaken in the coming weeks with a view to Consultants being appointed in April/May 2023.

13. Notice of Motion submitted by the Municipal District of Adare-Rathkeale - Councillors B. Collins (Proposer), J. O'Donoghue, K. Sheahan, S. Keary, A. Teskey

We will move at the next Meeting that the tenants of Approved Housing Bodies be given the same rights as local authority housing tenants in the option of purchasing their rented home, should they wish to do so.

The Motion was proposed by Councillor Collins (B).

The Members agreed that it was important that tenants across all social housing categories be treated fairly and consistently. They agreed that most tenants do not understand what was the difference in tenure type and what possible options were available to them re the right to purchase, etc., so they agreed that it was important that there was consistency in approach.

Members also noted concerns regarding the ongoing management of individual housing associations due to the age profile of committees involved in their original set up, and who would continue the management of same going forward.

REPLY: If an Approved Housing Body (AHB) is in receipt of funding under a scheme (e.g. CALF or CAS), they must comply with the terms and conditions of that scheme. Under such schemes, the AHB is legally required to make the property available for social renting for the duration of the mortgage or leasing agreement (e.g. 25 years).

Section 45 of the Housing (Miscellaneous Provisions) Act, 2009, does provide for the sale by local authorities and AHBs of designated new houses to eligible households and the associated Housing (Incremental Purchase) Regulations 2010 (S.I. 252 of 2010).

In addition, if a property is owned outright by an AHB and it is not subject to public funding, the AHB may choose to sell that property, once this is allowed for in their constitution.

However, it is our understanding that any sales would have to be initiated by the AHB in question. There is no direction from the Department of Housing, Local Government and Heritage to compel the AHB Sector to initiate the sale of new houses.

Should this Notice of Motion be passed, we would recommend that we write to the Minister to consider same and a copy of this Notice of Motion is forwarded to the Housing Commission.

The Motion was seconded by Councillor Keary and adopted.

14. Notice of Motion submitted by Councillors P.J. Carey, E. Ryan and G. Mitchell

We will move at the next Meeting that Limerick City and County Council call on the Minister for Housing, Local Government and Heritage to review the Derelict Sites Act, 1990, in accordance and with respect to property rights as determined in Article 40.3.2 and Article 43 of Bunreacht na hÉireann.

At the request of Councillor Carey and with the agreement of the Meeting, this Motion was withdrawn.

15. Notice of Motion submitted by Councillor O. O'Sullivan

I will move at the next Meeting that Limerick City and County Council write to the Minister for Health asking that immediate access be granted to Kaftrio for the 35 children in Ireland with Cystic Fibrosis excluded from accessing this drug.

At the request of Councillor O'Sullivan and with the agreement of the Meeting, this Notice of Motion was withdrawn. Councillor O'Sullivan welcomed the recent announcement that the Minister for Health had agreed to the drug being provided.

16. Correspondence
