**Proposed Land Disposal of 0.6 Acres (0.25 hectares) of land at Garrane Beg, Pallasgreen to
Health Service Executive**



1. Introduction

It is intended that the following proposed disposal of lands to the Health Service Executive comprising 0.0245 hectares (245 m/sq) (map and photo attached in this report) will be included on the Agenda for the July Full Council Meeting.

2. History of the Property


Limerick County Council disposed of a site to Thomond Housing Association in 2013 to build 3 properties on a site to the south east of Canon Breen Park, Pallasgreen. Unfortunately, the sale did not provide for connection to the adjacent road network effectively leaving the site land locked. The HSE are progressing the development of the site due to funding issues experienced by Thomond Housing Association. The HSE have requested that LCCC dispose of the area required in order for them to access the site. Agreement to this is conditional on HSE covering LCCC costs and also ensuring right of access over the lands for Pallas Utd soccer club.

3. Key Elements of Proposal

A portion of Folio LK2584 is to be transferred to the Health Service Executive (see map AG/5138 Revision A, area highlighted in red to be transferred). Area to be transferred is 0.0245 hectares (245 m/sq).

4. Executive Recommendation to Council

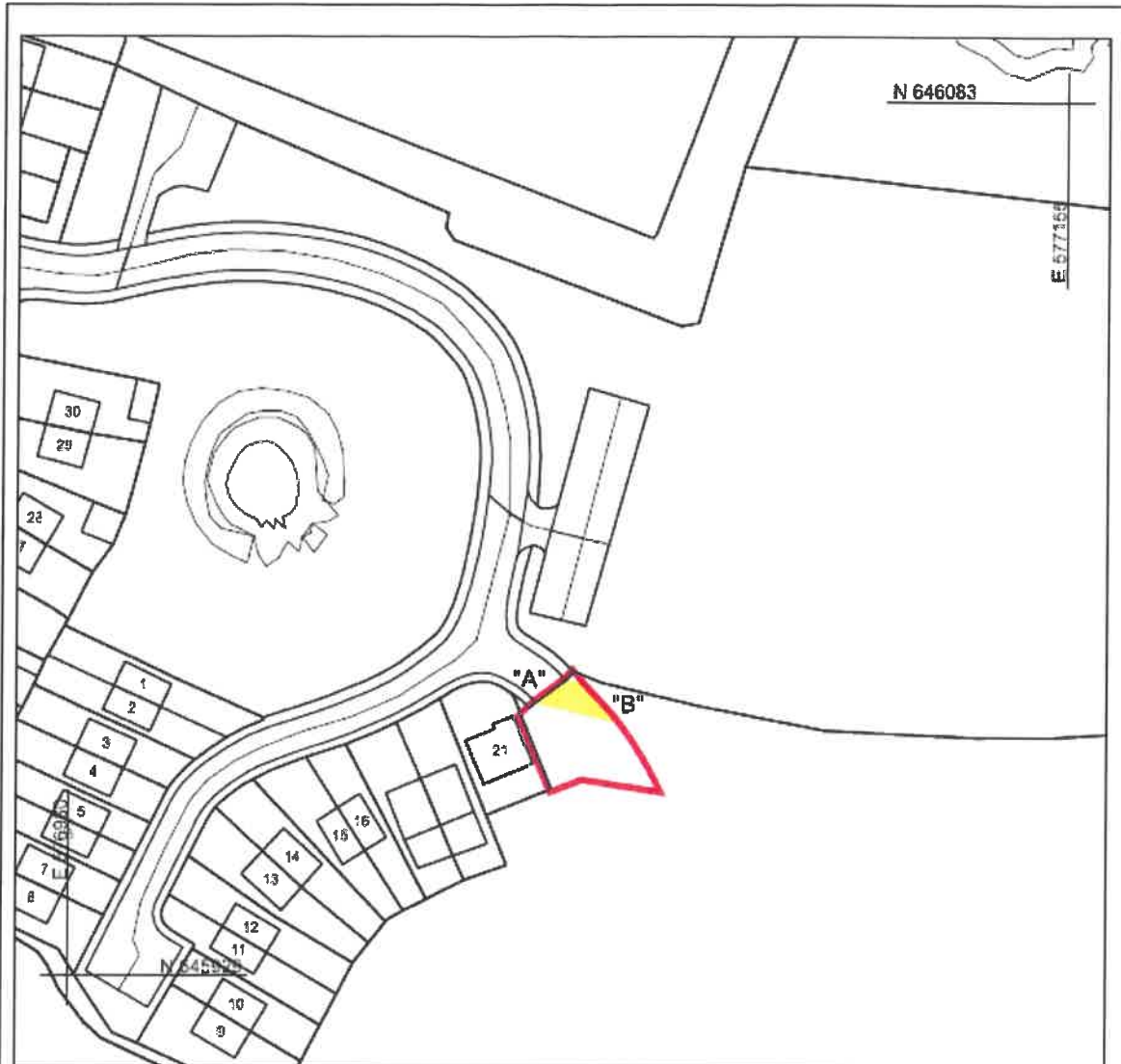
