Jobs and Investments

French company, Expleo, a global engineering, technology, and consulting service, announced that they will open a new Limerick office, bringing their Irish office portfolio to six. The Limerick office is set to create 15 additional jobs, adding to the company's aim of having 1,000 staff in Ireland by the end of 2024. Expleo specialise in quality testing for technology, having previously worked on testing the Covid-19 tracing app.

Dell Technologies has announced the expansion of its Customer Solution Centre Innovation Lab at its campus in Limerick. The lab allows customers to test technologies such as Artificial Intelligence (AI), 5G and edge computing. The expanded capabilities were built in collaboration with Vodafone and Ericsson. The partners, together with NovaUCD, the hub of innovation at University College Dublin, are developing an accelerator programme to support innovative start-ups.

Forbes Under 30 Forum

The Forbes Under 30 Forum came to Limerick on 26 June. Over 140 attendees were treated to a showcase of entrepreneurship and start-up companies in Ireland. The event shone an international spotlight on Irish innovation, while showcasing Limerick's thriving business landscape.

The day-long forum saw a number of speakers share their experiences with business and investment, while the audience had guests from Ireland, Australia, the US and beyond shining a light on the Mid West Region. Speakers included three honourees of the 2023 Forbes 30 Under 30 Europe list, Dan Hobbs, Grainne Mullins and Ruth Williams.

During the afternoon, two groups of event participants dispersed across the city centre for lunch and tours at four locations: STATS Perform, International Rugby Experience, Innovate Limerick and Gardens International. Here the

groups heard from business leaders and executives about their work operating in Limerick and attracting talent into office buildings in the era of remote work.

EU Programmes

Following the submission by the EU Project Office and Environment Department of two EU Funding Applications, Greenplace and BiodiverCity under the URBACT IV Call, notification was received in June confirming that these applications were successful. Both projects will be led by the Environment, Recreation and Climate Change Department. Funding of €70,000 has been approved for each project.

The Green Place Action Planning Network examines changing urban spaces that have lost their current functionality to be friendly to residents, the environment and the city.

The Biodiversity Action Planning Network measures biodiversity in a city and ecosystem services to verify, design and scale up nature-based solutions.

Shannon Conference Bureau

The Tourism Department was delighted to share anniversary celebrations with the Shannon Conference Bureau, celebrating 20 years in existence, promoting the region for visiting conferences and events. In this time, it has attracted blue-chip events worth more than €150m to the local economy. Limerick City and County Council is a significant stakeholder with the Bureau and works very closely with it to attract major sporting events to Limerick.

Festivals and Events

Christmas in Limerick Survey 2023

Christmas in Limerick is a calendar of festive events and offerings delivered by Limerick City and County Council. Each year Limerick has a seasonal mix of everything from Christmas Markets to an ice rink and on-street entertainment.

The survey, which was launched on 26 June, will allow people to have their say on Limerick City and County Council's planning for Christmas in Limerick 2023. It will give people the opportunity to tell us what they would like to see in Limerick this Christmas and is available through MyPoint on Limerick.ie.

Fleadh Cheoil Luimnigh 2023

Limerick City and County Council Festivals and Events grant-aided this year's Fleadh Cheoil which took place from 01 - 05 June. This festival of Irish Traditional Music, Song, Dance, Gaeilge and Culture gives the opportunity for four different age groups to participate in various music, song, dance, storytelling and Comhrá Gaeilge events in the town of Kilfinane.

The Limerick Sings International Choral Festival

Limerick Sings is a non-competitive annual celebration of choral music at the University of Limerick and took place from 09 -11 June. As a choral festival, it welcomes choirs of all traditions and nationalities to come together for a weekend of festive singing while inviting them to explore the amazing locality and sites of the Wild Atlantic Way. It is a celebration of the choral tradition of choral singing, opera and musical theatre, with many choral groups existing and performing for decades in Limerick City. Limerick City and County Council supported this festival with grant funding through the Festivals and Events Grant Scheme.

Welcome to the Neighbourhood 2023

'Welcome to the Neighbourhood' is an annual festival of contemporary art in Askeaton which took place from 12 - 25 June and benefitted from Limerick City and County Council grant funding through the Festivals and Events Grant Scheme. International and Irish artists stayed in the town taking part in residencies, activating and presenting new cultural projects that connect with the unique history and everyday life of Askeaton.

Askeaton native, Jim Clarken (CEO of Oxfam Ireland and an Executive Director at Oxfam International), joined Curator, Michele Horrigan, to give a talk on 22 June. Other events over the festival included 'relatively stable conditions,' Deel River tour which explored the history, traditions and connection the river has with the area.

The Limerick Garden Festival

The Limerick Garden Festival took place on 18 June at Limerick's Milk Market and had an array of exciting plants, garden and food market with over 50 traders from all over Ireland. It featured all-day talks with garden experts. It provided opportunities for gardeners and enthusiasts to see different elements of gardening and enjoy the display of plants and stalls. Limerick City and County Council supported this festival with grant funding through the Festivals and Events Grant Scheme. The Garden Festival broadens the range of festivals and events in Limerick and adds to the diversity of offering at the Milk Market as a venue in the heart of the city.

Engine Short Film Scheme Pitching Weekend

12 teams pitched their Engine short film projects that they have been developing over the past few months with Film in Limerick. The in-person pitches took place at the Engine Collaboration Centre and six projects have been selected to go forward for funding approval. This year's judging panel members were Kate McCullough, cinematographer on the OSCAR-nominated *An Cailín Ciúin*, Fionnuala Halligan, Screen International's executive editor and Grainne Humphreys, Director of the Dublin International Film Festival.

Run by Innovate Limerick through Film in Limerick, Engine Shorts is a partnership between the Local Authorities in Tipperary, Limerick and Clare, and Limerick and Clare Education and Training Board. The new scheme aims to inspire and support up-and-coming writers, directors and producers to create inspiring, engaging world-class short films that resonate with a wide international audience.

Local and Inwards Productions

'Blackshore,' from the makers of 'Smother,' wrapped 13 weeks of filming in Clare and Limerick in June. Film in Limerick assisted with locations, crewing, training, placement and provided production support during the pre-production and production of this new series.

Film in Limerick assisted with three scouting trips in the region in June, arranging tours for US, UK and Irish-based producers seeking locations for feature films and TV series.

Film and TV Crew Academy

A quarterly Film and TV Crew Academy Steering Group meeting took place at Engine in June, focusing on training plans for the coming months and on plans for the upcoming Cineposium conference that Film in Limerick is hosting. A separate meeting was held with the other National Talent Academies to discuss Cineposium and

to plan for Film Week, a series of events for aspiring and experienced filmmakers taking place in Limerick in September.

Evening Course: Managing Tax as a Freelancer

Held over two evenings, this Crew Academy course focused on crew, operating as sole traders or as company owners. The course covered book-keeping, starting your own business and Tax/VAT issues. 27 participants took part in the course.

3. Mid West National Road Design Office

The completed N24 Beary's Cross Road Improvement scheme was officially opened by the Mayor of the City and County of Limerick, Councillor Francis Foley.

The project represents a continuation of the collaboration between Limerick City and County Council and Transport Infrastructure Ireland (TII) in delivering significant capital infrastructure investments in the region. The project was funded by TII as part of Project Ireland 2040. The new junction configuration consists of a roundabout located on the N24 approx. 150m southeast of the original junction, along with the realignment of 400m of the R513 and creation of a cul-de-sac access to the existing properties located on the old R513.

Libraries

- 'Summer Stars' is a free reading programme that takes place in all Limerick Libraries over the summer months as part of the national Right to Read initiative. Limerick Libraries launched this programme for the entire network of branches on 19 June. Children are encouraged to read eight books as part of the programme, and there are rewards and incentives along the way, culminating in a certificate and medal being awarded to all those who complete the programme.
- The 'My Little Library Book Bag' initiative is a collaboration between Public Libraries, the Department of Rural and Community Development, and the Department of Children, Equality, Disability, Integration and Youth as part of the First 5 Strategy. As part of the initiative, a 'My Little Library Book Bag' is available free for every child about to start school to help them to prepare for this big step. Children and their parents/guardians can collect the bags at any library throughout Limerick from 08 June.
- Limerick Libraries were happy to visit the Live 95 radio studios on 27 June to speak on the 'Limerick Today with Joe Nash' show about "Summer Stars," 'My Little Library Book Bag' and other dynamic initiatives available from all branches.
- On 16 June, the City Library was delighted to host its first Fighting Words creative writing workshop, which proved a great success. Third Class from St. Brigid's National School were authors for the day and their hilarious and imaginative story, 'Jake and Joe's Shenanigans,' is now available to be enjoyed online at the Fighting Words website.
- On 15 June, Dr. Robert Collins (author and Lecturer at the University of Limerick) delivered a well-attended talk to mark the 25th anniversary of the Good Friday Agreement. The lecture, entitled 'Irish America and the Path to the Good Friday Agreement,' sparked great engagement and debate from the audience.
- Clare Donnellan from Repak Ireland visited the City Library on 21 June with a special presentation for Fifth and Sixth Class from St. Mary's National School about all things recycling. During the talk, Clare showed some practical examples to the children of what can and cannot be recycled and explained what happens to our recyclables after they have been collected by waste contractors.
- The annual Cruinniú Na nÓg celebrations took place on 10 June and several young people called in to collect this year's Circus Explored-themed spinning plates sets which were made available for free at all branch libraries. They were also treated to the 'This Is Art' digital gallery of young Limerick artists, which was on display throughout the day.
- The ongoing series of Migrant Support Clinics continued across Monday mornings in June. These drop-in clinics are jointly organised by the Limerick and Clare Education and Training Board and PAUL Partnership. The monthly Aphasia Conversation Group met in the community activity room on 30 June and the Writepace creative writing group held their monthly meeting on 10 June.
- Monthly book clubs continued to meet and discuss their chosen reads with seven separate meetings in June. The children's book club for ages 9-12 years had their meeting on 01 June and the Young Adult book club took place on 08 June.
- Róisín Meaney visited on 17 June for her final story time before taking a well-deserved summer break. Also breaking for the summer is the monthly Spanish language storytelling group, 'Cuenta Cuentos,' who held their meeting 13 June.

- Weekly toddler story time continued to entertain an ever-growing group of babies, toddlers and their accompanying adults on Wednesday mornings at 10.30am.
- June proved to be a busy month for school visits, which saw the City Library welcome 16 different class groups from primary schools, Presentation Primary School, CBS Primary School, St. Mary's National School and St. John's National School; and from the city centre English language schools Limerick Student Campus and RightWord.
- In addition to these class visits, the City Library also hosted visits from some of the school summer camps taking place in local primary schools. On 27 June, Presentation Primary School brought a group of 36 children aged seven to nine years for an introduction to the Library and a story time. On 30 June, two groups from St. Mary's National School visited for their library tour and all pledged to complete the annual Summer Stars reading challenge during their summer school break.
- On 23 June, the City Library participated in the national initiative #YourCouncilDay on Limerick City and Council's Twitter account. The City Library had nine different posts on the day highlighting some of the many activities and services offered by the library service. All posts had high levels of engagement with one particular post, a video created by City Library staff, reaching more than 6,800 views.
- Cruinniú na nÓg, the national day of free creativity for children and young people, took place on 10 June and Limerick Libraries were once again delighted to be involved. RTÉ and Creative Ireland teamed up to present This is Art!, Ireland's national young people's art competition. The theme for 2023 was 'This is Inspiration,' encouraging artists to show what inspires them and sparks their creativity, and Limerick's entries were displayed in a digital gallery in library branches across the city and county in: Abbeyfeale, Dooradoyle, Kilmallock, Newcastle West, Watch House Cross and City Library. In the weeks leading up to the day itself, families were invited to call in to one of the seven full-time branches to take away a set of spinning plates as part of the Circus Explored theme, and were also given a link to a video showing them tips and tricks. Each of the seven branches has kept sets for families to borrow over the coming months.
- Glin Library welcomed Claire Flynn from Mental Health Ireland on 07 June for an informative talk on mental health and wellbeing, followed by a lively Question and Answer session. The event was organised and funded by West Limerick Resources. It was a full house for a chair yoga session delivered by instructor, Joanne O'Callaghan, on 08 June. This Healthy Ireland in Your Library event was so popular that requests have been flying in for another session. A local scrabble club returned to playing in the library for the month of June, meeting two to three mornings a week. Glin Library's book club has continued meeting across two days to accommodate its growing numbers, meeting on the 14 and 15 of the month. On 14 June, the library received a surprise visit from second/third class students from St. Fergus National School. Having received an invitation from library staff to sign up for Summer Stars, they returned the following week to collect their colourful bags and reading cards.
- Rathkeale Library hosted an exhibition of paintings by the girls from Fifth Class in St. Anne's Primary School. The exhibition, which featured paintings of Frida Kahlo, was launched on 09 June and sponsored by Rathkeale Together. The paintings are all for sale, with the proceeds going to the school. The library also hosted seven class visits during the month from local primary schools, and a creative writing workshop, which was facilitated by library staff, and a co-ordinator from Fighting Words.
- Adare Library was the venue for Acorn Tablet training classes, which took place on 21 and 28 June. The Acorn Tablet is an Age-Friendly smart tablet designed with the older person in mind and Limerick Libraries have acquired seven in total for loaning to borrowers. The attendees borrowed the tablet for three weeks once the training was finished.

- Newcastle West Library continued weekly activities including the knitting group, class visits and sessions in the Sensory Area. On 14 June, the branch invited thirty children from Mrs. Brosnan's Third Class at Courtenay National School for a talk on recycling from Repak Ireland.
- Kilmallock Library launched its "Summer Stars" reading challenge at the beginning of June and children flocked to receive their registration cards and free book-bags.
- Mid-West Aries (Advancing Recovery in Ireland Education Service) presented two very effective and inspiring wellbeing workshops at Kilmallock Library. On 15 June, the workshop focused on "Creativity for Wellbeing" to broaden people's understanding of creativity and how to weave it into our daily lives. Twenty-five adults eagerly participated and many registered for the workshop on the following week. On 22 June, the theme was "Journaling for Wellbeing." Journaling has long been recognised as an effective way to reduce stress, help with depression and anxiety, focus the mind, and organise your life.
- On 24 June, Kilmallock Library celebrated the opening of The GAFF'S audio and photographic exhibition "Tiny Little Histories," a community-sharing programme that brings untold histories from the Mid-West to life. THE GAFF is a resource for community and voluntary arts in Limerick, facilitating direct connection between artists, communities and the wider public. Through a collaborative arts methodology, Tiny Little Histories embraces a layer of oral history that too often disappears with the passing of generations. [The Gaff](#) with [Creative Communities Midwest](#) invited artists and community groups to share cultural and historical experiences with the intention of bringing them to public audiences through digital platforms. Then, working with UK-based artist, Lowri Evans, and curator, Maeve McGrath, artists working with community groups excavated these stories, bringing them into the public domain through this audio installation.
- The branch was delighted to welcome 32 children on two Summer Camps with Scoil Mocheallóg, Kilmallock, for a morning of storytelling, singing, and crafting on 28 June. Little Readers continued on 30 June for an interactive session of nursery rhymes, song, stories and crafting with refreshments for young and old.
- Dooradoyle Library was the venue for a series of Beginner Social Media Workshops organised by The Women's Shed, Limerick. The group met weekly on Thursday evenings for a period of four weeks where members learned how to set up an email account, search the internet and use Facebook, Twitter and Instagram.
- To date, 450 children have registered for the Summer Stars Programme in Dooradoyle Library.
- Dooradoyle Library's latest exhibition, 'Through The Looking Glass,' was officially opened on 02 June, with approximately sixty people in attendance on the night. The exhibits, by local artist, Tarah Scott, were a mix of paintings, sculpture and fine art prints. The exhibition ran for the month of June.
- The branch was delighted to welcome sixty Fifth Class students from Monaleen National School on 14 June for a special awards ceremony. Having completed a Book Review Project with the library, children attended the library for a visual quiz, followed by a certificate presentation. All of the book reviews were on display in the library.
- The monthly book club met on 29 June where they discussed their latest novel, 'The Glass Hotel,' by Emily St. John Mandel. The First Friday Book Club met to discuss 'In Kiltumper: A Year in an Irish Garden,' by Niall Williams and Christine Breen.
- Regular visits from Catherine McAuley School, Health Service Executive Training Centre and the National Learning Network continued throughout the month.
- There were 20 onsite visits by researchers to the Local Studies Department. These comprised 12 research sessions on the archives of local and national newspapers, three on the FindMyPast site, and five on material from the Local Studies and Archives collections. There were 17 remote queries,

The editing of essays and the collection and scanning of images, for the Department's Decade of Centenaries' volume on Protestant life in Limerick during the revolutionary period, continued. Work on the new Local Studies website was further progressed and some new acquisitions were added to stock.

- In Watch House Cross Library, classes continued to run weekly for those seeking international protection who are living in the Knockalisheen Centre. The English language classes and driver theory classes were facilitated by a tutor from The Limerick and Clare Education and Training Board with 30 people attending.
- June featured many class visits with children returning their library books before the school holidays. Gaelscoil Sáirséal Third and Fourth Classes, Thomond Primary Third and Fourth Classes, and Corpus Christi First and Second Classes visited and heard all about the summer Stars Programme and were encouraged to join and enjoy reading during the summer.
- 10 June was an amazing day of creativity celebrating Criunniú na nÓg with 25 children participating in a workshop designing sets and filming stop motion Lego movies.
- The Lego Club continued on 16 June with some highly skilled and imaginative creations.
- On 21 June, the branch was delighted to welcome pupils from Corpus Christi and the Green Schools' Committee to meet with Claire from Repack, an environmental not-for-profit organisation. The children heard all about the need for, and value of, recycling and were engaged and had loads of questions on the day.
- Helium Arts, the charity working with children and young people with lifelong health conditions, continued with their monthly art and craft session in the library on 24 June. This series of arts-based workshops creates safe and inclusive spaces that inspire creativity, spark friendships, and improve

mental health and wellbeing for children and young people coping with long-term illness.

- Caherdavin Girls' Primary School Literacy and Numeracy Camp visited on 27 June with 40 children and 10 staff. The girls were given a tour of the library, chose some books to take home and were invited to participate in the Summer Stars Programme.

- The Friday Adult Book Club held its last meeting before the summer holidays on 30 June. The book choice in June was Marianne Lee's debut novel, A Quiet Tide. Set in the early 1800's, this book is a fictionalised account of the life of Irish botanist, Ellen Hutchins. It was a huge hit with the club, getting a 10 out of 10.
- The Parent and Toddler Group celebrated the last meeting before the summer holidays on 30 June, with lots of rhymes, song and some stories.
- Storytime was held each Thursday during the month. World Refugee Day was marked with stories to celebrate the day. The Sensory Room had 70 bookings in June with 160 users in total.

Gradam Bliantúil Filíochta i gCuimhne ar Mhícheál Ó hAirtnéide 2023 / Michael Hartnett Annual Poetry Award 2023

This annual award closed for application on 16 June following an open call out. It was established by Limerick County Council and is jointly funded by Limerick City and County Council and The Arts Council to mark Michael Hartnett's contribution to literature in English and Irish. The Michael Hartnett Annual Poetry Award is awarded in alternate years to books of poetry in the Irish and English language. This year, 2023, the award will be made to a poet writing in Irish. A prize of €4,000 will be awarded to the winning poet on the basis of a second or subsequent book of poetry, published in the last three years, i.e. 2020 – 2022. This year's adjudicators are poets, Áine Uí Fhoghlú and Paddy Bushe, who are currently assessing applications.

Limerick Culture Night 2023

The deadline for receipt of applications for Culture Night 2023 from the Limerick Culture and Arts Community was 30 June at 4pm. Expressions of interest for grant support were requested as part of the online registration process. Limerick Culture Night is supported each year by the Arts Council in partnership with Limerick City and County Council.

CREATIVE IRELAND

Cruinniú na nÓg 2023

Cruinniú na nÓg is a national day of creativity for children and young people, that celebrates and encourages participation in culture and creativity through performance, theatre, art and music workshops, readings, screenings, special events and much more. Cruinniú na nÓg is a flagship initiative funded by Creative Ireland Programme's Creative Youth Plan to enable the creative potential of children and young people. All events are free of charge, child-centred and activity based. It is a day for lots of doing, making and creating.

Limerick Arts Office, in partnership with Fresh Film, provided a series of free workshops, activities and performances across the city and county which took place on 10 June for children and young people to take part and enjoy. The programme was delivered in partnership with the Library Service, Hunt Museum, Music Generation, Irish Chamber Orchestra Youth Orchestra, Emerging Limerick Filmmakers, King's Island Lego Club, the Limerick and Clare Local Creative Youth Partnership and Glórach Theatre, Abbeyfeale, to deliver a wide ranging and exciting programme for the day! Limerick also engaged in several national youth arts initiatives including Circus Explored, Youth Theatre Ireland Taster workshops, Rap Music Workshops with Rhyme Island and This Is Art, a national art competition.

Programme highlights included Open Air Movie in The People's Park! Film Screening: Moana. Arriving with blankets and popcorn, children and young people and their families enjoyed a feature film for all ages presented on a large LED screen in the beautiful setting of The People's Park. Silent films were set to music by the Irish Chamber Orchestra Youth Orchestra, Lego workshops with stop motion animation and VR headsets went down a treat in UL City Campus, and taster workshops took place in drama groups across the county.

Limerick City and County Council secured additional funding of €4,550 to deliver events that targeted equality, human rights and diversity as part of Cruinniú na nÓg 2023. This programme included Shadow Animation @ the Ark, University Hospital Limerick, and partner event workshops with Ukrainian teenagers. For the Shadow Animation, local animator, Dr. Emma Fisher-Owen, designed an animation work pack for children and young people who were in hospital on Cruinniú na nÓg. These packs each contained shadow puppets, backgrounds and materials to colour them in, along with instructions on how to make your own shadow puppet animation film!

Cruinniú na nÓg Advisory Group

The Cruinniú na nÓg Advisory Group debriefing meeting took place on 21 June. Joining Limerick Arts Office and Fresh Film were representatives from Innovate Limerick - Film in Limerick, Limerick Libraries and Limerick City Gallery of Art.

Creative Communities on a Shared Island Fund application

The Creative Ireland Programme developed the Creative Communities - Shared Island Initiative that seeks to build on the experience and expertise of local authorities' existing strategic north-south and east-west (Ireland-Britain) ambitions and transform them into a collaborative network across the island of Ireland. It intends to recognise and utilise the inherent creativity of all who live on the island of Ireland.

The project that Limerick City and County Council submitted focused on supporting collaboration and exchanges between lace-maker groups and heritage institutions on the island of Ireland. This application is in collaboration with voluntary experienced groups, Friends of Lace Limerick, and the South Armagh Lace Collective and involving Limerick Museum, Armagh County Museum and Cork Public Museum. The long-term goal is to create and promote a lace trail through the majority of historical lacemaking centres on the island of Ireland. Limerick Arts Office coordinated the application and submitted it in June.

ARTS COUNCIL FRAMEWORK AGREEMENT PROGRAMME

Culture Night Late Funding Application

Limerick Arts Office applied for Culture Night Late Funding, securing an additional €16,000 from the Arts Council from the Culture Night Late Funding Scheme, to host a flagship event in Limerick for Culture Night 2023. Limerick has hosted two previous flagship events for Culture Night, both in King John's Castle, showcasing emerging talent across Hip-Hop and Electronic Dance

Music. Limerick will showcase emerging talent, in the large-scale event, late into the night.

River Residencies - Invitation to Collaboration

Limerick was lead partner on this Arts Council funded Invitation to Collaboration project with the Arts Offices in Cavan, Clare, and Tipperary, and Ormston House as artistic lead. Over the past two years, artists met with communities in rural locations along the River Shannon in Clare, Cavan, Limerick and Tipperary. Final reporting documents were prepared and submitted to the Arts Council in June.

Limerick City Gallery of Art (LCGA)

- Diana Copperwhite's exhibition, *Onomatopoeia*, finished on 25 June and was visited by 9,887 people. It was curated by Aoife Ruane and presented as a national tour with financial support from The Arts Council Touring Award. Copperwhite is from Co. Limerick and she has gained a significant national and international profile over her thirty-year career.
- A selection of works from the Permanent Collection forms the basis of a very fine representation from The Collection on exhibit in the East Gallery and the first floor galleries, including works by seminal artists from the last century including Paul Henry, Evie Hone, William Leech and Limerick artist, Walter Verling, who recently died (RIP).
- LCGA continues to collaborate with other national institutions and galleries making artworks available from the Permanent Collections for temporary exhibitions and most recently loaned work to the Model in Sligo. Talks have also commenced with Crawford Gallery in Cork. The executive are keen to ensure that the public still has access to works from their significant Permanent Collection.
- Juliette Morrison, who is currently doing an MA, by practice, at TUS - Limerick School of Art and Design (LSAD), exhibited the painting produced during her residency in the LCGA TEST SPACE programme.

Visitors to the Gallery had the opportunity to engage with Juliette and observe an artist while she works.

- The recruitment of the Shinnors Scholar, a two year MA by practice, was awarded to LSAD graduate, Aoife Doherty. The position is for a two-year period. This initiative is a partnership with TUS, which has been in place for 16 years with eight participants to date. The focus of the Shinnors Scholar is on the development of the education programme with primary schools.
- LCGA continued to have a notable increase in school groups, foreign visitors from EU, South America (particularly Brazil), USA, and Ukraine, which suggests that there are significant opportunities for LCGA to grow this audience.
- LCGA continued to collaborate with local community groups, facilitating meetings for U3A (University of the 3rd Age) with meetings held three times in the month, hosting meetings with The Wheel and Helium and a concert/performance with the Irish Chamber Orchestra youth orchestra.
- LCGA hosted a photographic exhibition by Limerick College of Further Education students which ended on 02 June.

Limerick Museum

- On 15 June, the Mayor of the City and County of Limerick, Councillor Francis Foley, performed the Official Opening of *Riband*, an art exhibition by Pauline Flynn, in Limerick Museum. 'Riband' is the title of Pauline Flynn's new work based on the ribbons of the military medals on display in the Museum. The exhibition showed how a simple starting point could inspire an artist towards an exciting and very creative group of paintings. As part of the Opening, the Curator gave a short talk on the history of the Museum's collection of military medals and Pauline Flynn recited some of her poems.
- Pauline Flynn is a visual artist/poet. She studied at the National College of Art & Design, University College Dublin, the Art Institute of Chicago and Kyoto University of Arts. She has worked as a professional artist since 1985 and has exhibited in Ireland, United Kingdom, Japan and China. Her imagery is abstract, acrylic on canvas. Her work is influenced by the Bauhaus and Japanese aesthetics. She was selected for the Beijing International Art Biennale in 2022. Her poetry is published in Literary Journals in Ireland, UK and USA. She lives and works in County Wicklow.
- On 16 June, Dr. Catherine Moran, Associate Professor of American Studies of Saint Louis University, USA, who is conducting research on the links between the Good Shepherd Convents in Limerick City and Saint Louis, Missouri, visited the Museum and examined some of the Limerick lace in the permanent collection.
- On 22 June, the Assistant Curator welcomed members of the extended Unthank family from Ireland and abroad to Limerick Museum where she showed them portraits of their nineteenth-century ancestors from the Museum's permanent collection. The Unthinks were a prominent Quaker merchant family in eighteenth and nineteenth-century Limerick.
- The Friends of Lace held their usual monthly meeting in the Museum on 24 June.
- As part of the Museum's new partnership with Askeaton Civic Trust, the Curator attended the events celebrating the 500th anniversary of the signing of the Desmond-Valois Treaty in 1523 in Askeaton. On 23 June, he attended a special illustrated lecture by Dr. Declan M. Downey in Askeaton Community Hall, and on 25 June, he attended the Ó Riada Mass in St. Mary's Church, Askeaton, followed by a Heraldic Pageant Procession from the Church to the Castle, a commemoration ceremony and a dramatic re-enactment of the Treaty by En-Garde.
- As part of an Irish Research Council-funded project on the archaeology of the Irish revolutionary period in East Limerick, Dr. Joanna Bruck, Professor of Archaeology in UCD, and Aidan Harte of Munster Archaeology, visited the Museum where the Assistant Curator showed them a large number of relevant objects from the Museum's permanent collection.

2. Community Development

Age Friendly Limerick

- Age Friendly Limerick attended the launch of the Limerick Women's Shed at Mungret St. Paul's GAA Club. Positive exposure was generated for the Limerick Age Friendly programme through the distribution of Age Friendly branded goodie bags and information packs on the local Age Friendly and Healthy Age Friendly Homes, to the event attendees.
- The Limerick Older People's Executive (OPE) met in Dooradoyle and a progress report was delivered by the Limerick Age Friendly Programme Manager on the ongoing work on the draft Limerick Age Friendly Strategy 2023-2028. The OPE members were also made aware of the positive publicity raised by the recent Limerick Post newspaper article.
- The team at Age Friendly Limerick marked World Elder Abuse Day by holding an event at St. Munchin's Community Centre. The Community Gardaí from Mayorstone Garda Station, members of the HSE Community Healthcare team, ALONE and Sláintecare Healthy Communities Team also attended. The Council Headquarters at Merchant's Quay was lit up purple in recognition of World Elder Abuse Awareness Day.
- Age Friendly Limerick, in collaboration with the Tourism promotion Section, arranged a familiarisation trip to the Limerick Greenway to ascertain insights and views of the OPE members on making the Greenway age friendly.
- A migrant Women's Health and Wellbeing Fair took place at the Clayton Hotel in June. This project was a collaboration between Healthy Limerick, INTEgreat and PAUL Partnership. 22 different health related services attended, including screening services, and over 90 women attended.
- The Healthy Ireland Coordinator took part in an information exchange visit to the Hohenlohe region of Germany to hear about the approach there to migrant health and wellbeing and to visit migrant accommodation centres in the region.
- The completion of the Community Garden in Saint Mary's Park has successfully provided a vibrant space where people can come together, foster community cohesion and promote environmental awareness.
- In June the revival of the community fishing competition in the King's Island area was supported. This event has proven to be an effective means of engaging the local community with their natural environment and fostering a sense of pride and ownership.
- In collaboration with the Thomondgate Residents' Association, The Housing Community Sustainment Team and Healthy Communities supported a mural project in Thomondgate.

Health and Wellbeing

- In June, Art and Craft classes continued every Thursday and Saturday at the Hunt Museum. Attendance has been steady with 57 children and 48 adults attending the family classes and 44 adults attending adult workshops. An overnight residential trip for 20 migrant young people took place in collaboration with Limerick Youth Services and Healthy Limerick.

Integration

On 19 June, the Mayor of the City and County of Limerick, Councillor Francis Foley, launched the "Limerick United against Racism" campaign.

An InteGreat EU project mid-term conference took place in Gothenburg, Sweden, at the beginning of June and a presentation was given on the multi-agency strategic approach undertaken in Limerick. This was viewed as an example of good practice.

On 21 June, a meeting with members of the migrant community was held to consider the establishment of a Migrant Forum in Limerick. It was agreed that such a Forum would be very positive and will be explored further.

Outdoor Recreation Infrastructure Scheme

- The 2023 Outdoor Recreation Infrastructure Scheme (ORIS) launched and is expected to provide funding of €16 million for the development of new outdoor recreational infrastructure and the necessary repair, enhancement or promotion of existing outdoor recreational infrastructure in countryside areas. The type of activities supported by the Scheme include trails, cycleways, Blueways, bridleways, as well as outdoor amenities located near rivers, lakes, beaches and on upland areas. 'Embracing Ireland's Outdoors' sets out the future of outdoor recreation over the next five years.
- On 16 June, Community Development invited Expressions of Interest (EOI), through My Point under all Measures of the Scheme as follows: Project Development Measure: Development Costs for Strategic Large Scale Projects – Grant up to €50,000; Measure 1: Small Scale Repair/Development/Promotion and Marketing - Grant up to €30,000, Measures 2: Medium Scale Repair/Upgrade and New Trail/Amenity Development – Grant up to €200,000 and Measure 3: Strategic Large Scale Repair/Upgrade and New Strategic Trail/Amenity Development – Grant up to €500,000.

Public Participation Network (PPN) Limerick

- Membership of PPN Limerick continues to grow and stands at 190. The membership registration form is on the Limerick PPN [website](#) and eligible groups in Limerick can register at any time.
- Two Linkage group meetings were held in June: Home and Social Development Meeting and Economic Development, Enterprise and Planning.
- PPN Limerick completed and submitted its annual report to the Department of Rural and Community Development.
- The Secretariat hosted a meeting for the Representatives to discuss issues they may be

experiencing and supports they would benefit from.

- Two nominations were received following the closing date for the vacant community/voluntary Strategic Policy Committee seats. These nominations were for one seat on the Climate Action, Biodiversity and Environment Strategic Policy Committee and the other for the Community, Leisure and Culture Strategic Policy Committee.

Environmental Awareness

- On 16 June, the annual Going for Gold competition was launched by the Mayor of the City and County of Limerick, Councillor Francis Foley, and the JP McManus Charitable Foundation, on the banks of the River Shannon in Castleconnell. The overall aim of the competition is to make Limerick a cleaner, brighter place to work, live and visit.
- Over €50,000 in grant assistance has been distributed to communities so far this year to assist groups prepare for the annual competition. The funding is applied for under the Limerick Going for Gold Environment Improvement Grant Scheme, jointly funded by Limerick City and County Council and the by JP McManus Charitable Foundation.
- This year, the competition element of Going for Gold is expected to have over €60,000 in prizes to be distributed across a number of categories including: Tidy Towns Category, Limerick Bee Friendly in Bloom, Residential Areas, Judges Award, Reuse Award and Best Front Garden Category.

1. Regeneration and Sports

Regeneration

The Council has appointed KPMG to prepare a status update of the Limerick Regeneration Framework Implementation Plan (LRFIP 2014-2023). KPMG met with the relevant key stakeholders to discuss the draft findings and recommendations for the four communities. The Limerick Regeneration Status Update will assess the current position and make recommendations for the future strategic direction of Limerick's Regeneration Programme to 2030 including across social, economic and physical objectives. Feedback sessions took place in June with the regeneration committees and local residents on the Limerick Regeneration Status Update Report. A draft is being finalised for submission to the Department of Housing, Local Government and Heritage.

Economic Regeneration

Outreach to Employment Programme

A review of the programme in June showed that significant progress is being made with both the employer and the engagement from the communities:

- 16 new employers engaged for 2023.
- 85 Participants are currently engaged across the four Regeneration areas in the Outreach to Employment Programme.
- Employment Meetings were established in Ballinacurra Weston and Southill in June. Monthly employment meetings continued in St. Mary's Park and Moyross throughout the month engaging with the relevant stakeholders in the training and employment field.
- New employers have also been recruited for the next Jobs Fair.

Social Regeneration

Economic and Social Intervention Fund (ESIF) Update

Following the approval of additional submissions under the Economic and Social Intervention Fund 2023, the Department of Housing, Local Government and Heritage has now approved over 190 ESIF projects to the value of €3,983,264. The recent tranche of approvals included funding to support the development of a Multi-Use Games Area in St. Mary's Park and funding to support Southill Afterschool's Club CLG.

The Directorate continues to support organisations with their drawdown of the Economic and Social Intervention Fund (ESIF) Grants 2023. Ongoing evaluation and coordination work continues with the ESIF recipients.

18 site visits to fund recipients were conducted throughout the month of June, which served to highlight the scale and breadth of work that the Economic and Social Intervention Fund currently supports in the city.

A meeting of one of the Local Strategic Advisory Monitoring Group's sub-committees, Families and Youth at Risk, was held during the month of June. At this meeting, organisations and funding streams were discussed.

Visits from the Tipperary Town Revitalisation Taskforce and Queens University were also facilitated during the month of June. Site visits were conducted in all four Regeneration areas and provided the Directorate with a wonderful opportunity to showcase the social and economic initiatives happening in the communities.

Visits by Councillors and members of the Oireachtas to several ESIF projects were also convened during the month of June and served to highlight the Fund's critical role in the ongoing evolution of the Regeneration communities.

Southside

Dr. Niall Muldoon, the Ombudsman for Children, visited Childworld Crèche in Our Lady of Lourdes Parish to celebrate its newly launched Early Years Family Guide. The Ombudsman was joined by children, parents, staff, the manager, Yvonne Galvin, and the Chair of the Board, Senator Maria Byrne. Mr. Muldoon was most impressed by the vibrancy of the setting and the innovation of the staff in co-producing the album booklet with parents.

Turnout was high at the Southill Community Health Information Day. Services on offer included health screening, information stands, healthy eating advice, mental health advice, yoga workshop and complimentary breakfast. The event was organised by Southill Family Resource Centre and supported by Tusla. Another great example of Southill Stronger Together Collaboration.

Southill wildflower projects took place in the estates, as well as expanding into neighbouring schools, as part of the All-Ireland 2021-2025 pollinator plan. Southill Residents' Association and the Tidy Towns group supplied the topsoil and wildflower seeds to the Southill Hub, Southill After-School Club, Southill Allotments Group, O'Malley Park Grotto and the Le Chéile and Our Lady Queen of Peace Schools. A new flowerbed has been installed on the Old Lilac Store site and wildflowers have been added and are currently in bloom.

Limerick crest painting - Southill Tidy Towns and Residents' Group have proudly painted an ESB substation with the Limerick crest using paint from Relove Paint, a Tait House enterprise which re-uses donated water-based paint from Mungret Recycling Centre and upcycles it into premium quality paint.

Northside

Strengthening Communities initiative meeting was hosted by St. Mary's Park for the Regeneration communities. The project is being well received.

Care and Repair Scheme saw another 10 new clients identified in St. Mary's Park.

Dissemination of a Useful Contacts leaflet was done in Nicholas Street, Athlunkard Street and the Abbey River area.

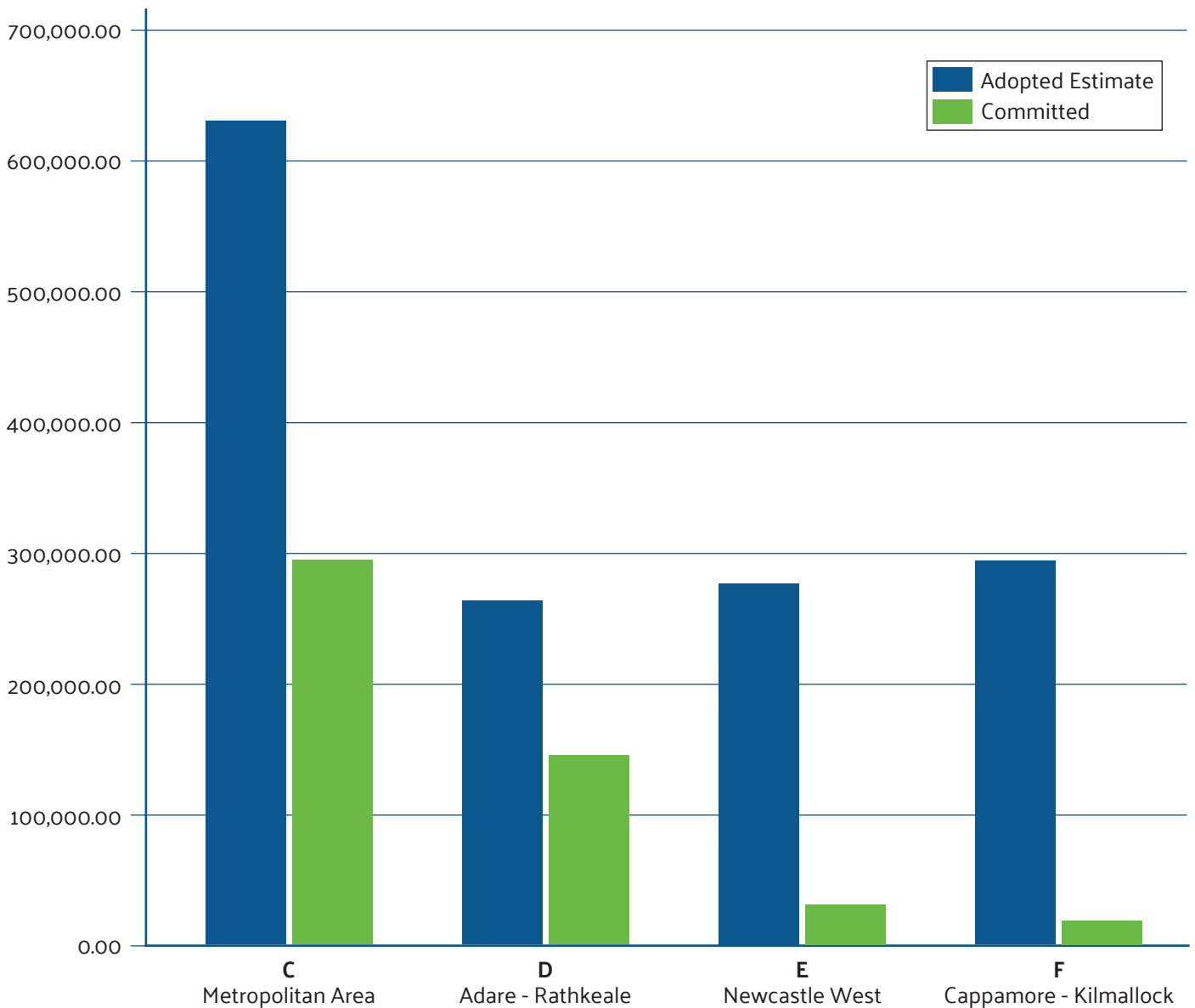

Customer Services

The Customer Services Team continued to support customers and Public Representatives at first point of contact by answering queries via telephone, email, MyLimerick and social media. Case creation, payments processing and generally facilitating applications for all Council services also continued throughout the month.

The following figures highlight the activity within the Contact Centre throughout the month of June:

- Customer Services Call Centre answered 10,023 calls. This represents an average of 477 per day, with the number of calls reaching as high as 571. A total of 70% of calls were handled at first point of contact.

- A total of 3,234 emails were processed through the Customer Services email platform.
- 2,770 cases were created on Sugar CRM (customer relationship management), with 704 of these logged on behalf of Public Representatives. 2,845 cases were closed, with 578 of these being cases logged by Public Representatives.
- Of the 2,770 cases created, 68% were logged by the Customer Services Team.
- The logging of cases through the MyLimerick portal continued, with a total of 219 cases being logged. Of these, 191 were submitted by Public Representatives.
- Customer Services continued to support the Housing Maintenance Department in creating service requests, and throughout the month, 75% of Housing Maintenance cases for the Limerick Metropolitan District were logged by Customer Services staff in the Dooradoyle and Merchant's Quay offices.
- A total of 90 out-of-hours cases were created.
- Customer Services continued to provide other frontline services to the general public, such as processing applications for Residential Parking Permits, of which 115 were applied for and 77 issued.
- Customer Services staff welcomed a total of 2,073 customers at the Merchant's Quay and Dooradoyle Offices.
