Jobs

BRITVIC Ireland announced an investment of €6 million in its Ballygowan facility in Newcastle West, Co. Limerick. This investment will grow the site's production capacity by over 20% in order to meet growing consumer demand for Ballygowan mineral water and create 28 new jobs.

Food supplier Sysco also unveiled plans to create 50 new positions in its Newcastle West facility.

Sister Cities

A delegation from the Sister City of Spokane visited Limerick this month. The group was led by Ben Stuckart, former President of the Spokane City Council. The Mayor of the City and County of Limerick, Councillor Gerald Mitchell, welcomed the group to Corporate Headquarters where Elected Members and Council staff were present.

The group also visited Limerick Chamber, King John's Castle and Innovate Limerick as well as the University of Limerick, where a student exchange programme exists with Washington State University.

The Spokane-Limerick relationship officially began when a joint agreement linking the two cities was signed in Spokane by the Mayors of Spokane and Limerick. Foremost among the objectives of the relationship is to foster and encourage bonds of friendship and understanding between the two cities and to bring together events of cultural, educational and economic benefit.

Limerick Greenway Biodiversity Plan

With the popularity of the Limerick Greenway increasing steadily since its opening, Limerick City and County Council is very aware of the need to ensure minimal impact to species, and to enable the rich biodiversity of the Greenway to be both an educational asset and a visitor attraction.

The Limerick Greenway Biodiversity Plan was commissioned by Limerick City and County Council and presents a comprehensive assessment of the Greenway's ecology, combining findings from desktop studies and ecological surveys, over a twelve-month period. The plan collates and presents the results of the surveys, which will inform actions and makes recommendations for future implementation. The Limerick Greenway Biodiversity Plan aims to support, protect, enhance, restore and conserve the flora and fauna of Limerick Greenway, and to plan, manage and maintain the 40km route, placing biodiversity at the heart of this process, with sympathetic management, and retention as a natural corridor.

One of the recommendations contained in the plan is to support education initiatives regarding the Greenway. On 26 September, teachers from Primary Schools located along the Greenway route took part in a three-hour on-site training session delivered by Botanist, Phoebe O'Brien. Teachers were provided with resources to assist them when bringing children on class trips to the Greenway.

This funding was secured via a competitive process to select three destinations to support the development of St. Patrick's festival outside of Dublin for the period 2024-2026.

Festivals and Events 2023/2024 Open Call

The recommendations for Festivals and Events funding for the Limerick City and County Council Festivals and Events Grant Scheme 2023/2024 went before the Council at the September Meeting. The following recommendations from the Assessment Panel were approved:

Recommendations: Strand 1: Fund Available: €30,000

- 17 applications were considered under this strand with a total ask of €99,580.
- The Assessment Panel recommended the allocation of funding to 12 successful applicants totalling €30,000.

Recommendations: Strand 2: Fund available: €171,500

- 17 applications were considered under this strand with a total ask of €391,568.47.
- The Assessment Panel recommended the allocation of funding to 16 successful applicants totalling €171,500.

Recommendations: Strand 3: Fund Available: €6,500

This award is intended to support a step change in the ambition and delivery of the festivals.

- 12 applications were received with a total ask of €47,500.
- The Assessment Panel recommended the allocation of funding to two successful applicants totalling €6,500.

The events supported in September were:

- The 40th EVA International, **Ireland's Biennial of Contemporary Art** featuring Irish and international artists across venues in Limerick throughout September. EVA International is a visual arts programme featuring new commissions and existing works from internationally acclaimed artists. Some of the highlights of EVA this year were a guest Programme and Platform Commission and Partnership Project initiatives.

- The **16th Polish Arts Festival (PAF)** ran from 13-17 September. PAF offers a diverse range of events including film, storytelling, drama, music and art with family fun for all ages to enjoy. It embodies the notion of a shared cultural experience with participants from a range of locations and background. Events were mostly presented in both English and Polish.
- Cannonball Run**, the largest organised road trip in Europe, returned to Limerick from 15-17 September with a largescale spectacle of high-end supercars, all in aid of the Jack and Jill Foundation. There was an electric atmosphere in Limerick's Pery Square on the Saturday evening as the cars rolled, accompanied by live music, Brazilian dancers and family fun, including a fancy-dress competition. The cars parked up there, giving plenty of opportunity for spectators to enjoy them before heading away on the Sunday morning.
- Limerick Jazz Festival**, now in its 12th year, took place in a number of venues across Limerick City from 20-24 September. This year's festival had a particular focus on female artists from Ireland and the UK and had a very busy schedule of events over the five days.
- Pigtown Culture and Food Series** celebrates Limerick's food culture, producers, and food heritage and took place from 21-24 September. The weekend's events included fine dining, demonstrations, tours, family fun and an art fair.

Coonagh to Knockalisheen Distributor Road Project

The Trunk Watermain Contract on the Coonagh to Knockalisheen Distributor Road Project was substantially completed by Wills Bros Ltd.

European Mobility Week

European Mobility Week took place from 16-22 September and is an initiative aimed at promoting sustainable and active modes of transport. During this week-long campaign, the Council committed to raising awareness about sustainable mobility and inspiring behavioural change towards active and sustainable travel methods, including walking, cycling, carpooling, and public transport.

- A 'Walk on Wednesday' competition was organised with schools around the city and county on 20 September. The winning school had 94% of their students walking, cycling and scooting on the day.
- A social media competition was held where members of the public were asked to share photos of their sustainable commute.
- A public awareness campaign was organised, and mobility week signage was erected on Patrick Street in the city centre. The signage delivered the key messages of the campaign.
- Internally, within the organisation, a number of promotions were held across the week. The Management Team led the initiative and adopted sustainable modes of travel throughout the week. Throughout Mobility Week, details were shared about the public transport tax saver scheme, bike programmes, and car-share opportunities available throughout Limerick. All staff were encouraged to participate in 'Car Free' commuting during the week.

Motion by Electronomous

On 20 September, Travel and Transport Strategy staff attended the Motion by Electronomous conference in Shannon. On the day, they had the opportunity to meet public and private sector attendees from across the globe who are helping shape future mobility.

Staff from Limerick City and County Council presented some of the great projects happening in Limerick, and participated in panel discussions.

SSMA Training Programme

The Smart and Sustainable Mobility Accelerator (SSMA) Training Programme commenced on 25 September. The programme aims to equip Local Authorities and Stakeholders with the knowledge and skills needed to excel in the realm of sustainable and intelligent mobility.

The programme represents an holistic training and capacity-building workshop series designed to empower Local Authorities and Stakeholders in the execution of smart and sustainable mobility projects. Staff from Limerick City and County Council Transportation and Mobility Directorate are participating in the training which is being hosted by the Southern Regional Assembly.

Electric Vehicle (EV) Pilot Project

Limerick City and County Council has embarked on the development and delivery of a pilot EV charging project. This project will focus on delivering residential home charging solutions and destination charging at a number of locations around the city and county. In September, the Department of Transport, through the Zero Emission Vehicles Ireland (ZEVI) Office, committed additional funding to support the delivery of this pilot project.

Official Opening of Broadford Community Centre by Minister Heather Humphries

Minister Heather Humphries visited Broadford on 14 September to officially open the newly refurbished Broadford Community Centre. The refurbishment of the community centre was undertaken in two phases - the first phase was part-funded through the Town and Village Renewal Scheme (2019) and included new roof and internal upgrades; the second phase was funded through the LEADER programme (2021) and included a single-storey extension to the rear providing upgraded kitchen, toilets and stage support area. Broadford Development Association oversaw and managed the project and undertook a huge amount of fundraising for this project in addition to the grant funding.

Environmental Awareness

National Sustainable Development Goals Week Events

- Limerick City and County Council marked National Sustainable Development Goals Week with the launch of three new CLÁR public drinking water fountains by the Mayor of the City and County of Limerick, Councillor Gerald Mitchell, on 25 September. The new fountains are in Kilfinane, Galbally and Doon.
- Two reusable cup promotions took place in the public offices of Dooradoyle on 27 September, and Merchant's Quay on 26 September, during National Sustainable Development Goals Week, with 200 reusable cups distributed to Limerick City and County Council staff and public.
- A Food Waste Recycling Promotion took place in the Square, Newcastle West, on 29 September.

Public Participation Network (PPN) Limerick

- Membership of PPN Limerick continued to grow and stands at 195. The membership registration form is on the Limerick PPN [website](#) and eligible groups in Limerick can register at any time.
- Two linkage group meetings were held: Economic Development, Enterprise and Planning on 18 September and Home and Social Development on 25 September.
- The PPN Resource Worker presented at the launch of URBACT IV on 07 September. Limerick City and County Council is leading two projects: BiodiverCity and GreenPlace. The Resource Worker spoke about the PPN's previous engagement with URBACT and the benefits of collaborating with PPN Limerick.
- PPN Limerick continued to have an active presence with its regularly updated website, social media and bi-monthly Newsletter distributed to members.

Limerick City Gallery of Art (LCGA)

- Record numbers for EVA International totalling 5,749 visits.
- A Walk along the banks of the Shannon took place on 27 September with artist, Seodín O'Sullivan, who is exhibiting her work in LCGA.
- In consultation with the curator of EVA International, the Permanent Collection was folded into contemporary exhibits. This innovation met with approval from the Irish Times critic, Gemma Tipton.
- Gallery staff were involved in significant preparatory work in advance of the George Shaw exhibition, Nothing Strange or Startling. Work progressed for the Screen Dance exhibition. Screen Dance is part of Light Moves festival, a Limerick-based initiative, which has been running since 2014.
- LCGA continued to collaborate with other local and national institutions and galleries making artworks available from the Permanent Collections for temporary exhibition.
- LCGA submitted its application to the Arts Council for the 2024 Strategic Funding.
- LCGA Shinnors Scholar continued to deliver the schools' programme.
- Throughout the month of September, LCGA worked with EVA International, Helium Arts (providers of visual art experiences for children with long-term illnesses), and University of the Third Age (U3A) who meet on a fortnightly basis in the Gallery.

Strategic Fund for Culture and Arts Scheme 2023

Limerick Arts Office manages the 2023 Strategic Fund for Culture and Arts Scheme. The purpose of the Scheme is to support the maximising of the leveraging of funding into Limerick from national and international sources and to support a vibrant creative culture. In September, five letters of support were issued. At the September Council Meeting, nine Strategic Applications were approved awarding €25,375 of grants - leveraging in €462,532 of national funding into Limerick City and County.

CREATIVE IRELAND

The recently appointed Creative Communities Engagement Officer participated in a national training and networking event, organised by Creative Ireland, at the Department of Tourism, Culture, Arts, Gaeltacht, Sport and Media Headquarters in Dublin, on 27 September.

Future Creators

The Irish Aerial Creation Centre (IACC), in a partnership with Limerick City and County Council, delivers Limerick Future Creators 2023. The Creative Ireland collaborative youth project, led by the IACC, has only just begun to uncover the potential of what could be, and the time has come for Limerick to step up and take its place as a European Capital for Young Creators. The young people began their new Creative project on 29 September.

Creative Aftercare Communities

Two applications from Limerick for the Creative Youth Nurture Fund were successful: Building Bridges - Ballyhoura Development CLG; and Creative Aftercare Communities - Limerick Learning Hub.

Castleconnell Autumn Concerts

A live programme of enchanting and beautiful music and song returned to All Saints Church in Castleconnell this Autumn. Limerick Arts Office programmes Castleconnell Autumn Concert Series, with financial support from the Arts Council and Creative Ireland. The concerts are presented in partnership with Love Castleconnell. The second concert took place on 26 September with British classical pianist, Leon McCawley, who has been delighting audiences worldwide winning in 1993 first prize in the international Beethoven Piano Competition in Vienna and second prize in the Leeds International Piano Competition. It was presented by Liz Nolan on the night and recorded for future broadcast on RTE Lyric FM, The Full Score Programme, with Liz Nolan.

Culture Night 2023

22 September saw over 60 free events take place across Limerick City and County for Culture Night. This national celebration invites people to join in and explore the many different cultural offerings. Limerick people could enjoy dance, music, street art, theatre, parade, printmaking, exhibitions, talks, and tours with events taking place from 4 p.m. until 2 a.m.

Limerick was also featured, along with Kerry and Wexford, on RTÉ's Culture Night: Live from Dún Lúiche, as locations for events happening around the country. Fidget Feet's performance in Robert Byrne Park, with views of King John's Castle, was aired on the night.

This year, Limerick was successful in three Culture Night Late events - two large projects and one smaller grant project. 1. Regeneration and Sports

Regeneration

A working draft of the Status Update prepared by Consultants, KPMG, has been submitted to the Department of Housing, Local Government and Heritage for consideration.

The Department indicated that detailed consideration would be required given the extensive nature of the proposals and, in the interim, has confirmed that there will be a Regeneration budgetary allocation for 2024.

No decision has been made on the extent and structure of the 2024 budget at the time of going to print on this report, but it has been agreed that funding will be available in 2024 for the continuation of ongoing projects and the Department will consider a specific submission for the 2024 Economic and Social Intervention Fund (ESIF). 2024 funding will need to reflect the proposals contained within the working draft of the Status Update rather than simply act as an extension of the current fund.

Outreach to Employment Programme

The third of the Annual Regeneration Community Jobs Fairs took place in King's Island Community Centre on 16 September. Over 22 employers and agencies were in attendance to meet with local residents and the wider King's Island community. Over 300 were in attendance.

Forward Planning



Customer Services

The Customer Services Team continued to support customers and Public Representatives at first point of contact by answering queries via telephone, email, MyLimerick and social media. Case creation, payments processing and generally facilitating applications for all Council services also continued in September.

The following figures highlight the activity within the Contact Centre throughout the month:

- Customer Services Call Centre answered 10,418 calls. This represents an average of 496 per day, with the number of calls reaching as high as 586. A total of 71% of calls were handled at first point of contact.
- A total of 3,354 emails were processed through the Customer Services email platform.
- 3,161 cases were created on Sugar CRM (customer relationship management), with 773 of these logged on behalf of Public Representatives. 2,641 cases were closed, with 581 of these being cases logged by Public Representatives.
- Of the 3,161 cases created, 67% were logged by the Customer Services Team.

- The logging of cases through the MyLimerick portal continued, with a total of 254 cases being logged. Of these, 231 were submitted by Public Representatives.
- Customer Services continued to support the Housing Maintenance Department in creating service requests. 90% of Housing Maintenance cases for the Metropolitan District of Limerick were logged by Customer Services staff in the Dooradoyle and Merchant's Quay offices.
- A total of 119 out-of-hours cases were created.
- Customer Services continued to provide other frontline services to the general public, such as processing applications for Residential Parking Permits, of which 117 were applied for and 86 issued.
- Customer Services staff welcomed a total of 2,464 customers at the Merchant's Quay and Dooradoyle offices.
