Diaspora Engagement

Global Limerick, Limerick City and County Council's Diaspora engagement project, continued its mission to animate and mobilise the connection between Limerick and its Diaspora. Central to the Global Limerick project is the importance of harnessing a mutually beneficial relationship between communities in Limerick and Limerick's global Diaspora network.

October saw the second year of the Rose Fitzgerald Kennedy Autumn School in Bruff. This Diaspora-themed event was a weekend long celebration of the Fitzgerald family who emigrated from Bruff, Co. Limerick, to forge a new life in the US and eventually attain the highest office in the world. The three-day festival honoured Rose, mother of former President of the United States, John F. Kennedy, and her three grandparents who left Bruff in 1850. The events reflected on the home place the Fitzgeralds left in 1850 and told the story of Bruff and its Diaspora – past, present and future. This year's event marked the 60th anniversary of the visit by President John Fitzgerald Kennedy to Limerick, and the notable role played by the then Mayor of Limerick, Frances Condell.

Over 400 guests participated in various sessions throughout the weekend in Bruff and Lough Gur. Guest of honour at this year's event was Ukrainian Ambassador to Ireland, Ms. Larysa Gerasko, who spoke of the enforced emigration experience on her people and its unique echo of the Irish post-famine exodus. Some 320 Ukrainian refugees are now living in Bruff, and making a productive contribution to the local community.

2. Digital Services

A new website containing the 'Transcribed Burial Register Database' for Mount Saint Lawrence Cemetery in Limerick was launched by Digital Services.

EU Programmes

- **BiodiverCity**

The project lead expert for URBACT BiodiverCity, Ferenc Szigeti, and a delegation from the project lead city, Dunaújváros, visited Limerick to discuss the experiences and challenges to be addressed as part of the two-year project.

The site visit aimed at providing a good understanding of the situation (the local situation and experiences in relation to the policy challenge to be addressed) for Limerick in the BiodiverCity network and more specifically of the object under study. By coming in person, the international partner leads had a better grasp of why Limerick decided to join the network, what the main practical and policy challenges are, what the local reality is and what solutions have been envisaged so far. Presentations and site visits were undertaken to help prepare the baseline study and design a roadmap for all the network partners. The study visit was also an occasion to present the URBACT framework, and the specific objectives and focus of the network, to different internal departments within the organisation.

- **+CityxChange**

As part of GKINETIC's ongoing work in the +CityxChange project, the company showcased one of their 12kW units in the heart of Limerick city. The aim of the demonstration was to allow people to see the unit in real-life and share

their thoughts and feedback via the survey being run independently by the National University of Ireland Galway.

By way of background, the unit is a 'hydrokinetic energy converter' that can generate clean, reliable electricity from the natural kinetic movement found in free-flowing water. There are no dams or permanent civil infrastructure needed and it can be easily relocated or removed if needed. Above the surface, all that can be seen is a tidy, low-profile platform which houses all the electrical equipment for the unit. Underneath the water are two vertical axis hydrokinetic turbines that are turned by the force of the water to generate predictable, local energy. When running at full capacity, the 12kW unit that was on display can output enough power to meet the full electrical needs of 17 Irish homes. In remote communities where energy usage is lower, one turbine can power an entire village of 80-90 homes.

This highly innovative demonstration was part of an EU-funded smart cities project called '+CityxChange' which is led by two Lighthouse Cities - Limerick (Ireland) and Trondheim (Norway). There are also five 'Follower Cities' involved, including Alba Iulia (RO), Pisek (CZ), Võru (EE), Smolyan (BG) and Sestao (ES).

The aim of the project is to achieve sustainable urban ecosystems that have zero emissions and establish a 100% renewable energy city-region by 2050. This turbine demonstration aims to highlight the significant untapped energy potential in our free-flowing waterways such as rivers, canals, estuaries and tidal streams and to prove that it is possible to harness this energy with little-to-no negative impacts and in a way that is harmonious to the society and environment.

- **PACTE+**

Limerick Sports Partnership hosted a two-day Workshop on Active Governance. This area is one of the defined Pillars for the PACTE+ project promoting Active Cities.

Delegates from across Europe attended in-person and online over the two days. Graz, Fredrikstad and Anger are

the partner cities with Evaleo and Sports and Citizenship acting as the EU Non-Governmental Organisations.

The workshop was designed to outline the approach from a local and national perspective on promoting Active Cities.

3. Local Enterprise Office (LEO) Limerick

Funding Approved

There were five Businesses approved for grant funding, one Feasibility Study, one Priming Grant, two Business Expansion Grants and one Agile Research & Development and Innovation Grant. The total value of approvals was €252,931.

Seven Businesses were approved a Trading Online Voucher, and one Technical Assistance for Micro Exporters Grant was approved.

National Women's Enterprise Day

“Empowering Business Together” was the theme of the LEO Mid-West Conference for female entrepreneurs who took part in Ireland’s National Women’s Enterprise Day in the Clayton Hotel in Limerick City on 19 October.

140 women from the Region spent the day networking and learning from leading industry experts while tapping into the extensive supports available from their Local Enterprise Office.

The Mayor of the City and County of Limerick, Councillor Gerald Mitchell, opened the Conference by emphasising the importance of the SME sector in delivering jobs, economic growth and improving quality of life in the Region.

The event also heard from the LEO Limerick Head of Enterprise who spoke about the range of supports available from LEO to support growth.

4. Regional Enterprise Plan

Mid-West Regional Enterprise Plan

A new funding scheme for projects aligned with the Regional Enterprise Plan was launched by the Minister for Enterprise, Trade and Employment, Simon Coveney, T.D. More details on the Smart Regions Enterprise Innovation Scheme can be found here: <https://www.enterprise-ireland.com/en/funding-supports/Smart-Region-Enterprise-Innovation-Scheme/>

The Scheme is delivered by Enterprise Ireland and has a total value of €145.3 million with the overall objective of driving job creation/retention and enterprise development in each Region throughout Ireland. Call 1 is open for an extended period.

The Scheme caters for the following four streams:

1. Local enterprise infrastructure projects (for capital projects up to €10 million).
2. Innovation clusters and consortia (from €50,000 to €2m for projects over three years).
3. Services to SMEs to drive innovation solutions (80% programme funding up to a maximum of €1m).
4. Feasibility and Priming Grants (80% project funding up to a maximum of €200,000).

These projects shall be collaborative in nature, innovative, financially viable, sustainable and focused on delivering metrics and key performance indicators (KPIs) which provide additionality to the existing regional infrastructure.

Limerick Greenway

Tourism Industry and Trade Events

- The History Teachers' Association of Ireland (HTAI) conference took place in the Radisson Hotel Limerick on 14 October, and staff of Discover Limerick DAC attended and hosted a stand at the event.
- Staff of both Discover Limerick DAC and the Tourism Department of Limerick City and County Council attended a Fáilte Ireland hosted “speed dating” type event in the Radisson Hotel on 18 October. The structured 1:1 networking meetings were timed at four minutes long, allowing two minutes for each person to speak about their area of work, the attraction they were promoting etc. Attendees were encouraged to network with as many other attendees as possible at the event, regardless of sector, to introduce their attraction or business, to discuss their target markets, and to establish support networks among business owners in the Clare and Limerick region. More than 100 businesses took part, with half of those attending being from Limerick.
- The Association of Visitor Experiences and Attractions (AVEA) Annual Conference took place in Ennistymon, Co. Clare, on 23 and 24 October. Discover Limerick DAC was in attendance at the event.

Festivals and Events

The events supported in October were:

- Bualadh Bos Children's Festival** ran from the 01 to 15 October and consisted of a two-week long festival that included theatre, dance, music, masterclasses and creative workshops. The events offered gave an opportunity to young people to experience many different aspects of the creative arts. The festival brought collaborations between Local, National and International creative art companies. A new initiative to this festival was the ‘pay it forward’ campaign. This was a voluntary contribution made that was used to give creative experiences to communities who might not normally be able to avail of them.
- Ballyhoura Walking Festival** ran from 06 to 08 October and is now in its 27th year. Based in Kilfinane, Co. Limerick, the festival offered many variations of walking events as well as numerous events in the surrounding Ballyhoura areas, with some events taking place at sunrise, sunset and at night. The event also encouraged children to be out in nature and appreciate the wildlife with events such as a bug safari at Griston Bog.
- Cook Medical Women's Mini Marathon 2023** took place on 08 October in the University of Limerick Campus with over 3,000 participants who ran, jogged or walked the five- or 10-kilometers courses. The event is synonymous with raising money for good causes and is now in its 25th year.
- Culture through Action Series** commenced on 12 October and was hosted by the Limerick Civic Trust. The first four talks of the series, which took place throughout October, were given by distinguished individuals with superb insights into the chosen field being discussed. The lecture series theme was “Things Fall apart, the Centre cannot hold.”
- Castleconnell Fright Fest** ran from 20 October and saw Shannon House being transformed into a frightening escapade for all ages. Other events throughout the festival included Halloween-themed storytelling, pumpkin carving competition, arts and crafts and the infamous scary trail.
- Samhain: Limerick's Hallowe'en Festival 2023**, presented by Lumen Street Theatre in partnership with Limerick City and County Council and Failte Ireland, took place from 26 to 28 October. On the run-up to the festival, Lumen Street Theatre worked with local community groups doing mask and lantern making workshops which were used in the Samhain Parade on 28 October. The events throughout the festival included Folktales with Irish Folk hero, Eddie Lenihan, Samhain vampire swims, tales from beyond the grave with Caoimhe Tobin, Star Death Café, ‘The Ungodly Bishop’s Pop-up Confessions,’ Sing Out With Strings, a hugely successful community engagement programme

with the Irish Chamber Orchestra all building up to the main event, the Samhain Parade.

- The **Samhain Parade** of light on 28 October made its way through the medieval streets of Limerick City, including Nicholas Street and over Thomond Bridge before coming back to Limerick's Potato Market. The parade drew in large crowds in all locations who looked on with great excitement as the ghoulish characters, including the ungodly Bishop, procession of lanterns and creatures of the night made their way through the streets to see the rising of the Bishop's Lady.

6. Innovate Limerick DAC

Film in Limerick

Engine Shorts Film Scheme

October saw the six short films commissioned as part of the 2nd edition of Engine Shorts in post-production. Run by Innovate Limerick through Film in Limerick, Engine Shorts is a partnership between the Local Authorities in Tipperary, Limerick and Clare, and Limerick and Clare Education and Training Board. The scheme aims to inspire and support up-and-coming writers, directors and producers to create inspiring, engaging world-class short films that resonate with a wide international audience.

Creative Producing Programme

The 2nd edition of the Creative Producing Programme, in partnership with Limerick and Clare Education and Training Board, was underway with 15 new producers on the six-month programme. Learners attended twice weekly sessions, as well as in-person classes at Engine.

Makers and Shakers Awards at BAFTA

Innovate Limerick, through Film in Limerick, was again nominated for the prestigious international Makers & Shakers Awards. The awards celebrate excellence across screen content production worldwide and shine a spotlight on the work of film industry support services who have made a significant impact on the industry.

Film and TV Crew Academy Courses

Our Film and TV Crew Academy, in association with Screen Ireland, ran two courses in October:

Managing a Sustainable Film Production and Carbon Calculators – This workshop was for production crew and helped them gain a greater insight into sustainable travel, catering, energy, etc., and many more areas to help them in delivering a more sustainable production.

15 local new entrants completed placements on the 'Wayfinders' Production at Troy Studios and locations around Limerick. The placements were organised by Film in Limerick through our Crew Academy project, funded by Screen Ireland. The local crew had the opportunity to shadow trainees in various departments including – Props, Assistant Directors, Costume, Camera, Locations, Video Assist, SFX, Production office and Grips / Electrical.

There was a shared Island event between the five learning cities - Limerick, Cork, Dublin, Derry and Belfast - from 10 to 12 October.

There were inputs on best practice from the participating cities followed by a "Learning Island" consultation session. This session was to collaboratively identify actions for both individual cities and the Irish Network of Learning Cities.

Limerick did a presentation on the Limerick Ambassadors' Programme.

3. Culture

Library

City Library at Barrow House

- The Ukrainian Ambassador to Ireland, Larysa Garasko, was welcomed to the City Library by the Mayor of the City and County of Limerick, Councillor Gerald Mitchell, to launch the new Ukrainian Bookshelf, a collection generously donated by the Ukrainian Embassy. This collection is the first of its kind outside Dublin.
- Europe Direct featured two events, one discussing Ireland's 50-year EU membership and its impact on identity and culture, and another presenting a biodiversity study on rare bumblebee species.
- The library offered two well-attended history lectures, one on the history of Senior Football in Limerick and the other on aircraft crashes at Shannon Airport.
- Positive Ageing Week included an Oxygen Advantage Breathing Workshop from Limerick Sports Partnership focusing on sleep improvement and anxiety reduction.

- The Children's Book Festival included author visits, storytelling sessions, and creative writing workshops for local schools, concluding with a Halloween-themed Storytime.

Strategic Fund for Culture and Arts Scheme 2023

Limerick Arts Office manages the 2023 Strategic Fund for Culture and Arts Scheme. The purpose of the Scheme is to support the maximising of the leveraging of funding into Limerick from national and international sources and to support a vibrant creative culture. In October, three letters of support were issued.

CREATIVE IRELAND

Limerick City and County Council, as lead partner, was recently successful in its application to the Creative Communities on a Shared Island Grant Fund. The successful project, Lace of Ireland, will foster exchanges between lacemaker groups and heritage institutions in Limerick, Armagh and Cork. The long-term goal is to create and promote an island-wide lace trail through the majority of historical lacemaking centres on the island of Ireland.

On foot of this successful application, the Arts Officer I Creative Ireland Coordinator and Creative Communities Engagement Officer attended the Shared Island dialogue on 'Accommodating national identities,' on 25 October in the Abbey Theatre, Dublin.

The Arts Officer I Creative Ireland Coordinator and Creative Communities Engagement Officer attended the official opening of the community mural project at the Desmond Complex in Newcastle West on 18 October. This inclusive project was designed for not only people to paint the wall, but also accounted for service users with varying disabilities to design 3D elements offsite, with their support workers, to secure to the finished mural. The 3D elements that were secured on the wall before the launch included butterflies that were painted offsite by

Rathfredagh Cheshire Home, handprints provided from Desmond Community crèche, wooden hearts decorated by Brothers of Charity, and crochet pieces from Newcastle West Crafty Corner. This project was funded from a Creative Ireland Made in Limerick Grant 2023.



Customer Services

The Customer Services Team continued to support customers and Public Representatives at first point of contact by answering queries via telephone, email, MyLimerick and social media. Case creation, payments processing and generally facilitating applications for all Council services also continued throughout the month.

The following figures highlight the activity within the Contact Centre in October:

- Customer Services Call Centre answered 11,060 calls. This represents an average of 526 per day, with the number of calls reaching as high as 707. A total of 70% of calls were handled at first point of contact.
- A total of 4,102 emails were processed through the Customer Services email platform.
- 3,473 cases were created on Sugar CRM (customer relationship management), with 774 of these logged on behalf of Public Representatives. 2,988 cases were closed, with 747 of these being cases logged by Public Representatives.
- Of the 3,473 cases created, 67% were logged by the Customer Services team.
- The logging of cases through the MyLimerick portal continued, with a total of 188 cases being logged. Of these, 177 were submitted by Public Representatives.
- Customer Services continued to support the Housing Maintenance Department in creating service requests. 95% of Housing Maintenance cases for the Limerick Metropolitan District were logged by Customer Services staff in the Dooradoyle and Merchant's Quay offices.
- October saw a total of 127 out-of-hours cases being created.

- Customer Services continued to provide other frontline services to the public, such as processing applications for Residential Parking Permits, of which 112 were applied for and 78 issued.
- Customer Services staff welcomed a total of 2,350 customers at the Merchant's Quay and Dooradoyle offices.

Halloween in Limerick Promotional Campaign

- Launched a three week #HalloweenInLimerick social and digital campaign.
- Created a new Halloween in Limerick visual identity and graphic elements in line with parent brand, Brand Limerick.
- Rollout of marketing collateral targeting regional audiences, including campaign-specific graphics, animated social gifs and a Halloween in Limerick digital event guide.
- Dedicated Halloween in Limerick social content creation across each of our social platforms, including a competition collaboration with the Escape Rooms Limerick.
- Dedicated weekly Halloween in Limerick e-newsletter distribution promoting Halloween events.
- Continued development of Limerick.ie/Halloween promoting events, festivals and activities.

Limerick Student City

Concluded four-week Limerick Student City marketing campaign, which welcomed Freshers, as well as existing students, to Limerick and encouraged them to engage with all Limerick has to offer, off-campus.

- The campaign, which used the hashtag #LimerickStudentCity, employed captivating content including reels on Instagram and TikTok, static imagery and campaign-specific graphics to engage our target audience.
- The campaign launched two pieces of print and digital collateral: the Limerick Student City map and guide aimed at students who may be new to the city, and the Limerick Student City prospectus targeting those in the consideration stage of choosing a destination for study.
- Campus visits took place at TUS Moylish, Mary Immaculate College and the University of Limerick to meet with students in person and create engagement with Limerick.ie and our social channels via an iPad competition giveaway.
- Pillar-specific merchandise was also created and distributed at these events.
- Marketing also attended the Limerick Open Days on the University of Limerick Campus to engage with potential students, their guardians, teachers and guidance counsellors.

Other Marketing Activities

- Series of autumnal social media reels and posts were created to promote Autumn in Limerick and to reflect content produced on Limerick.ie.
- Ongoing engagement with Festivals and Events and collation of event information to progress the public relations and marketing campaign for Christmas in Limerick 2023, ahead of the festival launch.
