Dear Mr. Leahy,

Thank you for your letter of 26 October to the Minister for Justice, Ms Helen McEntee TD. I am responding on the Minister's behalf.

As you may be aware, the Garda Commissioner is responsible for the management and administration of Garda business under Section 26 of the Garda Síochána Act 2005 (as amended), which includes all operational policing decisions. Under Section 33 of the Act, the Commissioner determines the distribution and stationing of the Garda Síochána throughout the State, in line with the Annual Policing Plan approved by the independent Policing Authority under Section 22 of the Act.

The Minister has no role in determining the duties assigned to individual Garda members and is unable to seek to direct, intervene with, or otherwise influence the Commissioner in these matters. The distribution of resources is a matter for the Divisional Chief Superintendent, with regard to crime trends, population/demographic changes and other factors.

The Minister is advised by Garda management that no established units were considered for disbandment under the proposed reversion to the 'Westmanstown' roster and no consideration is being given at present. It should be noted that the reversion to the 'Westmanstown' roster is not proceeding as Garda management and representative associations are due to hold talks on a new roster agreement.

I refer to your recent email to the Minister for Education, Ms. Norma Foley TD, regarding Monaleen National School.

The project referred to, has been devolved for delivery to Limerick and Clare Education and Training Board (LCETB).

Following receipt of a detailed design and planning Stage 2b report from LCETB for this project, the Department upon review, recommended important enhancements to the project which related principally to the proposed decarbonisation strategy and project phasing requirements for the school.

The Department understands from the latest progress reports submitted by the ETB, that the design team are currently still implementing these recommendations. When finalised, LCETB will submit the revised stage 2b report including the updated cost plan requested, to the Department. Once this information is received, reviewed and approved, the project will then move onward to Tender and Construction in due course.

Dear Mr. Leahy

Thank you for your correspondence to the Minister for Education, Ms. Norma Foley TD in relation to seeking permission for pre-school properties to open after school services.

In reply, and with respect to the position of the Department of Education regarding the use of school property, please note that decisions on the use of school facilities lie with the relevant school authority in consultation with the property owner and priority has to be given to the interests of the school, teachers and pupils.

The Department's policy is to encourage the use of school facilities, where possible, for community, training and education related activities. The Department would encourage schools to facilitate requests wherever possible but on the basis that it would not impede the school's capacity to provide for education, which is the main use of the school property.

To assist schools in considering applications for use of their facilities the Department in consultation with representatives of schools has a set of general Guidelines on the use of school property outside of school hours. This is available on the Department's website at:
