



I will move at the next Meeting that consideration be given for the provision of columbarium structures in Council-owned burial grounds.

The Council are considering columbarian walls for a number of cemeteries. The Council have prepared preliminary designs for Columbarian Gardens for Kilmurray burial ground and also Mount Saint Lawrence burial ground in the metropolitan district. Both of these projects will be progressed further this year. The Council are also considering columbarian walls in cemeteries where there is limited capacity for burials. In this regard, the Council intend to provide a columbarian wall in Adare burial ground this year.

The provision of columbarian walls is very much demand led and is being reviewed on an annual basis.
