The civil engineering contractor for the Templeglantine Bus Shelter Enabling works has been appointed and will commence on site in January 2024 (city bound route).

We are currently assessing the the feasibility of providing bus shelters at the following locations;

- *Devon Road Cross,*
- *Killarney Road, Abbeyfeale.*

We will discuss the above locations with the National Transport Authority. If these locations are approved, they will be added to the 2024 Bus Shelter Enabling Works Grant Application, which will be submitted to the National Transport Authority for approval in February 2024.
