1. Introduction

It is intended that the following proposed disposal of 0.01 acres/0.0042 hectares of land at 1 St. Joseph Street, Limerick (Backyard rectification) (photo attached in this report) will be included on the Agenda for the March Full Council Meeting.

2. Description and Location of Property

The subject land measuring 0.01 acre/0.0042 hectares is located to the rear of 1 St. Joseph Street, Limerick. The land forms part of Limerick City and County Councils (LCCC) folio LK8271F.

3. History of the Property

The rear of the property at 1 St. Joseph Street is part of a larger land bank owned by Limerick City and County Council. The land has been registered to LCCC since the 1970's.

Ms. Helen Arnold purchased the property in the early 90's and the boundary issue was not identified at the time. Ms. Arnold has approached the council through her legal representative and requested that the backyard be transferred into Ms. Arnold's name.

4. Executive Recommendation to Council

The proposal before the Members is to note the proposed disposal of 0.01 acres/0.0042 hectares of land (backyard) at 1 St Joseph Street, Limerick to Ms. Helen Arnold for a consideration of a nominal fee of €1. Ms. Helen Arnold will discharge all legal and other costs incurred by Limerick City and County Council.
