1. Trade and Investment

Customer Care firm, Everise, announced 100 new positions for its city centre office. Located in Limerick since 2016, the Florida headquartered company operates from a 5,800 square foot office on Thomas Street where 130 are presently employed. The new positions available include customer service representatives, IT support specialists and other support staff. The new roles involve providing support to healthcare customers with insurance plans based in the USA. Everise provides back-office support to a huge number of blue-chip firms from across the world.

2. Local Enterprise Office (LEO) Limerick

The national LEO Employment Survey 2023 results were published in January showing LEO Limerick ranking 1st nationally with net jobs created and supported in 2023.

FESTIVAL AND EVENTS

The Hunt Museum - Kite Power Festival

In conjunction with the Kite Power Festival facilitated by the Hunt Museum, workshops took place in the city and county throughout January. The workshops enabled participants to create kites in a visually captivating and eco-friendly manner. The theme was to explore ways to encourage participants to recycle, by reusing their paper waste from the holiday period.

World Rally Championship (WRC) Limerick

Limerick has been chosen as one of three locations to be included in Motorsport Ireland's bid to host a round of the World Rally Championship. Limerick, along with its neighbours, Kerry and Waterford, were shortlisted to be the venues to host the Fan Zone, Service and Media areas for the event. With the judges not being able to decide on one winning location, the decision was made to have each location host one year from 2025 to 2027.

Limerick Racecourse has been identified as the venue to stage Limerick's event. The World Rally Championship has a global audience of 80 million in media viewership and the event will potentially bring up to 250,000 spectators and millions of euro in revenue to the Limerick economy during the event. The success of the Motorsport Ireland's application to Federation Internationale de l'Automobile (FIA) now rests with the Irish Government who have been asked to commit the necessary funding to ensure the event comes to Ireland for the next three years. A decision on the success of the application is awaited.

Film in Limerick

Film in Limerick wins Film Commission of the Year in London

Innovate Limerick, through Film in Limerick, won the prestigious Film Commission of the Year Award at the international Makers & Shakers Awards, at BAFTA London. The awards celebrate excellence across screen content production worldwide and shine a spotlight on the work of film industry support services who have made a significant impact on the industry through creativity, innovation and ground-breaking initiatives in the past year.

Blackshore TV Series screening on RTE 1

The six-part TV drama series, Blackshore, attracted to the region and supported by the Film in Limerick office, is now screening on Sunday nights on RTE 1. Filmed entirely in Killaloe, Ballina and in Limerick City, Blackshore, from the makers of Smother (also filmed in the region), tells the story of a missing person, with an investigating detective bruised by a traumatic past, in a pretty town with dark secrets. Produced by Treasure Entertainment, the production worked with Film in Limerick creating local employment and supporting local businesses in the area.

Double-Blind Feature Film in Cinema

The feature film, Double-Blind, 100% filmed in Limerick at the Innovate Limerick managed Rathkeale Industrial Estate and at the University of Limerick, is now playing at all Limerick cinemas. Double-Blind tells the story of an experimental drug trial that goes horribly wrong, with the surviving test subjects fighting off sleep, and each other, to stay alive. The film has received excellent reviews and is now playing nationwide.

Engine Shorts

The second edition of Film in Limerick's short film scheme, Engine Shorts, has commissioned and produced six new short films from local new writers, producers, directors and crews. The films are now in post-production and will be

premiered at film festivals and at a screening in Limerick later this year. Engine Shorts is funded by the Local Authorities in Limerick, Clare, Tipperary, Limerick and Clare Education and Training Board and Creative Ireland.

European Film Market at Berlinale

Three local producers have been selected to join the annual Film in Limerick Delegation to the European Film Market in Berlin in partnership with Limerick and Clare Education and Training Board. Melissa Collins, Grainne Carroll and Stephen Hall are the selected producers. The European Film Market (EFM) is the business centre of the Berlin Film Festival and one of the top international film markets in the world attended by over 8,300 international industry professionals.

Transportation and Mobility Directorate

1. Travel and Transport Strategy

Limerick City and County Council and An Garda Síochána launched the “Think Before You Park” Awareness Campaign on 29 January.

The aim is to inspire motorists, across the city and county, to reflect on the repercussions of obstructive parking. Whether it is impeding footpaths, bus corridors, cycle lanes, or access points, badly parked vehicles can pose challenges for various road users, including people with disabilities, cyclists, parents pushing buggies and other pedestrians. Bad parking affects the flow of our public transport services and causes traffic congestion. As part of the Think Before You Park campaign, for a limited period, members of the Garda Roads Policing Unit in Limerick have commenced placing information stickers on vehicles that have been issued with fixed charge notices for parking offences. A QR Code on the sticker directs the motorist to the Think Before You Park campaign webpage on Limerick.ie where they can find out more about the impact of bad parking.

2. Active Travel

Rural, Community and Culture Development Directorate

1. Rural Development

On 12 January, the Department of Rural and Community Development awarded €280,541 in funding for a range of projects to be delivered through the CLÁR 2023 Programme. Seven Limerick community groups were successful: Doon Community Centre, Feenagh Old Schoolhouse CLG, Mountcollins Community Centre, Tounafulla Development Association, Templeglantine Community Development Association, Galbally Community Council and Rathkeale District Office. Projects include car park developments, upgrading of community centres, access road improvements and outdoor gym equipment for adults. This announcement brings the total of CLÁR 2023 funding awarded to Limerick under this programme to €543,967, with a previous allocation awarded in December 2023.

2. Community Development

Local Community Development Committee

- A meeting of the Local Community Development Committee was held on 09 January in the Council Chamber, Dooradoyle, and Online. Some of the items discussed included the new Social Inclusion and Community Activation Programme 2024-2028, Local Enhancement Programme 2024 and closure of the 2014-2022 LEADER Programme.
- The Local Enhancement Programme was advertised on 19 January. This Grant Scheme is a small capital grant scheme for community groups. The maximum grant is €4,999.

Social Inclusion and Community Activation Programme (SICAP)

- The Annual Performance Reviews for the 2023 SICAP Programme delivery took place, with a budget for SICAP in Limerick in 2024 of €2,929,883.00.

- The new SICAP Programme, funded by the Department of Rural and Community Development and the EU, for the period 2024-2028, began in January. The Local Community Development Committee oversees the programme. The three Limerick LOTS or areas are: LOT 21-1 Limerick West Rural where West Limerick Resources CLG implements the programme, LOT 21-2 Limerick Urban where the PAUL Partnership Limerick CLG implements the programme, and LOT 21-3 Limerick East Rural where Ballyhoura Development CLG implements the programme.

Public Participation Network (PPN) Limerick

- Membership of PPN Limerick continued to grow and stands at 204. The membership registration form is on the Limerick PPN [website](#) and eligible groups in Limerick can register at any time.
- Nominations were opened to fill vacant Seats on the Secretariat and Strategic Policy Committees.
- Two Linkage Group meetings were held in January - Climate Action, Biodiversity and Environment; and Home and Social Development.

Integration Supports

Ukrainian Community Forum

On 30 January, the Ukraine Community Forum held a workshop to review 2023 activities, identify emerging issues and agree actions to assist the Forum in the co-ordination and facilitation of support services for the Ukrainian community in 2024.

Migrant Support Forum

The Migrant Support Forum, whose membership consists of members of the Migrant Community only, held a meeting on 25 January. Elections were held on the night for positions on the Executive Committee, Chair and Vice-

Chairperson, Secretary and Vice- Secretary. The Forum is supported by Limerick City and County Council.

Sláintecare Healthy Communities

A number of MoveWell Programmes took place during the month, including Aqua Aerobics for Chronic Pain and Arthritis (St. Gabriel's Hydrotherapy Pool); Activator Walking for Neuro Conditions (Southill Hub).

Venture Out events took place, including a weekly Singing for Lung Health Group, initiated at Moyross Community Hub, focusing on individuals with chronic lung conditions in Northside Limerick City.

Bin Waiver Scheme

The Household Waste Collection Subsidy Scheme closed to applications on 31 January. Out of the total of 3,708 received, 2,094 permits have been issued during the scheme's open period, with a number of applications still in progress.

Age Friendly

The Draft Age Friendly Strategy went before the Plenary Council on 22 January for noting, following which it went to the National Age Friendly Ireland Shared Service for final sign-off. The Shared Service supports all the local Age Friendly programmes hosted in the Local Authorities.

3. Culture

Library

City Library at Barrow House

- On 16 January, the branch hosted one of a series of drop-in information sessions from Limerick Arts Office on funding grants and opportunities available in 2024. An audience of 30 received expert advice on how to apply, what grants are available, and how applications are assessed and allocated.

- Emerging Limerick Filmmakers (ELF), the organisation for young filmmakers in Limerick, held three training sessions on 05, 20 and 27 January for filmmakers wishing to learn more about the editing process involved in exploring their cinematic voices.
- A new course of digital skills classes for absolute beginners began on 30 January organised by Limerick City Library and Europe Direct Limerick, in partnership with the Vodafone Ireland Foundation. Addressing the digital divide, tablets were made available for home use.
- In the Children's Library, events included Róisín Meaney's regular monthly story session 27 January, Scéalta agus Rannta with Joanne from Comhluadar Luimnigh on 20 January, while the library's own weekly toddler storytime continued on Wednesdays.

Limerick Museum

- Limerick Museum was accepted into the Museum Standards Programme for Ireland (MPSI). The purpose of the MSPI is to benchmark and promote professional standards in collections' care and to recognise the achievement of those standards within the Irish museum sector. The programme recognises the achievement of those standards through accreditation. It is used to set a baseline for management of collections in not-for-profit institutions that collect, safeguard, hold in trust, research, develop and interpret collections of original objects and items on loan, for the public benefit.
- The Exhibitions - Let's go Shopping! A History of Retail in Limerick, and The Art of the Stitch: The Enduring Legacy of Maude Kearney - continued in Limerick Museum for the month of January.
- The Curator was interviewed on the history of Limerick's Mayoralty by Limerick Journalist, Petula Martyn, as part of a package on the Directly Elected Mayor that was broadcast on Morning Ireland on RTE Radio One, and by a Researcher from Trinity College, Dublin, on the same topic.
- The Museum acquired a framed tapestry commemorating a local veteran of the First World War from one of his relatives; and a fine collection of memorabilia relating to the Treaty 300 celebrations of 1991 and other events in Limerick's public life, from Elenora Hogan.
- The Friends of Lace met in Limerick Museum on 27 January.

Limerick Arts Office

OPEN CALLS

Strategic Fund for Culture and Arts Scheme 2024

Limerick Arts Office manages the 2024 Strategic Fund for Culture and Arts Scheme. The purpose of the Scheme is to support the maximising of the leveraging of funding into Limerick from national and international sources and to support a vibrant creative culture. In January, three letters of support were issued.

Grants under the Arts Act

The Grants under the Arts Act opened on 29 January. These grants are open to artists, community and voluntary groups to promote the arts and provide access to arts for Limerick. The total grant budget is €20,000 and grants offered are usually between €150-500, with €1,000 being offered in exceptional circumstances.

Funding and Grants Roadshow

The Arts Office held a series of sessions in Libraries around the county, and online, advising on the various grants and funding opportunities available through the Arts Office. 1. Regeneration and Sports

Regeneration

The Draft Status Update of the Limerick Regeneration Framework Implementation Plan (LRFIP 2014-2023), prepared by consultants KPMG, has been submitted to the Department of Housing, Local Government and Heritage for consideration. The Department has confirmed that, while detailed consideration of the broader request under the Draft LRFIP Status Update was ongoing, funding will be available in 2024 for the continuation of ongoing projects and for applications under the Economic and Social Intervention Fund (ESIF). Consultation meetings were continuing with the officials from the Department to clarify any queries arising from the review document.

Economic Regeneration

Outreach to Employment Programme

Initiatives on the Outreach to Employment Programme continued in each of the Regeneration communities. A meeting of St. Mary's Park Employment Group was held where the work programme for 2024 was discussed.

Community Mentors – Expansion of the Community Mentor Network is ongoing and recruitment for the position of a Southside Community Mentor, to be hosted by Southill Hub, commenced with interviews for this position held.

Personal Development Pilot Programme – This programme is a multi-agency initiative which was developed by the Employment Project Team to work with people in the Regeneration Communities who have experienced addiction. The Programme has commenced, and a Personal Development Tutor has been recruited by Limerick and Clare Education and Training Board. This Programme is hosted on site in The Learning Hub, Kileely.

Social Regeneration

Economic and Social Intervention Fund (ESIF) Update

- The drawdown of funding for approved Economic and Social Intervention Fund projects continued. Ongoing evaluation and coordination work continued with ESIF recipients.

Community Activities

Moyross

In conjunction with the Limerick Sports Partnership, a number of weekly activities took place in Moyross during January:

- Functional Fitness had 10-15 participants each Wednesday in Moyross Community Centre.
- Two local fully qualified instructors ran classes four days per week with an average of 12 attendees at the Moyross Community Centre.
- An adapted physical activity programme/social outlet for older adults in Moyross and surrounding areas was also held at Moyross Community Centre.

King's Island

- An event was held to celebrate Nollaig na mBan in King's Island Community Centre. Residents of St. Mary's Park were treated to complementary therapies from the Body Tree Community Clinic with 30 women in attendance.

Clare (Parteen and Ardnacrusha)) and one for County Limerick. The Draft Plans provide the results of the strategic noise maps from all roads, rail and Environmental Protection Agency selected industrial sites (with an Industrial Emission licence) in the Agglomeration and major roads (>3 million vehicle passages per year) in the County. The Plans provide an assessment of the exposure to noise and its harmful effects on the population and based on the results address long-term strategic management through measures targeting mitigation, prevention and preservation.

Parks

O'Brien Park, Clare Street, Limerick

The installation of Physical Activity Play Equipment, funded by Limerick Sport Partnership Active Cities Initiative Project has completed, which include Table Tennis, Teqball tables and Volleyball Nets. Also, part of the installation is a BoxUp equipment locker, stocked with Table Tennis Rackets, Teqball, Soccer Ball, Basketball, dumbbells and skipping robes. These lockers are free to use and can be accessed through the BoxUp app.

These amenities, aimed at promoting active lifestyles and fostering community engagement, are made possible through the Active Cities Project. Funded by Sport Ireland through the Dormant Accounts Fund, this project aims to help shape recreational spaces across the city, encouraging participation and improving accessibility.



Customer Services

The Customer Services Team continued to support customers and Public Representatives at first point of contact by answering queries via telephone, email, MyLimerick and social media. Case creation, payments processing and generally facilitating applications for all Council services also continued throughout the month.

The following figures highlight the activity within the Contact Centre throughout the month of January:

- Customer Services Call Centre answered 12,140 calls. This represents an average of 552 per day, with the number of daily calls exceeding 700 on several occasions and reaching as high as 777. 71% of calls were handled at first point of contact.
- A total of 4,455 emails were processed through the Customer Services email platform.
- 3,918 cases were created, with 856 of these logged on behalf of Public Representatives. A total of 3,350 cases were closed, with 741 of these being cases logged by Public Representatives.
- Of these 3,918 cases, Customer Services staff logged 86% of same.
- The logging of cases through the MyLimerick portal continued, with a total of 283 cases being logged. Of these, 248 were submitted by Public Representatives.
- Customer Services continued to support the Housing Maintenance Department in creating service requests and, throughout January, 96% of housing maintenance cases for the Limerick Metropolitan District were logged by Customer Services staff in the Dooradoyle and Merchant's Quay Offices.
- A total of 143 out-of-hours cases were created.
- Customer Services continued to provide other frontline services to the general public, such as processing

applications for Residential Parking Permits, of which 110 were applied for and 95 issued.

- Customer Services staff welcomed a total of 2,595 customers at both the Merchant's Quay and Dooradoyle Offices.
