**Notice of Motion from Councillor Carey**

I will move at the next meeting of the Cappamore/Kilmallock Municipal District that this local authority allow stones to be spread on the floor, a seating bench, an information board and consider allowing public access to St. Andrews Medieval Church at Kilfinane Graveyard.

**Response:**

It was always the Councils intention to allow public access to St Andrew's Medieval Church in Kilfinane Graveyard. The seating and information board are included on proposed plans for opening up the Church to the public. There is currently architectural stone stored inside the Church and discussions are occurring with the Department and National Monuments to agree its long term storage. Once the storage of the architectural stone is resolved, it is intended to place the seating along the north wall to avail of maximum sunshine in the Church ruin. In relation to the surfacing, the Department are not in favour of a gravel surface. It is considered that grass/sod is a more appropriate and environmentally acceptable material for the interior surface of the Church.

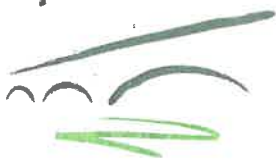
“I will move at the next meeting of the Cappamore Kilmallock Municipal District that a pedestrian crossing be put in at Holycross on the R512 where there is very large movement of traffic and pedestrians.”

**REPLY:**

The current speed limit on the R512 at Holycross is 80kph. This makes the location unsuitable for the installation of a pedestrian crossing at present. However, as part of the 2023 Speed Limits Appeals process, there is a proposal to reduce the speed limit at Holycross to 60kph. This proposal will be advertised for consultation shortly. If there are no objections or submissions, this speed limit revision will be incorporated into revised draft speed limit bye-laws for Limerick and brought forward to full council for consideration and approval. If the proposed reduced speed limit is adopted, the Municipal District office will assess the pedestrian crossing movements and if warranted, a design will be prepared and a funding submission made to the relevant funding authority.

### **REPLY:**

The Municipal District office will assess current traffic speeds on the R518 at the location identified. If it is determined that traffic is exceeding the speed limit, suitable traffic calming measures will be identified and a submission for funding will be made to the appropriate funding authority . It should be noted that any proposed speed limit extension cannot be determined by the MD office.
