Economic Development, Enterprise and Tourism Directorate

1. Trade and Investment

CLAYTON Hotel Limerick, part of the Dalata Hotel Group PLC, announced an investment of over €300,000 in their meetings and events space located on the first floor of the hotel on Steamboat Quay.

SYS Mortgages, a mortgage intermediary specialist, officially opened its new Limerick office at 3, The Crescent. Established in 2015, SYS incorporates SYS Financial Planning, SYS Employee Benefit Solutions, SYS Mortgages, SYS Public Sector Advisory, SYS Private and SYS Health Advisory Insurance. 10 jobs will be created at its new Limerick office.

Retail chain, The Works, announced its plans to open a new store on O'Connell Street. 121 O'Connell Street, which has been vacant for almost two years, is to be occupied again. The Works sells a range of books, toys, stationery items, craft materials and gifts. The company already has a number of outlets in Ireland, with two in Cork, one in Gorey, one in Kilkenny, one in Killarney, one in Athlone, and multiple branches over the border in Northern Ireland. 10 jobs are expected to be created in the Limerick store.

2. Local Enterprise Office (LEO) Limerick

The Local Enterprise Office Limerick hosted the annual Student Enterprise Programme County Final on 14 March in the Castletroy Park Hotel. 42 teams from secondary schools across Limerick City and County competed and hosted a display of creativity and determination in setting up their own mini-enterprises. The Head of Enterprise emphasised the significance of the event saying, *"The Student Enterprise County Final is probably the pinnacle of our year's events. The winners will go on to represent Limerick in the All-Ireland Finals, and we have a very good track record in that."* Mini-enterprise winners included awards for Innovation, Best Marketing, Best Business Plan, Sustainability, Best Display and a Teachers Award.

Also during March, LEO Limerick hosted Local Enterprise Week 2024 from 04 to 08 March. A total of 325 people signed up to the 11 different training sessions, networking events and seminars that LEO Limerick delivered throughout the week, both in-person in the Engine as well as online webinars.

3. Tourism

- Limerick Greenway recommended as a "must-do" in Limerick over the Easter holidays by Travel Expert, Sarah Slattery, in her interview with Andrea Gilligan on Lunchtime Live on Newstalk on 25 March.

Limerick St. Patrick's Festival 2024

Over the weekend of 15 to 18 March, the St. Patrick's Festival came to life with the energetic St. Patrick's Day parade and Limerick's unique International Band Championships. There was a great atmosphere throughout the weekend with events such as the Shamrock Street Shows and Music at the Green Stage entertaining onlookers with various street performances and amusements on the streets of Limerick on 16 March.

On 17 March, pre-parade and post-parade entertainment included dance group, the Mirror Dancers, and the Hit Machine Drummers.

St. Patrick's Day Parade

The Limerick St. Patrick's Parade brought tens of thousands of people to the streets of Limerick City. The theme this year was "Limerick: A different type of energy" to highlight Limerick's creativity and unique vibe. The Grand Marshal was Sean O'Sullivan, winner of the BT Young Scientist of the Year Award 2024. There were over 1,000 participants from 70 groups with a wide range of interests, including Scout Groups, Sports Groups, Community Groups, as well as amazing floats such as the Pirate Ship from aerial performance company, Fidget Feet. Bui Bolg showcased a large-scale snake that wowed spectators, and various vehicles from service vehicles to the rally cars added some trill, all enhanced by the music from multiple marching bands. The Mayor of the City and County of Limerick, Councillor Gerald Mitchell, commented: *"The parade was fun and exciting with great enthusiasm from the crowds and the participants. It was a fantastic show of community spirit and a worthy celebration of our Patron Saint. Limerick City and County Council must be commended for delivering a fantastic festival across this weekend."*

52nd International Band Championships

On 18 March, the 52nd International Band Championships took place. This is a unique event to Limerick. Tens of thousands of viewers lined the streets of Limerick to see the sixteen Marching Bands from Limerick, Ireland and from around the world. The Bands entertained the crowds with their music, chorography and costumes. Niall Carroll (Lyric FM Presenter), Dr. Evelyn Grant (Cork University Lecturer), Norman Rodgerson (Former First-Class Warrant Officer and Bandmaster) and Dr. Jonathan Helmick (Director of Bands at Slippery Rock University) judged the competition. There were numerous prizes from Special Judge's Awards to Best uniform. The overall Champions were Lakeville South Marching Cougars from Minnesota. The Band Championship brought a display of exceptional musical talent and explosive energy and a perfect way to end the St. Patrick's Festival weekend.

Other events over the weekend included: Street Show Saturday which saw the City streets come alive with a family fun day of high energy acrobatics, magic and comedy on Bedford Row and Thomas Street; city centre streets were also animated with roving stilt walkers and circus figures and the Limerick City Centre Traders' Association spread the fun with a range of amusements on Cruises Street.

Limerick Early Music Festival

The Festival took place from 20 to 23 March. Early Music is comprised of Medieval and Renaissance music. The Musical Journey began with Sung Compline performed by vocal ensemble, Peregryne. On 22 March, various Limerick musical groups in the beautiful surroundings of St. Mary's Cathedral were performing Bach. Medieval music in costume was performed in the Milk Market the next day and followed up by more medieval compositions in St. John's Church on the subject of travel, pilgrimage and spiritual journeys. The Finale took place on the night of 23 March and was the music and poetry from the Al-Andalus era, this music is still played to this day in North Africa. The concert consisted of Moroccan Nubas, Gharnati Songs and Andalusian Poems performed by renowned musicians, Vanessa Paloma Elbaz, Zaki Chaabi and Mustafa El Meknassi.

Limerick Lace Symposium 2024

Limerick Lace Festival/Symposium took place on 23 March at the Absolute Hotel. The event celebrated and promoted Limerick Lace and was opened by the Mayor of the City and County of Limerick, Councillor Gerald Mitchell. The morning consisted of talks from the Curator, Limerick Museum, and from Sharon Slater, Randel Hodkinson and Grania McElligott on the history and legacy of Limerick Lace. Bairbre Guilfoyle gave the keynote talk on lacemaking in Ireland followed by more short talks on Lace projects across Ireland. In the afternoon, there were three Panel Discussions on The Laces of Ireland - An All-Ireland Lace Trail, The precious Lace and the Final Panel Discussion was on Keeping the Craft Alive in the 21st Century.

King John's Castle Masterplan Announcement

Another new chapter is set to be written for King John's Castle with international Design Consultants appointed to prepare a Masterplan that will guide the transformation of the iconic 13th century castle into a world-class visitor attraction. A multi-disciplinary Design Team, headed up by international Design Practice, Galmstrup Architects, has been appointed to create a roadmap for maximising the potential of one of Ireland's foremost cultural and heritage sites.

The Mayor of the City and County of Limerick, Councillor Gerald Mitchell, and the Minister of State for Planning and Local Government, Mr. Kieran O'Donnell, TD, attended the announcement on 12 March, along with the Board members and staff members of Discover Limerick DAC. This announcement attracted widespread coverage when released to the media, making the papers, Limerick Leader and Irish Examiner on 20 March and widespread coverage online via social media channels.

1. Travel and Transport Strategy

The Adare Transport Plan

- The Adare Transport Plan commenced.

Limerick City and County Council Control of Car Clubs Draft Bye-Laws 2024

- At the March Monthly Meeting of the Metropolitan District of Limerick, Councillors approved placing the Limerick City and County Council Control of Car Clubs Draft Bye-Laws, 2024, on public display, in accordance with the requirements of the Section 200 (1) of the Local Government Act 2001 (as amended).

Marchathon Step Challenge

- 22 teams from Limerick City and County Council took part in the Step Challenge.

Approval of Bloodmill Road Extension

- An Bord Pleanála approved the Bloodmill Road Extension Scheme. The aim of the Scheme is to realign the existing Bloodmill Road to link with the recently constructed developer-provided Link Road Section. The road scheme will implement improved Active Travel measures for pedestrians, cyclists and public transport to serve the new secondary school and private hospital on adjacent land. Furthermore, the proposed road extension will open access to surrounding undeveloped zoned lands.

Plassey Park Road, Castletroy, Limerick: Foundations for a new bus shelter installed and work on a new stone wall at Kilmurry Lodge progressed.

Father Russell Road, Raheen, Limerick: Works continued at Racefield Roundabout; cycle lane segregation kerb works continued.

Mill Road, Corbally, Limerick: Foundation poured in Bishop's Field area.

Our Lady of Lourdes National School, Rosbrien, Limerick: Works began on week of 25 March.

Laurel Hill Avenue, South Circular Road, Limerick: Works began on week of 25 March.

1. Community Development

Local Community Development Committee

- A meeting of the Local Community Development Committee (LCDC) was held on 05 March in the Council Chamber, Dooradoyle, and Online. Some of the items discussed included SICAP (Social Inclusion and Community Activation Programme) 2023 End-of-Year Review, SICAP 2024 Annual Plans, LCDC Annual Report and the LEADER Rural Development Programme. A Presentation was given to the members on the Local Economic and Community Plan (LECP).

SICAP (Social Inclusion and Community Activation Programme)

- The budget for SICAP in Limerick in 2024 is €2,929,883.00 and training on the new IT system that is used to support the Limerick SICAP workers in delivering the new SICAP Programme 2024-2028 was completed in March.
- The 2023 Annual Performance Reviews of the three Limerick areas were approved at the March meeting of the LCDC as follows:
 - LOT 21-1 Limerick West Rural where West Limerick Resources CLG implements the programme.
 - LOT 21-2 Limerick Urban where the PAUL Partnership Limerick CLG implements the programme.
 - LOT 21-3 Limerick East Rural where Ballyhoura Development CLG implements the programme.

Public Participation Network (PPN)

- Membership of PPN Limerick continued to grow and stands at 219. The membership registration form is on the Limerick PPN [website](#) and eligible groups in Limerick can register at any time.
- The Secretariat continued to fulfil its function with a meeting held in March.
- PPNL continued to have an active presence with its regularly updated website, social media and bi-monthly Newsletter distributed to members.

Integration Supports

INTEgreat - Limerick Migrant Integration Forum

- Limerick Migrant Integration Forum participated in this year's St. Patrick's Day Parade, winning Best Community Award.
- International Anti-Racism Day on 21 March was marked at an event in Limerick in which the Limerick Migrant Integration Forum was officially launched by the Mayor of the City and County Limerick, Councillor Gerald Mitchell. This event, and launch, was run as part of the ongoing Limerick United Against Racism (LUAR) campaign. The campaign is an initiative of the Migrant Integration Steering Group, which is a network of 19 statutory agencies, community and voluntary organisations and migrant representative and support groups and many of them have joined to show their support.

Bin Waiver Scheme

The Household Waste Collection Subsidy Scheme applications continued to be assessed during March. Out of the total of 4,145 applications received, 3,856 have been issued during the Scheme's open period, with a number of applications still in progress.

Limerick City Gallery of Art (LCGA)

- The exhibition programme, which includes COSMUS by Irish artist, Brigid McLeer, a collaboration with Crawford Art Gallery to mark the 100th anniversary of the Friends of the National Collections of Ireland (FNCI) and Searching in the Dark, a series of paintings by Eddie Cahill, continued to attract significant visitor numbers in March.
- The Gallery's artist in residence, Michella Perera, was very active throughout the month in identifying participants for a series of free workshops at LCGA. In particular, she has reached out to Mary Immaculate College and PAUL Partnership who have been very responsive and co-operative.
- The Shinnors Scholar, Aoife Doherty, held two workshops for primary school children, which were very successful. Aoife also led two Gallery tours for the University of the Third Age.
- Several community groups continued to use the Gallery for meetings and events. These included the University of the Third Age (U3A) who hold their regular poetry and music meetings in the Gallery.
- The total number of visitors to the Gallery in March was 4,782.

Limerick Museum

- On 13 March, the Mayor of the City and County of Limerick, Councillor Gerald Mitchell, performed the official opening of Girl Unknown, an exhibition of works by Éadaoin Glynn, a painter based in Cork. The exhibition was a series of new paintings by Éadaoin inspired by old glass slides in the Limerick Museum collection. These glass slide negatives were discovered in a basement and donated to the Limerick Museum. They are made of glass and are extremely fragile. It was one of a number of exhibitions in the Museum where the artist has responded to, and been inspired by, objects in the permanent collection. On 23 March, Éadaoin gave a fascinating and well-attended public lecture on her exhibition in the Museum.
- On 13 March, the Mayor of the City and County of Limerick, Councillor Gerald Mitchell, also performed the Official Opening of Pagan Ireland and St. Patrick, an exhibition curated by the Assistant Curator which formed part of Limerick's St. Patrick's Festival for 2024. Using Bronze and Iron Age objects from the permanent collection, the exhibition explored the customs and beliefs that existed in Ireland prior to the arrival of St. Patrick, and how Ireland's Patron Saint converted an already spiritual people to Christianity.
- On 08 March, Limerick Museum marked International Women's Day by hosting what has now become an annual lecture hosted by the Limerick Federation of the Irish Countrywomen's Association. This year, the lecture was on 'All Things Environmental' and was delivered by Limerick City and County Council's Biodiversity Officer and Environmental Awareness Officer.
- The Museum continued its very active outreach programme. The Curator gave tours of the Museum to the Southill Drama Group on 12 March and to a group of trainees from the HSE Training Centre, Theatre Court, Mallow Street, on 14 March and the Assistant Curator gave two tours to the transition year classes from St. Mary's Secondary School, Nenagh, Co. Limerick Arts Office

Individual Arts Bursary, Theatre Bursary and Dolores O' Riordan Music Bursary Awards Schemes

On 20 March, Limerick Arts Office issued an Open Call for applications from professional artists for the Individual Arts Bursary (up to €4,000), Theatre Bursary (€5,000) and Dolores O'Riordan Music Bursary (€4,000) Awards Schemes. Artists based in Limerick City and County Council's administrative area, or operating substantially within Limerick City and County, can apply for a Bursary in any art form, including Visual Arts, Circus, Dance and Literature, Theatre and Music.

University Hospital Limerick - Artworks Loan Launch

Limerick Arts Office loaned 32 artworks to University Hospital Limerick for display across its corridors to increase access to artworks to those who use the hospital, including patients, visitors, and staff. This exhibition was launched by the Mayor of the City and County of Limerick, Councillor Gerald Mitchell, on 27 March, in University Hospital Limerick.

Limerick Artists - Professional Development

Visual Artists Ireland hosted a networking event for artists based in the Mid-West in Limerick City Art Gallery 14 March. This event was funded by Limerick Arts Office, in partnership with Clare Arts Office and Tipperary Arts Office.

Strategic Fund for Culture and Arts Scheme 2024

Limerick Arts Office manages the 2024 Strategic Fund for Culture and Arts Scheme, which was developed by Limerick City and County Council to facilitate culture and arts organisations and practitioners, in leveraging funds from national and international sources. This, in turn, helps support a vibrant creative culture in Limerick. Nine letters of support were issued in March.

Grants under the Arts Act

Assessment of 52 applications from individual artists or organisations under the 'Grants under the Arts Act' Scheme was completed on 13 March by an independent panel.

Creative Ireland Made in Limerick Grants Open Call

A total of 57 applications were received under the Creative Ireland Made in Limerick Grants Scheme, which closed for applications on 06 March. These grants were open to Limerick-based creative practitioners, organisations and communities of place and interest to submit applications. They were assessed on 27 March by an independent expert panel.

Night Time Economy - Cruinniú na nÓg 2024

The Limerick Creative Ireland Team was successful in its application to the Department of Tourism, Culture, Arts, Gaeltacht, Sport and Media for €8,000 in Night Time Economy funding for Cruinniú na nÓg 2024.

Creative Ireland and the Limerick Arts Office welcomed Christopher Bailey to Limerick

Christopher Bailey, Arts and Health Lead at the World Health Organisation, visited a selection of Creative Ireland funded projects in Limerick on 05 March. This visit was coordinated and facilitated by the Limerick Creative Ireland Team. Mr Bailey was in Ireland to participate in Creative Brain Week at Trinity College, in conjunction with Creative Aging International and the Global Brain Health Institute for Creative Brain Week, at Trinity College Dublin.

Play Space and Associated Landscape

The Main Contractor tender package for Southill Play Space and Associated Landscape was published on eTenders. This contract provides for the construction of a play space of approximately 1,052^{m2}, which will include hard and soft landscaping, the provision and installation of play equipment, for use by the children and young people living within the community.

Easter Events at Southill Hub

The Southill Hub hosted a number of events throughout Easter, including an Easter Bonnet competition on 25 March, and a Teenagers' Easter Disco on 27 March. A Bingo session and an Easter raffle were also held on the same day. The teenage disco was particularly popular, with the organisers confirming it was sold out, well in advance of it taking place.

Team Limerick Clean-Up (TLC) - Southill

Team Limerick Clean Up took place in Southill on 29 March. The community was very well represented with volunteers coming from the Southill Hub, Tait House and the Tidy Towns Committee.

Physical Regeneration

Housing Developments

- A total of 47 units at Cosgrave Park and Dalgaish Park, Moyross, progressed towards projected phased handover in Q2/Q3 2024.
- Construction works on the Sheep Street development, comprising of eight social housing units, continued.
- 37 housing units at Churchfield, Southill (Phase 2) - construction continued to advance on these units.
- Paul Keogh Architects progressed their design review of Cosgrave Park Phase 2 with a view to potential future modifications.

- Preliminary design and follow-up public consultation sessions were undertaken for a new housing project being advanced at Pineview Gardens, Moyross. This infill development will provide up to circa 67 residential units within the area.
- Progress continued with the works on the preparation of a Preliminary Design for a 20-unit housing scheme at Cliona Park, Moyross, Phase 4. It is now being advanced to a Stage 2 submission for Department of Housing, Local Government and Heritage to consider. A contractor has been appointed for site investigation works.
- Approval was received from the Department of Housing, Local Government and Heritage to proceed with appointment of M. Fitzgibbon Contractors Ltd. for 24 infills at Carew Park, in Southill, and Delmege Park and Hartigan Villas in Moyross.

Status of Thermal Upgrade Projects

- 47 units at Moyross, Limerick, were progressed under Thermal Upgrade Contract No. 121, with contractor, Icarus Properties Limited.
- Alan Hart Construction Ltd. progressed Thermal Upgrade Contract No. 123, in Southill, Limerick, which encompasses 53 properties.
- Work on 12 units, under Thermal Upgrade Contract No. 127, in Ballinacurra Weston, Ballinacurra, was continued by the contractor, JoeBren Construction Ltd.
- The detailed design for 55 housing units in Pineview Gardens, Moyross, under Thermal Upgrade Contract No. 130 continued.
- Final certification received in relation to Thermal Upgrade Contract No. 112 which has been closed out.

- Public Consultation Event held on 20 March.

Environmental Works

- The removal of redundant hardstanding areas in Salvia Court, Keyes Park, Southill, which was a source of flooding to Rose Court properties in Keyes Park, Southill, continued.

- As part of Women in Sport Week 2024, Limerick Sports Partnership (LSP) in collaboration with local clubs and NGBs (National Governing Bodies), hosted 22 different events. - Recent graduates from the Boxing Clever Programme were assessed at QQI Level 5 Community Addiction Studies and Health Related Fitness. Eight graduates were certified following the 24-week programme. This initiative caters for those recovering from addictive behaviours such as drugs, alcohol and gambling issues. Graduates can apply to undertake further education opportunities provided in the University of Limerick, TUS – Technological University of the Shannon, and Maynooth University to advance their skills in personal development and addiction management.
- The 65 Fourth Year Physical Education students, placed by LSP in local community groups, continued working through their eight-week programme. Throughout this period, students help to deliver Physical Activity initiatives. Community Groups that were supported include Youth Services, Older Adult Groups, Mental Health Groups, Desk to 5K Programmes, Inclusion Programmes, and Sports Clubs.
- More than 2,680 participants engaged in the suite of Physical activity programmes and educational initiatives held during March. This included schools, community, and sports Hubs activities.

Council Sporting Facilities

The Limerick Regional Athletics Hub facilitated primary and secondary schools from throughout the region to deliver elements of their physical education curriculum, in an outdoor setting. In addition to the schools within the catchment area, local clubs have utilised the resource to ensure the continued delivery of their fitness and skills training sessions. The quality of the surface and the lighting enabled sports organisations including the GAA, Rugby, Ladies Gaelic and Camogie, to book additional sessions, as the weather in March resulted in their own facilities being unavailable for training to be undertaken. Athletics clubs from Limerick and North Cork also travelled to Newcastle West to train within the facility and utilise the athletics equipment that is available on site.



Customer Services

The Customer Services Team continued to support customers and Public Representatives at first point of contact by answering queries via telephone, email, MyLimerick and social media. Case creation, payments processing and generally facilitating applications for all Council services also continued throughout the month.

The following figures highlight the activity within the Contact Centre throughout the month of March:

- Customer Services Call Centre answered 10,044 calls. This represents an average of 528 per day, with the number of calls reaching as high as 652. 72% of calls were handled at first point of contact.
- A total of 3,852 emails were processed through the Customer Services email platform.
- 3,096 cases were created, with 869 of these logged on behalf of Public Representatives. 3,576 cases were closed, with 862 of these being cases logged by Public Representatives.

- Of these 3,096 cases, Customer Services staff logged 68% of same.
- The logging of cases through the MyLimerick portal continued, with a total of 267 cases being logged. Of these, 235 were submitted by Public Representatives.
- Customer Services continued to support the Housing Maintenance Department in creating service requests and, throughout March, 95% of housing maintenance cases for the Limerick Metropolitan District were logged by Customer Services staff in the Dooradoyle and Merchant's Quay Offices.
- A total of 88 out-of-hours cases were created.
- Customer Services continued to provide other frontline services to the general public, such as processing applications for Residential Parking Permits, of which 89 were applied for and 74 issued.
- Customer Services staff welcomed a total of 2,228 customers at both the Merchant's Quay and Dooradoyle Offices.
