## 1.0 Foreword

Under the 1993 Roads Act, a Road Authority may, by order, declare any road over which a public right of way exists to be a public road. In accordance with the Act where a road authority proposes to declare a road to be a public road it shall:

- Satisfy itself that the road is of general public utility,
- Consider the financial implications for the authority of the proposed declaration,
- Advertise in accordance with regulations that it is proposed to declare the road to be a public road and consider any objections or representations made to it. The consideration of objections or representations and the making of an order are reserved functions.

A report detailing the financial implications of this process is included at Appendix. 1 of this document.

## 2.0 Details of advertisement.

**The intention to declare this roadway as a public road was advertised from Friday from Friday 8th March to Friday 5th April 2024. Submissions and objections had to be submitted by the 19th April 2024.**

## 4.0 Conclusion

Following the recent declaration by Limerick City and County Council (LCCC) to take the Cloisters estate into charge on February 2024, it was observed that the access road to the Cloisters estate off Revington Circle was not included as part of this process as it was outside the redline boundary of the original planning for this estate. In order for LCCC Road operations to maintain and access this estate, taking in charge of this roadway would also be required.

This public consultation process to take this road into charge provided zero submissions.

The Appendix A to this report sets out the defects in this roadway and the costs of rectifying same. The estimated costs of these rectification measures is €33,823.00. These works will be scheduled when funding can be secured for same.

It is recommended to the Members of Limerick Metropolitan District that the roadway accessing the Cloisters, North Circular Rd, Kilrush, Limerick is declared a Public Road.
