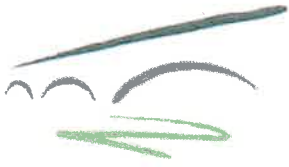
I will move at the next Meeting that a speed meter be installed at the Railway Road, Abbeyfeale at the town side of Buckley's Cross.

### Reply

Commercial rates are legally payable on all commercial properties. A Vacant Property Allowance Scheme has been adopted by the Council and all other businesses are liable to pay rates. This policy is consistent in all areas of the city and county. The roadworks/improvement works are managed to ensure minimum disruption to the business community.

The Rates Section offers an annual Small & Medium Business Enterprise Scheme, whereby the rate-payer may be entitled to 13.5% rebate of their annual rates, up to a maximum grant of €1,500.

Also the Increased Cost of Business Grant, funded by the Department of Enterprise, Trade & Employment is currently available to rate-payers and applications for same are open until 1<sup>st</sup> May 2024
