Economic Development, Enterprise and Tourism Directorate

1. Trade and Investment

Limerick-based AI (Artificial Intelligence) start-up, Mavarick, raised €1.3 million in funding to help support its plans for international expansion. Based at the ENGINE Building, Cecil Street, Limerick, the software company helps manufacturers become more sustainable and efficient by tracking sustainability through their operations, predominantly focusing on carbon and energy.

Supported by Limerick City and County Council, the European Young Engineers (EYE) annual conference was held in Limerick in May. The event in Limerick coincided with the 30th anniversary of EYE, which is an international not-for-profit group representing around half a million young engineers from 20 European nations.

“Q-PARK has announced the opening of its newly revamped Cornmarket Square Car Park in Limerick City Centre, marking the third addition to its Limerick portfolio. The Cornmarket Square Car Park was acquired by Q-Park in 2023 after 18 months of closure and underwent extensive refurbishment. The parking facility caters for seven electric vehicle charging points.

Recent City Centre Retail Openings

- SOS Cookies opened a new store in the Limerick Milk Market.
- The Trading Post, a gaming and hobby shop, opened a new store at 103, High Street, Limerick.

Night Time Economy

- Following a call out for applications, a Culture Night Late proposal has been developed for the Department of Tourism, Culture, Arts, Gaeltacht, Sport and Media to seek funding of €15,000 for three separate late night events. This funding is available for Night Time Economy (NTE) pilot location (in addition to general funding to the Arts Office).

- The Family Sunset Cycle took place on 17 May, which was an initial NTE-supported event in collaboration with Active Travel, Limerick Sports Partnership (Active Cities) and An Garda Síochána. Participation numbers exceeded expectations and the event was successful in realising that community members will participate in evening activities which are not alcohol related.
- Karen Thompson Consulting Ltd. has been appointed to support Limerick City and County Council for the production of a Night Time Economy Action Plan.

2. Digital Services

The National Disability Authority (NDA) completed Ireland's first monitoring report under the EU Web Accessibility Directive for the monitoring period 2018-2021. Digital Services Department has been working to ensure Limerick.ie and mobile apps comply with AA WCAG (Web Content Accessibility Guidelines) 2.1 (equivalent to EN 301 549).

We have now reached a 93.66% compliance level (which is broadly equivalent to Web Content Accessibility Guidelines 2.1 AA standard) from a low compliance score of 21% last year. We are committed to continually improving the user experience for everyone and adhering to the required accessibility standards.

EU Programmes

LIVING-IN-EU EU PROJECT

Limerick City and County Council was recently successful in securing EU funding for consultancy services to develop a 'Digital Roadmap' for Limerick City and County. This EU funding stream is being administered through LIVING-IN-EU. The project is currently at its infancy stage of consultancy engagement in regard to developing this 'Digital Roadmap.' Through the Digital Europe Programme, the European Commission has launched a collaborative

effort to accelerate digital maturity, with a particular focus on cities and communities that are less digitally ready for digital transformation. These services aim to foster the adoption of local digital twins and other digital solutions across rural and urban areas, ensuring that technology is accessible to all.

SmARTivism EU Project

Limerick City and County Council is partnering with the University of Limerick (UL). This EU Project is about research to better understand how to create public spaces that are positive for civic, cultural and artistic engagement. Research has shown globally that citizens who engage in cultural and artistic activities are typically more engaged in civic and political activities and more generally engaged in democratic life.

SmARTivism is about assessing how to create socially positive, culturally rich and inclusive spaces. EU and global research confirms that education is key to civic engagement generally but marginalised groups may require more context-specific forms of culture and art to develop the same sense of civic and cultural engagement and ownership. Working directly with Limerick City and County Council, UL can strategically assess where they could create new spaces by working with communities to create visions of possible future spaces through art and working with artists.

UL has allocated €66,000 to Limerick City and County Council to work with SmARTivism over the three years of the project with the most engagement in Years 2 and 3 collaborating with focus groups, communities and art workshops and facilitating spaces where the participants can share their art works.

EMERGE EU PROJECT

Limerick City and County Council is also a participant in an Erasmus + EU Project in collaboration with UL. The project entitled EMERGE is a European/University Alliance initiative. UL is hoping to be the Lead Partner with eight other Universities from around Europe. The initiative is being supported by the Irish Government and EU Commission. Seed funding of €20 million is being made

available. UL, if successful in the application process, will receive more funding than the other universities as it would be the Lead Partner.

One of the main aims of the programme is around the themes of social challenges/migration/empowering people and tapping into intercultural skills, leading to pathways to university both for historical and recently marginalised communities. UL is now embarking on Mission 3 which is around the theme of Community Service, where it strives to become a university which is community embedded, giving an educational pathway and access to all communities. To achieve this, the University needs to engage with all our communities, particularly our marginalised society, to provide the opportunities for lifelong learning for all.

THRIVE - Town Centre First Heritage Revival Scheme - ERDF

Limerick City and County Council was recently successful in securing nearly €400,000 funding under the New THRIVE scheme, co-funded by the European Union and Government of Ireland.

This funding was awarded under Ireland's two European Regional Development Fund (ERDF) Regional Programmes. THRIVE was developed by the Southern Regional Assembly and the Northern and Western Regional Assembly, working in close partnership with the Department of Housing, Local Government and Heritage. It aims to allow Local Authorities and citizens to reimagine and revitalise town centres through the renovation and reuse of publicly owned vacant or derelict heritage buildings. Funding has been provided for two projects in Newcastle West and King's Island.

The EU Programmes Department continues to support our Departments interested in participating in EU-funded projects across the entire Local Authority, whilst also collaborating with various stakeholders locally and internationally to pursue opportunities to support the Local Authority in achieving its objectives. We are currently looking at other exciting opportunities for other EU-funded projects under Horizon Europe/InterReg/ESPON and URBACT EU Programmes for 2024/2025.

3. Local Enterprise Office (LEO) Limerick

On 08 May, the Student Enterprise Programme, National Awards, took place in the Mullingar Park Hotel, Mullingar, Co. Westmeath, which was the first time the national final had taken place outside of Dublin in a number of years. Limerick was proudly represented by the students of Desmond College, Newcastle West (Senior category), Coláiste Chiaráin, Croom (Intermediate category) and Gaelcoláiste Uí Chonbá, Newcastle West (Junior category).

The National Enterprise Awards, National Final returned to the Round Room of Dublin's Mansion House on 23 May, with teams competing from each of the 31 Local Enterprise Offices around the country. Limerick was proudly represented by Monarú, high spec, bespoke furniture designer and manufacturer located at Watch House Cross.

The Management Development programme, one of LEO Limerick's premier programmes for business owners and managers, concluded its 15-week intensive programme on 08 May. Businesses from all across Limerick City and County participated in this programme which provides meaningful and practical guidance on how to further develop and enhance an existing enterprise.

On 15 May, the Government announced a further suite of supports for small and medium sized enterprise. Some of the supports announced by the Government being rolled out to SMEs in Limerick, directly by LEO Limerick, include:

- Increasing the maximum amount available under the Energy Efficiency Grant Scheme from €5,000 to €10,000 and reducing the business contribution rate from 50% to 25%.
- Widening the eligibility for the Trading Online Voucher, extending it to all sectors up to 50 employees (currently up to 10), modernise eligible expenditure and doubling the grant to €5,000.
- Increasing the lending limit for Microfinance Ireland loans to €50,000 from €25,000.

- Widening the eligibility for the Digital for Business Consultancy Scheme and extending it to all sectors with up to 50 employees – currently only open to enterprises engaged in manufacturing or internationally traded services.
- Launching a new 'Ireland's Best Entrepreneur Programme' to encourage entrepreneurship and start-ups in under-represented groups.

FESTIVAL AND EVENTS

Riverfest

The 20th Riverfest took place over 03 - 06 May and kicked off with the Pegasus Parade, a Giant Silver-winged Horse standing eight metres high, accompanied by acrobats and street performers. It took to the Limerick streets on the Friday night with its unique performance. Riverfest saw over 133,000 people attending numerous events within Limerick City. Centre of Riverfest was the Riverfestival Village, located next to the River Shannon, which had Live Music, Artisan Food, Fabulous Crafts and Street Performers.

For the thrill seekers, a Zip Line over the River Shannon was an exhilarating experience.

There was a wide variety of other events for people such as Fashionfest, which showcased Limerick's talented designers; The National All Ireland BBQ Competition; and The Riverfest Street Party which took place in partnership with Red Bull on Howley's Quay creating a party atmosphere on the streets of Limerick, as well as many more events.

The Riverfest Spectacular Fireworks Display took place on the Sunday night bringing the festival to a close.

Great Limerick Run

The Great Limerick run took place on 05 May, during the Riverfest weekend. Over 17,000 runners and walkers took to the streets of Limerick and ran the Marathon, half-Marathon or 10km, adding a vibrant atmosphere to the City from Sunday morning.

Red Bull Drift Pursuit

In a first for Limerick and Ireland, Red Bull brought a new hybrid designed drift course to Limerick City. The hybrid course was specifically designed and trialed in Limerick and proved an outstanding success. This event received significant support from Limerick City and County Council Festivals and Events. The Red Bull Drift Pursuit took place on 18 and 19 May. The motorsport event saw some of the best drifters in Europe challenge their skills of speed, accuracy and control in a compact course at Limerick's Greyhound Track. 7,000 people enjoyed the two sold-out shows. Reigning Drift Masters European Championship winner, Conor Shanahan, demonstrated why he is one of the best drivers in the world. The Inaugural Title was won by Cork man, Alan Hayes.

The Limerick Opera Festival

The annual event took place from 04 to 25 May. There were numerous events throughout the month. The On-Street Arias took place on the Saturday of Riverfest at Colbert Station; International Rugby Experience; Arthur's Quay Shopping Centre; and Lower Thomas Street. A lecture took place on 16 May on the life of Catherine Hayes, world famous Irish Soprano, at Laurel Hill School. The final Event was on 25 May at St. Mary's Cathedral, a Catherine Hayes tribute Concert, with Soprano, Amy Hewitt, and pianist, Irina Dernova. Earlier that day, local Historian, Sharon Slater, did an informative historical walk on the history of opera in Limerick.

Fleadh By the Feale 2024

The Annual Traditional Music Festival, celebrating its 30th anniversary, took place over the May Bank Holiday weekend from 03 - 06 May in the historic Market Town of Abbeyfeale. Various local venues held music sessions throughout the weekend with musicians coming from near and far. Friday saw the beginning of the festival with Tour na Fola and Athea Wren Groups performing in the town centre, followed by a Céilí at Fr. Casey's GAA Club. Saturday saw numerous workshops take place, a family fun day and Traditional music session in the town square and Celtic Steps, a spectacular Irish Music, Song and Dance Show performed at Coláiste Ide agus Iosef to a sold-out crowd. Sunday saw the All-Ireland Bones Competition take place and numerous music sessions spread across the town showcasing Traditional Irish Music talent from Limerick and across Ireland.

Festivals and Events Grants Scheme 2024/2025

The recommendations for Festivals and Events funding for the Limerick City and County Council Festivals and Events Grant Scheme 2024/2025 went before the Full Council at the May Meeting. The following recommendations from the Assessment Panel were approved:

Recommendations: Strand 1: Funds Available €33,000

- 27 applications were considered under this strand with a total ask of €170,050.
- The assessment panel recommended the allocation of funding to 12 successful applicants totalling €33,000.

Recommendations: Strand 2: Fund available €170,500

- 18 applications were considered under this strand with a total ask of €367,209.97.
- The assessment panel recommended the allocation of funding to 15 successful applicants totalling €170,500.

Recommendations: Strand 3: Fund Available €4,500

This award is intended to support a step change in the festival's ambition and delivery.

- 15 applications were received with a total ask of €62,950.
- The assessment panel recommended the allocation of funding to two successful applicants totalling €4,500.

5. Innovate Limerick DAC

02 May: Head of Innovate represented Innovate Limerick at the HealthTech Ireland Symposium in Dublin.

14 May: The Rinnovalleys EU project delegation, coordinated by the Community Enterprise Association Ireland, was hosted at the ENGINE for Day 1 of their visit, with welcome speech and presentations provided by the Innovate Limerick team.

24 May: Head of Innovate represented Innovate Limerick at the .ie Digital Town Awards in Athlone, Co. Westmeath, where Innovate Limerick won the runner-up prize in the Digital Business Category.

Film in Limerick

Limerick Film Groups in the Frame at Cannes Film Festival

Two Limerick film projects were recognised for their work developing the film sector in the region, with nominations at the prestigious Global Production Awards that took place at the Cannes Film Festival in May.

The awards celebrate outstanding and sustainable work in the world of film and TV production, locations and studios. Film in Limerick was nominated in the City of Film Category and fellow Limerick film group, Fresh Film Festival, was nominated and won the award in the Community Impact category for outstanding work in developing next generation film talent, both locally and nationally.

Film in Limerick at Marché du Film

Film in Limerick also attended the Marché du Film (film market) at the Festival de Cannes. Putting the spotlight on the Mid-West of Ireland as a Film/TV Location, the regional film manager promoted the region, with a packed schedule of meetings, panels, presentations, talks and receptions.

Local Films and Filmmakers celebrated in Berlin

A partnership between Film in Limerick and Irish Film Berlin Festival saw a focus on films made in the region at the festival in Berlin in May. Irish Film Berlin screened a programme of local shorts that were commissioned by Film in Limerick through their Engine Shorts initiative and invited filmmakers to Berlin to present their films. Nine local filmmakers travelled to Berlin, supported by the festival, to network with other film industry representatives in the city.

Film Work Placements

Film in Limerick and the National Talent Academies arranged three on-set placements on feature film 'Whitetail' in May. The placements were in the production office, art department and assistant director roles and the placements ran for three weeks. Two further work placements were also arranged on the film set of 'Mayfair Witches,' in the video assist department and props department, and these placements also ran for three weeks. Participants were required to set goals, learn new skills and keep a journal during the placement. Participants received a level 6 QQI 10 credit certificate on completion.

Film/TV Job Share Workshop

Film in Limerick and the National Talent Academies, in partnership with Screen Producers Ireland, Screen Guilds Ireland, and Reeltime Media, ran a Film and TV Job Share Workshop in May. A series of panels, workshops and

pairing interviews were delivered to discuss opportunities for the film industry to review roles where job share may be suitable. The workshop was online and in-person, with producers from major companies attending.

Production Support

Production support and locations services were arranged for five companies in May, scouting for future feature production and TV series, and further support was offered for several television programme features.

Events

A networking reception was held in King John's Castle on the evening of 15 May.

Concerts

Two sold-out concerts took place in King John's Castle during the Riverfest weekend with artists, Qween and Moncrieff, both receiving positive feedback online via our social media channels. These concerts act as a vehicle for opening up the castle to a wider target audience that might not necessarily visit the castle. They generate increased exposure for the castle and enable us to expand our customer reach, hence they are an important element of the castle's Summer programme of events.

Lough Gur held a Bealtaine Festival over the May Bank Holiday, with events such as yoga, healing workshops and a scavenger hunt for children. There was something to appeal to all ages.

Transportation and Mobility Directorate

1. Travel and Transport Strategy

Compulsory Purchase Order 2021 for Dock Road Improvement Scheme

- Upgrade of Atlas Avenue and Courtback Avenue Junction - An order was made by An Bord Pleanála determining the Compulsory Purchase Order.

National Bike Week - 11 to 19 May

- A family bike ride was held along the UL to City Centre riverbank on 12 May. Families started their cycle from the UL Boathouse and enjoyed an ice-cream in O'Brien Park before returning.
- Over 100 cyclists participated in a Sunset City Cycle on 17 May. The event was organised by Limerick City and County Council in collaboration with Limerick Sports Partnership and Limerick Cycling Campaign. The cycle started at King John's Castle and followed the iconic Three Bridges route. Free bikes were provided for adults and children. Following the cycle, everyone returned to Nicholas Street and enjoyed an ice-cream.
- On 18 May, a bike maintenance workshop was held on the Limerick Greenway at Barnagh Hub where people of all ages learned about how to keep their bikes in top condition. On 19 May, a bike maintenance workshop was held on the Castletroy Urban Greenway.
- A family bike ride and fun day was held in Limerick City on 19 May to mark the end of National Bike Week. A parade of almost one hundred cyclists took to the streets of Limerick. Cyclists left Arthur's Quay Park for a 4km Three Bridges loop route that took in King John's Castle, Thomond Bridge, Clancy Strand, O'Callaghan Strand and Shannon Bridge. Along with the bike parade, the crowds also enjoyed an afternoon of entertainment in the park with music and face painters. Gardai from Henry Street Garda Station were on hand on the day to provide information on safe cycling. A

bike mechanic was also on hand to provide free bike checks and minor repairs before and after the bike ride.

- Schools around Limerick had the opportunity to apply for funding support to run bicycle-related events throughout the city and county. A variety of events and promotions with staff and students were held, including cycle to school days, bike parades, cycle skills sessions, bling your bike competitions.
- A number of workplaces in Limerick got involved in Bike Week by holding cycling promotions.
- A number of inclusive cycle events were also held throughout the week with various groups from around Limerick.

Adare Transport Plan

Limerick City and County Council has commenced the preparation of a Transport Plan for Adare. The strategic aim of the Transport Plan is to provide for the planning and delivery of transport infrastructure and place making in the village. Limerick City and County Council has published an online survey for local residents and business owners to share their views. The findings from this survey will help inform the development of the transport plan.

Projects on Site

Rural, Community and Culture Development Directorate

1. Community Development

- Funding secured under the THRIVE funding scheme to develop an Integrated Urban Strategy for Newcastle West. The scheme has been co-designed by the Regional Assemblies and the Department of Housing, Local Government and Heritage. THRIVE is co-funded by the Government of Ireland and the European Union. The scheme promotes a citizen-centred community-led approach to planning, design and project selection under the Town Centre First framework. Funding of €199,115 has been secured to deliver an Integrated Urban Strategy.
- Funding secured from the Department of Rural and Community Development to support the development of Town Teams in Newcastle West, Kilmallock and Askeaton, under the Town Centre Suite of Supports 2024.
- Funding secured to deliver a County Outdoor Recreation Strategy for Limerick from the Department of Rural and Community Development in conjunction with all relevant stakeholders.

Local Community Development Committee

- A meeting of the Local Community Development Committee (LCDC) was held on 07 May.
- Presentations were given on the SICAP 2024 where Annual Plans were approved, the Children and Young People's Service Committee/LCDC Local Area Child Poverty Action Plan Pilot Scheme Funding Application process, the Local Economic and Community Plan and the Community Recognition Fund 2024.

SICAP (Social Inclusion and Community Activation Programme)

- The new SICAP Programme, funded by the Department of Rural and Community Development and the European Union, was updated in May with Limerick receiving €2,979,113 for 2024.
- The SICAP Sub-Committee, in conjunction with the Local Development Companies, agreed the Local Priority Target Group (LPTG) targets and percentages for the three Limerick LOTS at the May LCDC meeting, along with the Local Priority Target Group Templates for Limerick.

Public Participation Network (PPN)

- Membership of PPN Limerick continued to grow and stands at 219 as at end of May 2024. The membership registration form is on the Limerick PPN [website](#) and eligible groups in Limerick can register at any time. The Secretariat continued to fulfil its function with a meeting held in May.
- The PPN, in partnership with the University of Limerick, Cormhairle na nÓg and Limerick Community Education Network, hosted a Citizens' Assembly on 02 May. The attendees at this Assembly voted for three of nine projects developed and presented by UL academics to receive funding. All the projects were required to address a Sustainable Development Goal and have a community engagement component of project delivery.

Integration Supports

- A Migrant Election Information Event was held on 15 May in collaboration with Limerick Migrant Integration Forum. Eligibility, Registration and Proportional Representation were explained to all present.

- LCGA, in collaboration with Limerick and Clare Education and Training Board, hosted an exhibition by Brandon Hanley, which was part of the LCETB Arts Festival Week 2024.

Limerick Museum

- On 16 May, Councillor Joe Pond, on behalf of the Mayor of the City and County of Limerick, Councillor Gerald Mitchell, performed the official opening of Pond - A New Photographic Exhibition by Paul Sweeney in Limerick Museum. Paul is a member of Limerick's ForeFront Poets, along with Ciaran O'Driscoll, Jo Slade, and the recently deceased Mark Whelan. He has been a co-founder and organiser of the Cuisle Poetry Festival and was the curator of the 20th Anniversary of the Festival, which involved the transformation of Patrick Street into a gallery space. For the Pond Exhibition in Limerick Museum, Paul traced the changing seasons over the course of a year at the Baths in Corbally in a series of photographs. A respected and distinguished Limerick born poet, he displayed his versatility in this exhibition by expressing himself in the very different medium of photography.
- Limerick Museum collaborated with Limerick Civic Trust to bring a new history festival to Limerick. The Shannonside History Festival commenced on 31 May

with two free events in Limerick Museum. The first was a workshop and handling session on Limerick Silver by the Assistant Curator, who is an authority on the precious metals trade in Georgian Ireland, and Jim Noonan, a renowned Limerick Silver expert. They were assisted by silver experts, Sarah Gough, John Breen and Michael Lynch. Limerick Arts Office

Strategic Fund for Culture and Arts Scheme 2024

Limerick Arts Office manages the 2024 Strategic Fund for Culture and Arts Scheme. The purpose of the Scheme is to support the maximising of the leveraging of funding into Limerick from national and international sources and to support a vibrant creative culture. Two Strategic Fund grants were approved at the May Council Meeting awarding a total of €8,089, and a further four letters of support were issued.

Creative Ireland Limerick, in collaboration with Healthy Limerick, Clare County Council and Tipperary County Council, secured funding from the Creative Health and Wellbeing in the Community Scheme. "Creativity Changing Young Lives in the Mid-West" will be delivered in partnership with Helium Arts. Economic Regeneration

Outreach to Employment Programme

The Outreach to Employment Programme has funded two new posts for community mentors who are working with people who are long term unemployed. The programme is bespoke to the individual's needs.

The Programme is led by Limerick City and County Council, in partnership with Limerick and Clare Education and Training Board and Limerick Enterprise Development Partnership, PAUL Partnership, Department of Social Welfare and Community and Industry Leaders, all forming part of a multi-stakeholder project team who meet regularly to network and support the programme.

The mentors strive to ensure the delivery of appropriate and innovative employment supports to individuals that will increase their readiness for progression towards employment/training into the future.

Community Mentor Network

Limerick and Clare Education and Training Board hosted a site visit for the Community Mentor Network on 30 May to its NZEB (Nearly Zero Energy Building) and Retrofitting Centre of Excellence in Roxboro. This is a newly-established training campus aimed at upskilling individuals to work on retrofitting older buildings to improve their energy performance. Training will consist of NZEB Electrical, Plastering, Plumbing, Bricklaying, and Carpentry, complemented by training in NZEB fundamentals, Air Tightness, Ventilation and Insulation.

Social Regeneration

Limerick Island Community Partners officially launched the Irish Black Bee Museum on World Bee Day, 20 May, in the presence of the Mayor of the City and County of Limerick, Councillor Gerald Mitchell, and His Excellency, Ambassador Mr. Stanislav Vidovic, from the Embassy of the Republic of Slovenia.

The official launch of the fundraising campaign for The Irish Black Bee Museum took place on the day. The Irish Black Bees produce King's Island honey which can be purchased at the Alms Houses off Nicholas Street.

The Department of Applied Social Studies at Technological University of the Shannon held a "soft launch" of the Centre for Community Research and Innovation. This took place on 27 May. The Centre aims to build bridges between the local community and the University, to address issues related to disadvantage and disparity. Regeneration staff were in attendance.

Economic and Social Intervention Fund (ESIF) Update

- The Health, Wellbeing and Ageing Well Funding Call was launched on MyPoint on 31 May.
- The Families and Youth at Risk Call closed for applications on 15 May. A total of 34 applications were received.
- The Employability and Work Call closed for applications on 17 May. 28 applications were received for review.

King's Island

- A Gardening Workshop took place in conjunction with Limerick Island Community Partners on 01 May.

Moyross

The project promotes the values and working principles of the New European Bauhaus – an initiative of the European Union – in their strategies and projects to ensure their projects are sustainable, aesthetically pleasing, inclusive and accessible.

Archaeology

- The Hidden Heritages project started in Kilmallock on 20 May. Entitled: *Kilmallock – Derry – Bradford: Twinning North-South Irish Walled Towns and UK Cities of Culture*. This project is funded by the UK's Arts & Humanities Research Council with and supported by a wide range of partners from Ireland and the UK, including Limerick City and County Council represented by the Archaeology Section. A team from Bradford University's Department of Archaeology & Forensic Science, the lead institution, used cutting-edge equipment to survey the walled town of Kilmallock. While at the other end of the scale, Dr. Caroline Wilhelmsson, an historical researcher based in University College Cork, started to collate all of the available historical information on the houses of Kilmallock.
- As part of the URBACT GreenPlace Project's family fun day in Grattan Court on 25 May, the works to the City Wall were opened up to the public with

tours and explanations of the works and the history and significance of this section of City defences on demand.



Customer Services

The Customer Services Team continued to support customers and Public Representatives at first point of contact by answering queries via telephone, email, MyLimerick and social media. Case creation, payments processing and generally facilitating applications for all Council services also continued throughout the month.

The following figures highlight the activity within the Contact Centre throughout the month of May:

- Customer Services Call Centre answered 11,699 calls. This represents an average of 531 per day, with the number of calls reaching as high as 614. 72% of calls were handled at first point of contact.
- A total of 4,434 emails were processed through the Customer Services email platform.
- 3,469 cases were created, with 1,114 of these logged on behalf of Public Representatives. 3,112 cases were closed, with 1,015 of these being cases logged by Public Representatives.

- Of these 3,469 cases, Customer Services staff logged 75% of same.
- The logging of cases through the MyLimerick portal continued, with a total of 360 cases being logged. Of these, 316 were submitted by Public Representatives.
- Customer Services continued to support the Housing Maintenance Department in creating service requests and, throughout May, 97% of housing maintenance cases for the Limerick Metropolitan District were logged by Customer Services staff in the Dooradoyle and Merchant's Quay offices.
- A total of 94 out-of-hours cases were created.
- Customer Services continued to provide other frontline services to the general public, such as processing applications for Residential Parking Permits, of which 82 were applied for and 71 issued.
- Customer Services staff welcomed a total of 2,631 customers at both the Merchant's Quay and Dooradoyle offices.
