Proposed Disposal of 0.3645 acres (0.1475 hectares) Land surrounding St. Nesson's Church, Mungret, Co.Limerick.



1. Introduction

It is intended that the following proposed disposal of 0.3645 acres (0.1475 hectares) of land surrounding St. Nessen's Church, Mungret, Co. Limerick (maps and photo attached in this report) will be included on the Agenda for the September Full Council Meeting:

Disposal of 0.365 acres (0.1475 hectares) Land surrounding St. Nessen's Church, Mungret, Co. Limerick (See Map AG 5094 – B attached) for a nominal fee of €1.00.

2. Description and Location of the Property

The subject land for disposal comprises 0.3645 acres (0.1475 Hectares) surrounding St. Nessen's Church, Mungret, Co. Limerick

3. History of Property

St. Nessen's Church, Mungret, Limerick (RMP LI013-009001) is part of a group of 3 structures, within the early monastery in Mungret vested in state ownership since 1881. The standing remains of this monastic site consist of 3 churches, St. Nessen's at the side of the regional road (R-859-1), an unnamed church with a small graveyard on the left hand side of the local road (L51001-65) and the Abbey Church and Graveyard on the right-hand side of the local road (L-51001-65). All of these buildings are maintained on the Minister's behalf by the Office of Public Works, National Monuments Section.

A large area of land was zoned as Special Development Control in the Local Area Plan. This land was transferred to Limerick City and County Council by Homeland MLS Limited who had planning permission to build a new housing estate on the lands adjacent. As Homeland MLS Limited would never be allowed to develop them, not even open space or amenity, they decided early on in the process to hand the land bank over to the Local Authority.

Sarah McCutcheon, Executive Archaeologist for Limerick City and County Council met with the Department of Housing, Local Government and Heritage, National Monuments Service, and agreed an appropriate area of ground surrounding the church at St. Nessans, that should be transferred over to the department.

The land which is to be disposed of to the Minister of Housing, Local Government and Heritage surrounds St. Nessen's Church at the regional road, which is an important 12th Century Church.

4. Key Elements of Proposal

Limerick City and County Council are transferring the land surrounding St Nessen's Church and this will enable the Office of Public Works to demolish one of the farm buildings which currently abuts the church and covers the east window, to carry out improvement works on

the boundary and upgrade and landscape to provide a proper setting for the 12th Century Church.

5. Executive Recommendation to Council.

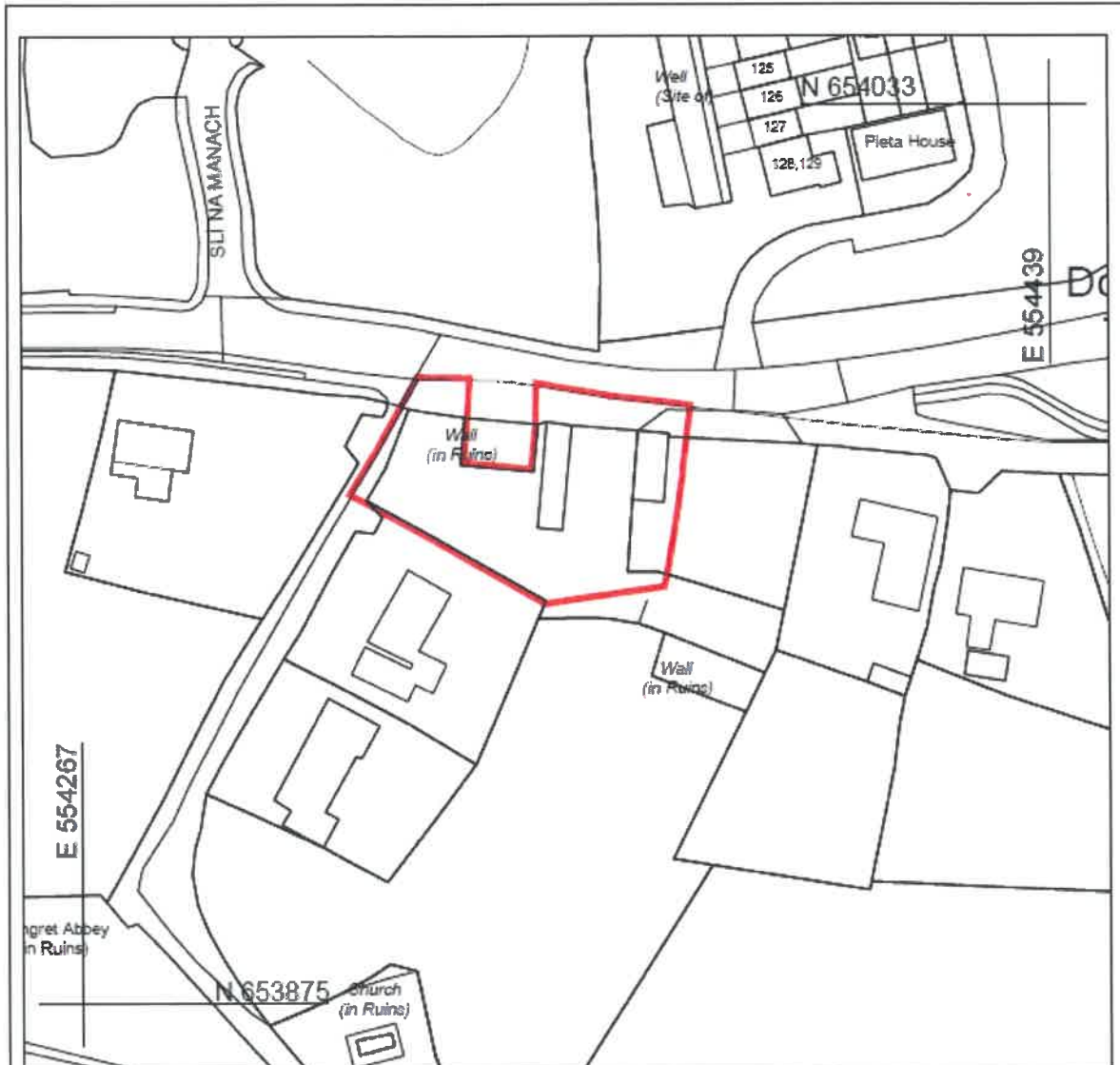
