Thank you for your recent correspondence in relation to funding for the Bedford Row Project.

The funding for this project is not within this Department's remit, it is funded by the Department of Housing, Local Government and Heritage (DHLGH). I have been informed that DHLGH has allocated €4 million in 2024 to facilitate the Council in transitioning previously funded groups to other sources.

This Department however, is responsible for the Social Inclusion and Community Activation Programme (SICAP), our country's primary social inclusion intervention. This is a national programme that is delivered in both rural and urban areas by Local Development Companies (LDCs) to help those in the greatest need.

It targets and supports those who are disadvantaged in Irish society and less likely to use mainstream services. SICAP workers have extensive local connections and in-depth knowledge of available resources and supports in their area and work to ensure the emerging needs of their locality are responded to. I would recommend that you make contact with the SICAP Programme Implementer, Paul Partnership Limerick who can advise you of any supports that are available.

The Department of Social Protection administers the Community Employment Scheme which has provisions for those who have been in prison. Further information regarding this can be found on the Departments website: <https://www.gov.ie/en/organisation/departments-of-social-protection/>

I would also recommend for you to contact the Department of Justice to assess if they have any future or existing funding streams that may be of benefit to this project.
