I will move at the next Meeting of the Metropolitan District of Limerick that Limerick City and County Council increase enforcement of the regulations regarding restricted dog breeds.

Response:

Limerick City and County Council employs two dog wardens, a kennel assistant and administrative support in operating the LCCC Dog Shelter and in enforcing the Control of Dogs Act, including regulations regarding restricted dog breeds. The team responds to all complaints regarding stray dogs, restricted breeds, dog licences, issues fines, and seizes dogs where it is safe and appropriate to do so. LCCC Dog Wardens work in close collaboration with Gardaí in relation to enforcement of restricted breeds regulations and regularly assist in Garda operations where restricted breeds are present.

In May, LCCC in collaboration with local Gardaí launched an awareness campaign that highlighted the responsibilities of owning a restricted breed and asked the public to seriously consider before taking one of these dogs into their homes.

Minster for Rural and Community Development Heather Humphries has recently set up a cross Governmental stakeholder group, to the examine issues related to dangerous dogs and restricted breeds. The Group is made up of representatives from key government departments and interest groups and will make recommendations on strengthening the policy and increasing regulations around dog control. Further powers on restricted breeds may be available to Council staff on foot of these recommendations.

I will move at the next Meeting of the Metropolitan District of Limerick that TII, the Mid West Road Design Office and Limerick City and County Council engage with the owners of the Crescent Shopping Centre to explore the possibility of an extra entrance / exit from the Crescent Shopping Centre in Dooradoyle, parallel to the railway line and then connected to the N18 Motorway Section, so as to alleviate congestion on the Dooradoyle Road.

Reply:

The provision of an additional junction at the location suggested, would be a matter for the crescent shopping centre to propose as it would be a dedicated access to a private development. Any such junction would need to be cognisant of the spatial planning and national roads, relevant local and national policies and not impact on the capacity and safety of the existing national road infrastructure. It is noted that this section of the national road network also forms part of the Limerick Tunnel PPP concession contract.
