I will ask at the next Meeting of the Metropolitan District of Limerick what criteria is used to monitor the city roundabouts that are sponsored by corporate organisations as there is quite a difference in the quality and appearance of these roundabouts.

Response:

The Council has entered into Service Level Agreements with Corporate bodies who sponsor the various roundabouts around the city. The Service Level Agreement is for a period of three years with the option of extending for another three years subject to agreement between both parties. The design for the individual roundabouts vary and require different levels of maintenance and have different challenges. All designs must be pollinator friendly and comply with the All Ireland Pollinator Plan. The sponsorships include a specific maintenance schedule in the Service Level Agreement and this is monitored by the Council throughout the year. The Council are reviewing all sponsorships to ensure that all roundabouts are up to the required standard.

I will ask the next Meeting of the Metropolitan District of Limerick what progress has been made on the installation of eircodes on playgrounds and public parks under Council control after a commitment was given in the last term of this Council.

Response:

The Council has reviewed the matter of eircodes for amenities, including playgrounds and public parks for emergency contact purposes. From consultation with the National Ambulance Service, the preferred method of contact and that being used by the National Ambulance Service is where a member of the public contacts the emergency services, the Ambulance Service responds by texting back the caller, allowing the location of the caller to be made known to the Ambulance Service. This is considered to be satisfactory by the Ambulance Service, there are concerns that an incorrect digit may be stated by the caller which would hamper an emergency response. It is considered that the current system is satisfactory and therefore there is no requirement for eircodes.



I will ask at the next Meeting of the Metropolitan District of Limerick can the Council advise when a property is in the Council ownership after the Tenant in Situ Scheme how long is it taking for the Council to go in and refurbish/repair the property and is there funding specifically available for these properties.

REPLY:

The Department of Housing, Local Government and Heritage funds both the acquisition and the refurbishment of properties under the Tenant in Situ scheme.

Specifically, refurbishment works include essential repairs and safety works to bring a property up to rental standards as set out in Housing (Standards for Rented Houses) Regulations 2019.

The Department of Housing, Local Government and Heritage expect recoupment claims for refurbishment works after works have been carried out to be submitted to them within 6 months of the acquisition closing its sale.

It is currently taking Limerick City and County Council an average of 160 days (approximately 5 months) from close of sale to completion of the refurbishment works.




I will ask at the next Meeting of the Metropolitan District of Limerick for an update on progress for the delivery of the much-needed proposed Library for the greater Castletroy Area.

The need for a library in Castletroy has been identified in the current City and County Council's 5 year Library Development Plan.

Following the launch of the current plan, two potential sites in Council ownership were identified directly behind the Castletroy Shopping Centre and adjacent to both primary and secondary schools.

A facility of this size and range requires significant planning and resources, both capital and revenue and progress must be set in the context of other local authority demands. Therefore, we are not in a position at this stage to have a definite timeline for delivery of this facility.

I will ask at the next meeting of the Metropolitan District of Limerick about whether a sustainability audit was carried out for Riverfest 2024 and if not could a sustainability audit be carried out on forthcoming festivals beginning with Samhain 2024.

REPLY:

A sustainability audit was not undertaken for Riverfest 2024. However, Limerick City and County Council is currently examining the sustainability of its Civic festivals in line with LCCC's Festivals and Events Strategy.

Samhain is an independent festival produced and delivered by Lumen Street Theatre.

Limerick City and County Council makes direct investment in the festival sector through the annual Festivals and Events scheme. The competitive grant scheme, offers the opportunity for funding under three Strands.

The three strands of funding are:

- S1: Delivery and Programming of Small and Community focused Festivals and Events
- S2: Delivery and Programming of Medium and Large Scale Festivals and Events
- S3: Festival Development and Sustainability

Strand 3 seeks to fund actions to support the long-term sustainability of Festivals/Events. This strand aims to support the development of organisational structures such as the carrying out of feasibility studies; business plan development; reviews of governance structures; development of new

Festival/Event concepts; marketing and audience development strategies; brand development; clustering initiatives which support collaboration through shared resources and/or expertise amongst two or more Festivals/Events. This award is intended to support a step change in the ambition and delivery of the festival.

Dear Vincent,

I have examined the agreement, maps etc. in relation to the above. The documents go back to the early 1970's and the agreement had a specific purpose which was to accommodate surface water from the then new Raheen Industrial Estate. The solicitor acting at the time for the County Council was Mr. William Leahy and as you know our firm Leahy Reidy is the successor firm to the old Leahy & O'Sullivan. It would not be appropriate to share the documents I have viewed as they relate to an agreement with a considerable number of persons all of whose consent would be required.


By way of background in the early 1970's the Council entered into a legally binding agreement with persons residing in the region of Loughmore Canal. This letter relates only to that part of the Canal constructed through Loughmore Commons. The agreement involved payment of compensation and legal costs by the Council and in exchange the parties to the agreement surrendered their grazing rights in the area of Loughmore Canal and further granted rights of way for various purposes to the Council its servant and agents with and without vehicles to enter lands not acquired by the Council to gain access to the Loughmore Canal. It is quite clear that all parties were fully aware of the purpose of the Agreement and the parties surrendering their grazing rights had their own independent legal advisors.

Not only did the Council compensate the parties to the agreement but it also further agreed to do the following

1. To fence a specified area and to maintain the fence
2. To provide sluices at the points marked on the map to enable water on Loughmore to be drained into the trench
3. To provide a substantial bridge 10 feet wide at a specified point to enable cattle to pass and repass over the trench.

It is important to understand the content and significance of this agreement given the construction and importance of Raheen Industrial Estate. Since the date of the Agreement the Council constructed the Canal, back drains, sluices, bridge, sections of pipeline, fencing and gates and over fifty years carried out continuous maintenance work on the Canal in conjunction with various other statutory bodies including SFADCO and the IDA. We have not been provided with any evidence that any party other than the Council has any evidence of a legal interest in Loughmore Canal. The Council's legal interest has been acquired by agreement with third parties as mentioned above, the payment of consideration and the construction and maintenance of the Canal for over half a century. The rights acquired by the Council and its servants and agents are not in our opinion capable of being successfully challenged by any party.

I will ask at the next meeting of the Metropolitan District of Limerick for an update on extending the 30kmph zone to residential streets in the city centre including St. Joseph's Street, St. Alphonsus Street, Barrack Hill, Lord Edward Street and Rosbrien Road.

Response:

As part of the Programme for Government an implementation group was formed to review and reduce speed limits where appropriate to address both road safety issues and carbon emissions. As part of this review the following amendments in relation to default speed limits were proposed and legislation passed to amend the default speed limits as follows:

- a) On national secondary roads, from 100km/h to 80km/h
- b) On local roads, from 80km/h to 60 km/h
- c) On roads in built-up areas from 50km/h to 30km/h

The legislation was amended with respect to the default speed limits on the 12th of April 2024. The Department of Transport have indicated that the Bill will be "commenced" in phases.

- The first phase is the implementation of the local roads default from the current 80 km/h to 60 km/h.
- The second phase is the implementation of the national secondary roads default from the current 100km/h to 80km/h and also on roads in built-up areas from the default of 50km/h to 30km/h
- The third phase will examine particular areas of sensitivity such as schools or locations where VRUs are the predominant road user

Phase 1 has commenced with a view of the introduction of the revised speed limits in November with Phase 2 commencing in the first part of 2025. Any proposed extension of the 30kph zone will be accessed and managed as part of Phase 2 and implemented in accordance with the guidelines.

I will ask at the next meeting of the Metropolitan District of Limerick for an update on THM levels in Limerick City water supply and if it's now compliant with EPA recommendations.

Dear Mr. Mark Leahy,

I am writing to you today regarding your representation on behalf of your constituents in advance of the July Meeting of the Metropolitan District of Limerick. Your Uisce Éireann reference number for same was 24249 which was raised on the 10/7/2024.

In response to your constituent's query, I wish to advise that the last update provided to the EPA, in terms of actions to be taken for this supply, is as follows: The project for resolving the THM issues at Clareville WTP was handed over for infrastructure delivery in Q3 2023.

The solution requires extensive bench trials and experimental design to study the efficacy of the following options prior to implementation of a preferred solution: 1. Enhanced coagulation optimisation 2. Chlorine Dioxide Dosing 3. PAC Dosing 4. Potassium Permanganate dosing 5. Chloramination. An instruction to commence with the bench trials was issued to our Early Contractor Involvement (ECI) partners in Q4 2023, with trials ongoing.

On successful completion of bench trials, the optimum solution will be selected based on the effectiveness in THM reduction while adhering to other water quality standards. A preferred solution and timeline will be confirmed in Q4 2024. Please find report attached as requested.





I will ask at the next Meeting of the Metropolitan District of Limerick what is the funding that was given by Central Government for the Travelling Community. How much has been spent and a breakdown of expenditure.

REPLY:

There is no set fund provided to Local Authorities by Central Government. Each Local Authority must apply for funding for projects they wish to undertake as set out in the Traveller Accommodation Programme. Limerick City & County Council claimed a total of €9,953,304.11 during the period January 2019 - June 2024. This is made up of €7,536,271.82 in Capital Expenditure and €2,417,032.29 in Traveller Specific Accommodation Maintenance for the Limerick Metropolitan Area. Between July 2024 and December 2024 it is hoped that a capital project of €1.5 million will commence in Rathkeale and a capital project of €175,000 will be complete in Askeaton. The new Traveller Accommodation Programme will commence in January 2025.

I will ask at the next Meeting of the Metropolitan District of Limerick what was the revenue from dog fines when released back to their owners from Limerick pound over last 2 years.

Response:

A reclamation fee of €50 is to be paid to reclaim your dog from the Dog Shelter. The fee can be waived at the Dog Warden's discretion depending on the circumstances. The issuing of a fine will depend on whether an offence has been committed under the Control of Dogs Act.

Over the last 2 years (From July 2022 to June 2024), €1,300 total was paid in reclamation fees. There were 39 dogs reclaimed from the shelter during this period and 26 owners paid the fee.
