The 2014 Act requires that each Local Authority establishes an Audit Committee. The Local Government (Audit Committee) Regulations 2014 states the Audit Committee shall consist of seven members (where the total revenue expenditure by a local authority in 2013 exceed €150m) and shall include:

- not less than four external members,
- not more than three serving or retired elected members, and
- three or more persons having knowledge or experience in finance, audit or accounting.

It is proposed to nominate the following external members for appointment to the Audit and Risk Committee:
