Thank you for your correspondence regarding the fee structure of the naturalisation process to the Minister of Justice, Ms. Helen McEntee T.D. I am responding to you on behalf of the Minister.

The fees to be paid by an applicant for a certificate of naturalisation are governed by the provisions of the Irish Nationality and Citizenship Regulations 2011 (S.I. No. 569 of 2011). The application fee is â¬175.

A certification fee of â¬950 is then required following a positive decision being reached on the naturalisation application.

The standard certification fee is set at â¬950, while a reduced fee of â¬200 applies in the case of an application made on behalf of a minor or in certain cases where the application is made by a widow, widower or surviving civil partner of an Irish citizen. In the case of recognised refugees and stateless persons, there is no certification fee.

All of the fees payable are kept under ongoing review by the Department. However, there are no current plans to amend the fees.

It's important to note the State has not increased the fees for naturalisation applications since 2011.




Government examined in detail the recommendations of the independent Shannon Estuary Economic Taskforce Report and an implementation update, published by my Department in December 2023, outlined the good progress made on implementing actions. The implementation update also noted that some proposals were subject to further consideration in the context of ongoing national policy development. Officials in my Department are currently engaging with Departments and Agencies with a view to publishing a second implementation update in the coming weeks.

I note the Taskforce's recommendation that a regional implementation group be established to bring together key local stakeholders to advance the vision set out by the Taskforce. This would be beneficial in driving implementation at a local level and officials in my Department are available to engage with Limerick City and County Council, and the other Local Authorities in the region on proposals for how this group might be established.



Dear Councillor,

The National Oversight & Audit Commission (NOAC) has just published its 10th annual Local Authority Performance Indicator Report.

The report provides measurable and meaningful indicator data on progress, and performance of local authorities on 45 separate indicators over 11 distinct areas. Some of the report's findings are shown below, but you may find it useful to look at indicators relative to your particular local authority.

Indicative key Indicators

- The overall vacancy percentage of directly provided local authority stock is now at **2.81%** down from **3.03%** in 2022.
- **Average Re-letting Time** in 2023 was **33.72 weeks**, an improvement on 35.22 weeks in 2022.
- The number of **rented dwellings inspected** was **50,436**, a rise from 40,282 in 2022.
- **70,584** pollution complaints were made to local authorities in 2023.
- The total number of **library visits** in 2023 was **13,879,927**, with **16,219,445 items issued to library members**.
- **299,333.79** days were lost to certified sick leave by the local authority sector in 2023.
- **1,278** separate **websites** are being operated by the 31 local authorities.
- Six local authorities showed a **deficit on the Revenue Account** at the end of 2023.

At the launch of the report the **Minister of State at the Department of Housing, Local Government and Heritage** said: "This 10th Anniversary Performance Indicator Report is evidence of our local government's dedication to excellence and accountability."

Michael McCarthy, Chair of NOAC: "Local government continues to demonstrate its resilience and ability to embrace and adapt to new demands and priorities. In addition, they are also facing increasing demands and rising costs, which makes financial management and sustainability more important than ever."

It is hoped that this 10th Annual Local Authority Performance Indicator Report will support local government in their ongoing efforts a high standard of service and accountability to their communities.
