


# Executive Report

## Economic Development, Enterprise and Tourism

### 1. Trade and Investment

#### Industry Events

##### Trade and Investment attended:

#### Night-Time Economy Action Plan

Roundtable discussions on 14 and 15 October in The ENGINE building on Cecil Street. These sessions promoted a robust exchange of ideas, strategies and solutions aimed at enhancing the marketing and visibility of Limerick's night-time offerings.

#### Limerick Gift Card

A press release was issued announcing the Limerick Gift Card Initiative, a partnership between the Council and Limerick Chamber. The aim of the gift card is to increase footfall and spending in businesses across Limerick.

#### FDI Cities and Regions of the Future 2025

An application was submitted to this competition which analyses the most recent foreign direct investment (FDI) promotion across Europe. The competition is run by the Financial Times FDI Intelligence Magazine.

#### Forge Design Factory

Trade and Investment participated as part of a team led by Limerick School of Art and Design. The application was to secure priming funding to investigate design infrastructure and the creation of a central hub, based on an International Design Factory Model. It would have a focus on digitalisation and digital transformation, green transformation for enterprise, innovation diffusion, international collaboration on research, development and innovation, and improving the national/regional enterprise research and innovation systems. The application for €200,000 was successful.

## 2. Local Enterprise Office (LEO) Limerick

- This Year's LEO Midwest Region (Limerick, Clare, Tipperary) National Women's Enterprise Day was held in Dromoland Castle, Co. Clare. The Keynote Speaker was Aimee Connolly of Sculpted by Aimee, with a panel of guest speakers including Nell Stritch, a Limerick Entrepreneur and owner of Pressed Flowers by Nell.
- The focus of the full-day programme was on female entrepreneurship. 155 attendees networked, engaged with leading industry experts and acquired valuable knowledge about the extensive range of supports available from LEO. The team at the Limerick Local Enterprise Office was delighted to be able to provide a platform of this scale to enable the Female Entrepreneurs of the Limerick Region to engage with others in the Midwest, enhancing their business relations and knowledge. It was also revealed that so far this year, 64% of those who availed of training by the Local Enterprise Offices were women and that 61% of the participants in the Local Enterprise Offices 'Start Your Own Business' programme in 2024 have been female.
- LEO Limerick ran eight Training and Development programmes during October for Limerick based businesses, which were attended by 152 people from across the City and County. Our Autumn/Winter LEAN for Business programme also commenced with 17 businesses participating.
- Maximising Sales for Q4 Seminar, aimed at the Limerick retail industry and hosted by Miriam Simon, was held on 14 October and took place in the ENGINE building. There were 21 business owners in attendance.
- LEO Limerick also approved Green and Energy Efficiency supports for four businesses during the month of October, as well as five Trading Online Vouchers to assist Limerick companies wishing to trade online, and two TAME (Technical Assistance for Micro Exporters) grants to assist Limerick businesses with their exporting strategy.

## 3. Tourism

- Staff from the Tourism Department of Limerick City and County Council attended the Fáilte Ireland hosted Clare and Limerick Tourism Industry Networking Event in Dromoland Castle Hotel on 08 October. The structured 1:1 networking meetings were timed at four minutes long, allowing two minutes for each person to speak about their area of work, the attraction they were promoting, etc. Attendees were encouraged to network with as many other attendees as possible at the event, regardless of sector, to introduce their attraction or business, to discuss their target markets, and to establish support networks among business owners in the Clare and Limerick region. Additionally, a talk took place from special guest, Dr. Eoghan Staunton, on the following topic: The Exciting Future of Tourism in an AI (Artificial Intelligence) World. More than 50 businesses took part with half of those attending being from Limerick.

## FESTIVALS AND EVENTS

The Bualadh Bos Childrens Festival celebrated its tenth year in 2024 and ran from 02 to 12 October. There was an array of offerings for families and schools to enjoy over the festival. The diverse range of shows had something for everyone; the shows were aimed at different age groups and interests. The Family Day on 12 October saw a masterclass for aspiring artists at the Limerick City Gallery of Art, Moving Words, a dance performance at Dance Limerick, Wandering Stories workshop at The Belltable, with a finale screening of the Muppets Take Manhattan. The festival gave the opportunity to children to be creative in fun ways. The Pay It Forward Fundraising Campaign continued giving opportunities to families, who may not normally afford it, to attend.

The Ballyhoura Walking Festival, now in its 28th year, took place from 04 to 06 October. The festival took in a three-day series of walking related activities. Events included a moonlight walk off Carrighenry, a dawn chorus sunrise walk, half marathon via Highest Peaks, charity walk and Mitchelstown food and heritage tour. On the last day, activities included a yoga walk experience, Kilmallock medieval town walk and History of Ardpark Hill tour.

On 06 October, the Cook Medical Women's Mini Marathon took place at the University of Limerick Sports Arena. The event saw all ages run the 5 or 10 km courses. The participants each ran for their individual charities. The marathon has raised over €200,000 for various charities since its commencement.

This year's Castleconnell Halloween Frightfest hosted events over the month of October. Between 04 and 16 October, there was the Children's Historical Treasure Hunt, and from 11 to 22 October, a Children's Halloween School outreach programme was run. There are in excess of 150 staff currently working on site.

## Film in Limerick

### Feature Film "One Night Only" begins Production in Limerick

Film in Limerick has been working with the producers of new feature film 'One Night Only' to bring the project to Limerick. The project stars Colin Morgan (Dead and Buried, The Fall, The Boy That Never Was) as the manager of a small-town cinema who struggles to keep the peace on a chaotic Friday night at the pictures.

The project has been in pre-production since early October, based at the ENGINE Building on Cecil Street, and at the old Royal Cinema and offices on O'Connell Street. The production's art department has been busy transforming the former cinema and building sets at the venue to prepare for filming.

## Rural, Community and Culture Development

### 1. Rural

#### Rural Development

- On 07 October, the Department of Rural and Community Development awarded €532,722 in funding to Limerick, for a range of projects to be delivered through the CLÁR 2024 Programme. Twelve projects in total were successful, five sports clubs - Galtee Gaels GAA, Glenroe GAA, Mountcollins GAA, Athea GAA, Ballylanders GAA, five community groups - Killeedy Eco Park Group, Cappamore Development Association, Anglesboro Community Centre, Ashford Hall Group and Kilfinane Community Projects, and two national schools - Glengurt National School and Kilbehenny National School. Some of this year's projects include car park enhancements, upgrading of playing and club facilities, installation of shower and toilet facilities and the provision of multipurpose equipment and a sensory room, in sports facilities.
- On 17 October, the Department of Rural and Community Development issued a call for projects, under the Outdoor Recreation Infrastructure Scheme (ORIS), which provides funding for the development of new outdoor recreational infrastructure. It also provides support for the necessary repair, maintenance, enhancement and promotion of existing outdoor recreational infrastructure in rural areas across Ireland. The Rural Development Section will work with local communities and stakeholders to identify projects for submission across all of the funding measures.

### 2. Community Development

#### Pride of Place

- On 16 October, the Mayor of Limerick, John Moran, received a visit in Corporate Headquarters from the four groups representing Limerick at this year's IPB Pride of Place Competition. The groups and respective categories are:
  - Urban Neighbourhood under 3000 - Johnsgate Residents' Association

- Halloween Fun in King's Island took place on 31 October at King's Island Community Allotments and Community Centre, offering family-friendly pumpkin carving and a disco, encouraging community connection and wellbeing.

- Children's Book Festival takes place throughout the month of October each year and this year Foynes, Roxboro, Rathkeale and Cappamore libraries welcomed 140 pupils from local primary schools and creches for special storytimes.
- Glin Library Book Club welcomed Donal Ryan on 18 October for a chat about life as an author and his most recent novel 'Heart, Be At Peace,' which the Book Club read for their October meeting. 58 people attended the weekly singing group, 10 the fortnightly craft group, and the branch welcomed 12 pupils from Second Class in the local primary school. The weekly family board games afternoon continued.
- Rathkeale: On 30 October, the branch welcomed thirty children who were participating in the West Limerick Resources led Halloween camp for a morning of crafts and stories.
- Children's author, Judi Curtin, visited Roxboro Library on 02 October as part of our programme of events for Childrens' Book Festival. The pupils from Fourth Class in Our lady Queen of Peace attended.
- *Patching Femininity* by Polish artist, Olga Anacka, explored and challenged visual representations of femininity and the female body in western culture. The exhibition ran until 25 October and was part of the Polish Arts Festival programme for 2024.
- LCGA continued to exhibit a selection of works from the Permanent Collections on a rotation basis using separate exhibition galleries within the building. The exhibitions display recent works donated and acquired, as well as works which are firm favourites, to local and international visitors.
- Visitor numbers for the month of October exceeded 6,000.
- On 08 October, LCGA facilitated a workshop with the Irish World Academy of Music and Dance, University of Limerick, where the students spent the day at LCGA composing music in response to the current exhibitions. This is the fourth year of this innovative collaboration.
- LCGA continued to collaborate and facilitate workshops with Helium Arts and hosted an event for the family participants on 19 October and the launch of their exhibition on 23 October.
- LCGA continued to facilitate meetings for the University of the Third Age (U3A).
- LCGA continued to host visiting primary, secondary and third level students coming to view the exhibitions on display.
- Two works by Sarah Purser from LCGA Permanent Collections are on loan to the Hugh Lane Gallery for the major exhibition, More Power to You.
- LCGA continued to prepare for Museums Standard Programme for Ireland (MSPI) accreditation with the Heritage Council.

## Limerick City Gallery of Art (LCGA)

- The exhibition, *Spontaneous Self*, by Vivienne Bogan, continued through October. This is Bogan's first major institutional show in Limerick. A graduate of Limerick School of Art and Design, Bogan has had an illustrious career with work in several public and private collections nationally and internationally. The launch of a publication for Vivienne Bogan's exhibition took place on 31 October at 2pm.
- *Odysseys of Self*, an exhibition by Tina O'Connell, recipient of LCGA's Graduate Exhibition Award 2024, ended on 06 October. This is an annual award to a graduate of Limerick School of Art and Design who demonstrates ambition and dedication to their practice. The exhibition was very well received.

## Limerick Museum

- On 08 October, in Limerick Museum, Councillor Maria Donoghue, acting on behalf of the Mayor of Limerick, John Moran, performed the official opening of *To Jack*, an exhibition by Clare Lyons, curated by Catriona Osborne. Clare Lyons is a visual artist and photographer from Dublin, currently based between Bath and Bristol. She holds an MFA in Photography from the Belfast School of Art in Ulster University. Clare's practice finds its concern in the tactile nature of the photographic image. *To Jack*, derived from the Lyons family archive, was a deeply personal exhibition that intertwined the narrative of Clare Lyons and her father, Jack Lyons, into the fabric of societal history. The exhibition was on display until the end of October.
- On 10 October, the Príomh Chomhairleoir of Limerick City and County Council, Councillor Dan McSweeney, performed the official opening of *Remembering Krups 25 Years Later*, an exhibition by Limerick Museum and Limerick Enterprise Development Partnership (LEDP), celebrating the impact of Krups Engineering in Limerick between 1963 and 1999. The official opening was held in the LEDP Campus, Roxboro Road, in the presence of His Excellency, Mr David Gill, German Ambassador Designate to Ireland. Curated by Limerick Museum, and in collaboration with University of Limerick's Centre for Irish-German Studies, the exhibition consisted of a collection of artefacts, photographs and memorabilia representing the rich history of the factory and was on display in the LEDP Campus for three weeks.
- On 01 October, as part of the successful outreach programme, the Museum held a lecture on the 200 Years of Achievement: The Dunraven Family and Limerick, exhibition for the Limerick 922 Probus Club.
- On 05 October, the fifth and sixth class students from Caherelly National School, Ballybricken, Grange, Kilmallock, visited the Museum and were given a guided tour.
- The Limerick Museum exhibition 200 Years of Achievement: The Dunraven Family and Limerick, continued in Saint Mary's Cathedral throughout October.
- The pop-up exhibition, *Objects of the Revolution* in East Limerick, continued in the Museum throughout October.

## Limerick Arts Office

### Arts Office and Creative Ireland Programmes

#### Decade of Centenaries

"Her Skies, Our Voices" was launched on 31 October in Newcastle West library. This was a collaborative creative writing project between playwright and producer, Ella Daly, aviation expert, Ruth Bagnell, and young women from Newcastle West, centred on the life of Sophie Peirce-Evans, also known as Lady Mary Heath. The project explored creative writing in the creative non-fiction genre and included research into the subject's life, including a visit to Weston Airport to see and sit in an open cockpit aircraft, the likes of which she would have flown.

The website is now available [www.ladymaryheath.ie](http://www.ladymaryheath.ie) and contains the creative writings, biographical information, photos and videos pertaining to Sophie Peirce-Evans, all in one place. This project aims to be the start of a digital resource on Lady Mary Heath and will further her legacy into the future. The project was supported by the community of Newcastle West and the aviation sector. The project was supported through Decade of Centenaries Funding with subsequent private sponsorship from Aero Inspection International and Atlantic Flight Training Academy.

## Contemporary Cities Project

Work commenced in October under a new partnership between Limerick Arts Office and Hard Rain Soloist Ensemble, Belfast. Founded in 2013, Hard Rain is a world class group of musicians dedicated to the performance of modern and contemporary music. The new 'Contemporary Cities' project aims to create partnership music projects between Limerick and Belfast.

On 21 October, the ensemble delivered workshops on contemporary music score reading, performance and composition to students and teachers in Limerick School of Music. The ensemble performed in Castleconnell on 22 October, performing contemporary music which shows a connection between the composers in Belfast and the West of Ireland, plus present music which is both beautifully atmospheric and with a strong narrative behind it to entice listeners.

This was the third concert of the Castleconnell Autumn Concert Series, which is programmed by Limerick Arts Office, with financial support from the Arts Council and Creative Ireland. The concerts are presented in partnership with Love Castleconnell at All Saints Church and are recorded for a future broadcast on RTE Lyric FM, The Full Score Programme with Liz Nolan.

Children and young people from two Abbeyfeale national schools, and Foróige, participated in a morning of interactive contemporary music with Hard Rain in Glorach Theatre on 23 October. The workshop included demonstration of classical instruments and music, techniques, sounds and interactive conducting and song. This project was funded by Creative Ireland.

## Síolta Glasa

The Creative Climate Action project, Síolta Glasa, currently being delivered by Creative Ireland Limerick in partnership with Climate Action, held the second of their storytelling workshops for participating creatives and communities on 29 October. The workshop was facilitated by Dr. Fergal Quinn and the UL School of English, Irish and Communication.

## Artists' Studios, Apartments, and Tyrone Guthrie

An invited panel of three external professionals met on 08 October to assess applications and make recommendations on allocation of two single-occupancy artists' apartments, one artist studio, and three Tyrone Guthrie Bursaries.

## Artists Professional Development Programme - Visual Artists Ireland

A presentation, led by Fiona Byrne, on Artist in Schools programmes, was delivered in partnership with Visual Artists Ireland. This workshop was free to Limerick-based artists as part of the Limerick Arts Office professional development supports in the region.

## Éigse Michael Hartnett

Éigse Micheal Hartnett opened on 03 October, with events, readings, talks, exhibitions and music presented in Newcastle West. The literary and arts festival continued until 06 October. This festival is part of Limerick Arts Office rural excellence strand and is funded in part through Arts Council partnership funding and by Limerick City and County Council funding.

The Michael Hartnett Poetry Award, which is funded by Limerick Arts Office and the Municipal District of Newcastle West, was presented to poet, Tara Bergin, by the Mayor of Limerick, John Moran, on 03 October.

**Newcastle West Music Café** (pilot project) commenced in October, with meet-ups being held each week. Developed in partnership with West Limerick Resources and funded under the Limerick Creative Communities programme, the project aims to create connections, share stories, songs and music.

**King's Island/St. Mary's Youth Drama** also commenced in October. This is a pilot project to develop possibilities in community theatre, in cooperation with the Limerick Youth Diversion project, and is funded under the Limerick Creative Communities Programme.

## Regeneration, Sports and Recreation

### 1. Regeneration and Sports

#### Regeneration

##### Economic Regeneration

- Limerick City and County Council, in partnership with TUS Midwest and the Limerick and Clare Education and Training Board (LCETB), held a Jobs Fair in St. Mary's Park on 10 October. Over 20 employers, educational and training partners were there to discuss a wide range of opportunities available to the community. Over 140 people attended the Jobs Fair which forms part of the strategy for the Outreach to Employment Programme.
- The Outreach to Employment Co-ordinator facilitated a site visit to the National Learning Network (NLN) centre in Raheen Technological Park on 17 October for the Community Mentors and met with the NLN Employment Co-Ordinator to discuss opportunities available to people from age 16 who wish to be supported into education or employment and training.
- The Outreach to Employment Co-ordinator also facilitated a site visit to the LCETB College of Further Education and Training, O'Connell Avenue Campus, on 23 October for the Community Mentors to discuss access to a range of courses available across the LCETB campuses.
- The Employment Project Group met in Southill Hub on 15 October to plan for the final Jobs Fair for 2024 in Southill Hub.
- On 07 October, an online meet-and-greet took place for staff from the Regeneration Directorate and staff of Verizon Limerick who were briefed on the Outreach to Employment Programme.

#### Social Regeneration

##### Community Activities

##### King's Island

- Weekly events such as Crafty Mondays, Family Learnings, Lego Club and Bingo continued in King's Island Community Centre.
- Local children participated in the Samhain Parade, organised by Lumen Street Theatre, held on 26 October, which travelled through the city.
- A Pumpkin Patch event was held on 25 October in St. Mary's Park Allotments which was well attended by both children and adults from the community. This event was led by PAUL Partnership and community residents of St. Mary's Park.

##### Moyross

- Boxercise, Functional Fitness and Activator Walking were among a number of weekly programmes run in Moyross Youth Academy and Moyross Community Enterprise Centre, in conjunction with Limerick Local Sports Partnership.
- A Halloween Event for children took place in Moyross Community Enterprise Centre on 31 October.

##### Southill

- Students of Architecture at the University of Limerick were given a detailed presentation on the ongoing restoration works at Turner's Vinery on the grounds of Tait House. Local Councillors and Department of Housing, Local Government and Heritage staff were also in attendance, as the contractor and other stakeholders explained the restoration process.
- Delivery of community education classes in gardening and crafts continued in Tait House.

- Tait House co-ordinated the delivery of a digital literacy training programme to clients of Mid-West Simon Community.
- Limerick Growing Communities events continued during October - in partnership with Sláintecare Healthy Communities Programme and PAUL Partnership.
- The annual Halloween Pumpkin Patch event saw more than 100 local children enjoy this activity, during their mid-term break.

## Ballinacurra Weston

- Our Lady of Lourdes National School celebrated the first anniversary of the HAPPEE Project (Health Alliance for Practice-based Professional Education and Engagement), on 21 October. The celebrations included a choir performance by pupils, in addition to the sharing of key insights from stakeholders as to the importance of the project and the benefits for the participants. It is part-funded by Limerick City and County Council, and is currently delivered in six local primary schools, in partnership with the University of Limerick and St. Gabriel's Foundation.
- The four recently introduced Community Companions supported the local community to restore the grotto at Clarina Avenue/Crecora Avenue. Over 40 community members were involved in the clean-up and restoration works. This was funded under the Health, Wellbeing and Ageing Well Call of the Economic and Social Intervention Fund (ESIF).
- Our Lady of Lourdes (OLOL) Community Services Group hosted a townhall-style community consultation, supported by the Regeneration Education call, to explore a bespoke funding model for the centre. With 34 attendees, the event brought together diverse voices from across the community. Maria O'Dwyer joined as a researcher, gathering insights to help shape this tailored model.
- Two local after-school practitioners were hired this month. This is to help with an after-school club for 15 Junior Infants who attend Our Lady of Lourdes

National School. This is held within the OLOL Community Centre and provides a safe and supportive environment for 5-7 year-old children. This was funded via the Education and Learning Call, through ESIF.

## Physical Regeneration

### Housing Developments

- Works progressed on the infill housing at Carew Park and in Moyross. The works are for a total of 24 rapid build units at Carew Park, Southill and Delmege Park/Hartigan Villas in Moyross.
- Construction works moved towards completion on the Dalgaish Park and Cosgrave Park development at Moyross.
- The Sheep Street Development, comprising of eight social housing units, reached Substantial Completion in early October.
- Construction works progressed on Blocks 3 and 5 at Churchfield, Southill (Phase 2).
- Design works progressed towards lodgement of a Section 179A application for the Cosgrave Park Phase 2 development in Moyross comprising 20 units.

### Status of Thermal Upgrade Projects

- Thermal Upgrade Contract No. 121 (47 houses in Moyross) - nearing completion with snagging in progress.
- Thermal Upgrade Contract No. 123 (53 houses in Southill) - progressing on site.
- Thermal Upgrade Contract No. 125 (26 house in St. Mary's Park) - progressing on site.
- Thermal Upgrade Contract No. 126 (52 houses in Southill) - nearing completion with snagging in progress.

- Q3 Security Group have completed the upgrade to the vehicle and pedestrian access gates. Substantial progress was made with the upgrade of intercom system.

## King's Island Community Centre

- The appointed Integrated Design Team, led by Paul Keogh Architects, in consultation with the Working Group, continuing to advance design proposals for the King's Island Community Centre.

## Limerick Sports Partnership (LSP)

- LSP secured €138,750 under the National Participation Nation Sports Infrastructure and Biodiversity Supports Fund. This funding is for the development of a six lane Lawn Bowls Court. It will be the first of its kind in the Mid-West. Initial discussions were held with additional funders and partners, with a view to getting this project completed in 2025.
- 15 Sports Club Officers across the city and county have commenced our 12-week LEVEL 6 Sports Administration course. This programme is delivered in partnership with TUS and will help the identified sports clubs to develop best practice at club level and create a development plan to support on and off field activities.
- Funding was secured to recruit a Network Communications Officer to support Limerick LSP two days a week and the network of LSPs for three days a week. This role will be a great addition to the LSP team and will enhance the communication footprint.
- Limerick LSP was a host site for the EU Erasmus Youth Sport Network tour. Limerick staff met Youth Sport Officers from eight EU countries to share and discuss best practice in supporting sport and physical activity opportunities for youths from marginalised and disadvantaged communities. The developments in O'Brien Park and the Sports Hubs in Garryowen and Moyross Enterprise Centre were highlighted as key examples of best practice.

- Limerick LSP Active Cities staff attended the PACTE+ Project (Promoting Active Cities Throughout Europe) in Angers, France. The Active mobility pillar was the theme for the workshop, and LSP had the opportunity to share good examples from Limerick City.

## Council Sporting Facilities

### Limerick Regional Athletics Hub (LRAH)

- During October, 268 people used the track.
- A total of 65 signed up as new users during October.
- Local Club, West Limerick Athletics Club, had 80 juvenile members and 60 adults training weekly during this month.
- St. Mary's Athletics Club had 80 juvenile members training weekly.
- West Limerick Athletics Club began a Couch to 5K event. This had the maximum allowed 100 attendees weekly throughout the month.

- The Abbeyfeale Public Realm Scheme Phase 1 is designed to deliver a high-quality public realm scheme to enhance the built environment, improve pedestrian safety for residents and shoppers and increase the level of business in the town of Abbeyfeale. A priority of the scheme is to have the construction works carried out with minimal disruption to residents, shoppers and businesses with an emphasis on pedestrian safety, minimising supply outages, traffic delays and traffic disruption.

## Anti-Dumping Initiative

As part of the National Anti-Dumping Initiative, Limerick City and County Council offered a free Bulky Waste Collection Service to all households in the St. Mary's Park, Hyde Road and Ballinacurra Weston areas of Limerick City in the run-up to Halloween from 21 October to 25 October. The service was limited to a maximum of four bulky items per household and collections were made at an agreed time with the service provider. ## Biodiversity

### 08 October - Fourth Meeting of the Limerick

**Biodiversity Forum** - The Limerick Biodiversity Forum continued with its robust facilitated process to give final consideration to the draft Limerick Biodiversity Action Plan 2025-2030 before the document is considered by Elected Members at a dedicated workshop prior to going for Public Consultation. This process is a continuation of sectoral engagement that has been ongoing since the initiation of the process of drafting a Limerick specific Biodiversity Plan.

**14 October** - Biodiversity Officer, evening discussion with members of the Doon Men's Shed Project at one of their regular meetings on the Doon Social Farm.

**19 October** - There was a terrific turnout at the Limerick City and County Council and Hedgerows Ireland 'Managing Hedgerows for Nature Event' on Gearoid Maher's farm in Cappamore. Gearoid, a commercial dairy farmer and farming for Nature ambassador, opened his farm as a demonstration site for the event. Participants were treated to presentations from Dr. Aine Lynch, National Parks and Wildlife Service, Dr. Catherine Keena, Teagasc, Katie Smirnova, Hedgerows Ireland and the Council's Biodiversity Officer. In addition, there were 'A'- shape trimming and hedge laying demonstrations. The host and Farming for Nature Ambassador, Gearóid Maher, also shared how he keeps a productive dairy farm while reducing inputs and making space for biodiversity. Hedgerows may sequester between 0.66 and 3.3 t CO<sub>2</sub> per hectare per year (EPA, 2014). They provide food, nest sites, hibernation sites and a corridor for safe passage through the landscape for wildlife. Hedgerows benefit agriculture by providing windbreaks, shelter and or shade for livestock. During heavy rainfall, they help prevent flooding by slowing water movement and allowing excess water to soak into the soil. This also helps improve our freshwater quality by trapping sediments and nutrients and blocking their entry into rivers and lakes (Holden et al., 2019).

## Environmental Awareness

### Limerick Going for Gold – Environmental Improvement Grant and Competition

The grand final award ceremony was held in the Limerick Strand Hotel on 23 October with a large attendance, including representatives from the McManus Charitable Foundation, Sponsors/project partners – Limerick Live 95, The Limerick Leader, The Limerick Post, I Love Limerick and Southern Marketing Media and Design. It was a very enjoyable occasion with 36 groups representing localities across Limerick City and County in receipt of prize money and certificates. The perpetual trophies for the overall winner of the Tidy Towns Category and the Limerick Bee Friendly in Bloom Category were also awarded.

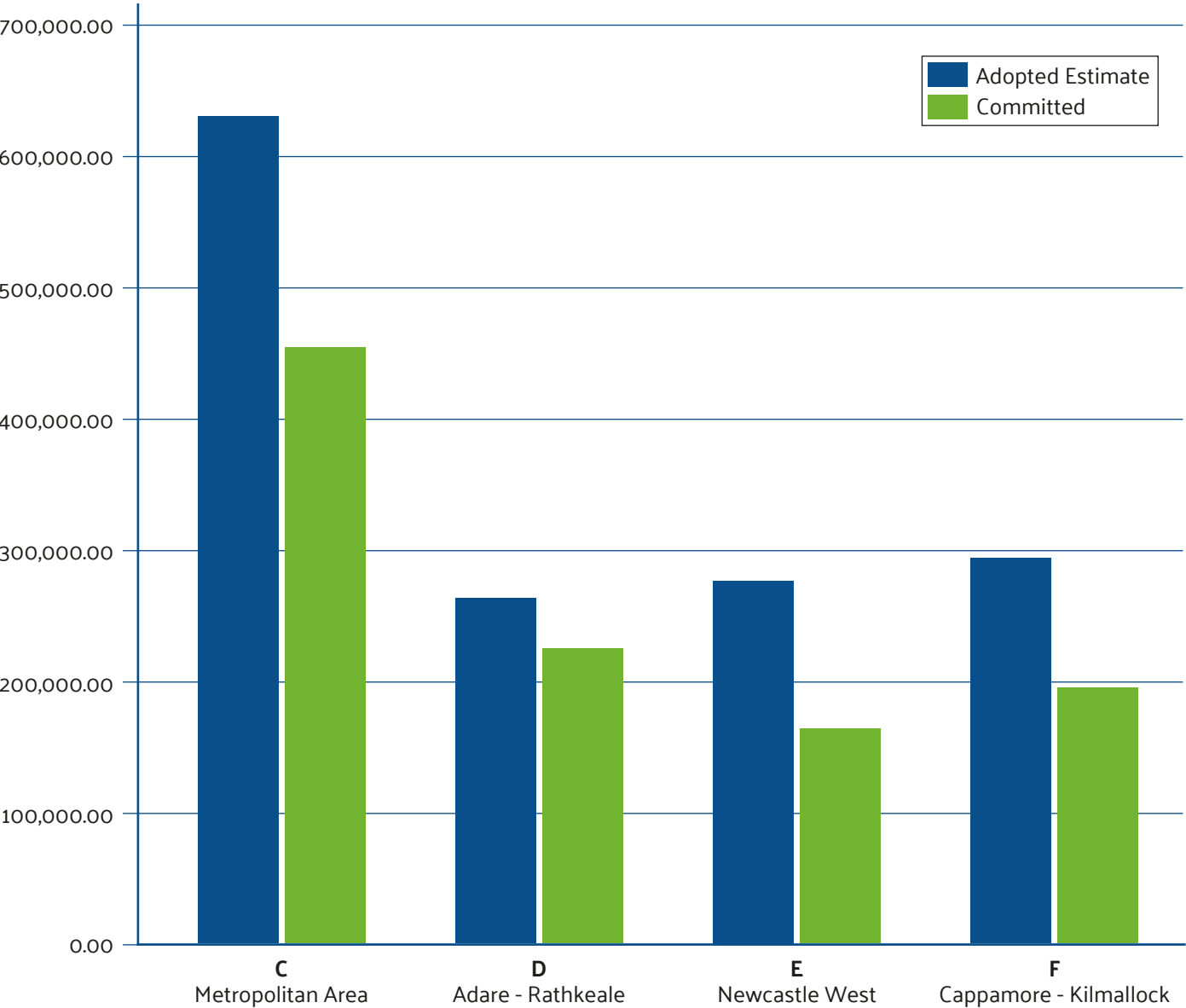

## Customer Services

The Customer Services Team continued to support customers and Public Representatives at first point of contact by answering queries via telephone, email, MyLimerick and social media. Case creation, payments processing and generally facilitating applications for all Council services also continued throughout the month.

The following figures highlight the activity within the Contact Centre throughout the month of October:

- Customer Services Call Centre answered 11,850 calls. This represents an average of 538 per day, with the number of calls reaching as high as 675. A total of 77% of calls were handled at first point of contact.
- A total of 3,999 emails were processed through the Customer Services email platform.
- 3,449 cases were created on Microsoft Dynamics, with 761 of these logged on behalf of Public Representatives. 3,425 cases were closed, with 903 of these being cases logged by Public Representatives.

- Of the 3,449 cases created, 69% were logged by the Customer Services team.
- The logging of cases through the MyLimerick portal continued, with a total of 211 cases being logged. Of these, 196 were submitted by Public Representatives.
- Customer Services continued to support the Housing Maintenance Department in creating service requests and, throughout the month, 96% of Housing Maintenance cases for the Metropolitan District of Limerick were logged by Customer Services staff in the Dooradoyle and Merchant's Quay offices.
- A total of 170 out-of-hours cases were created.
- Customer Services continued to provide other frontline services to the general public, such as processing applications for Residential Parking Permits, of which 122 were applied for and 73 issued.
- Customer Services staff welcomed a total of 2,742 customers at the Merchant's Quay and Dooradoyle offices.
