


Executive Report

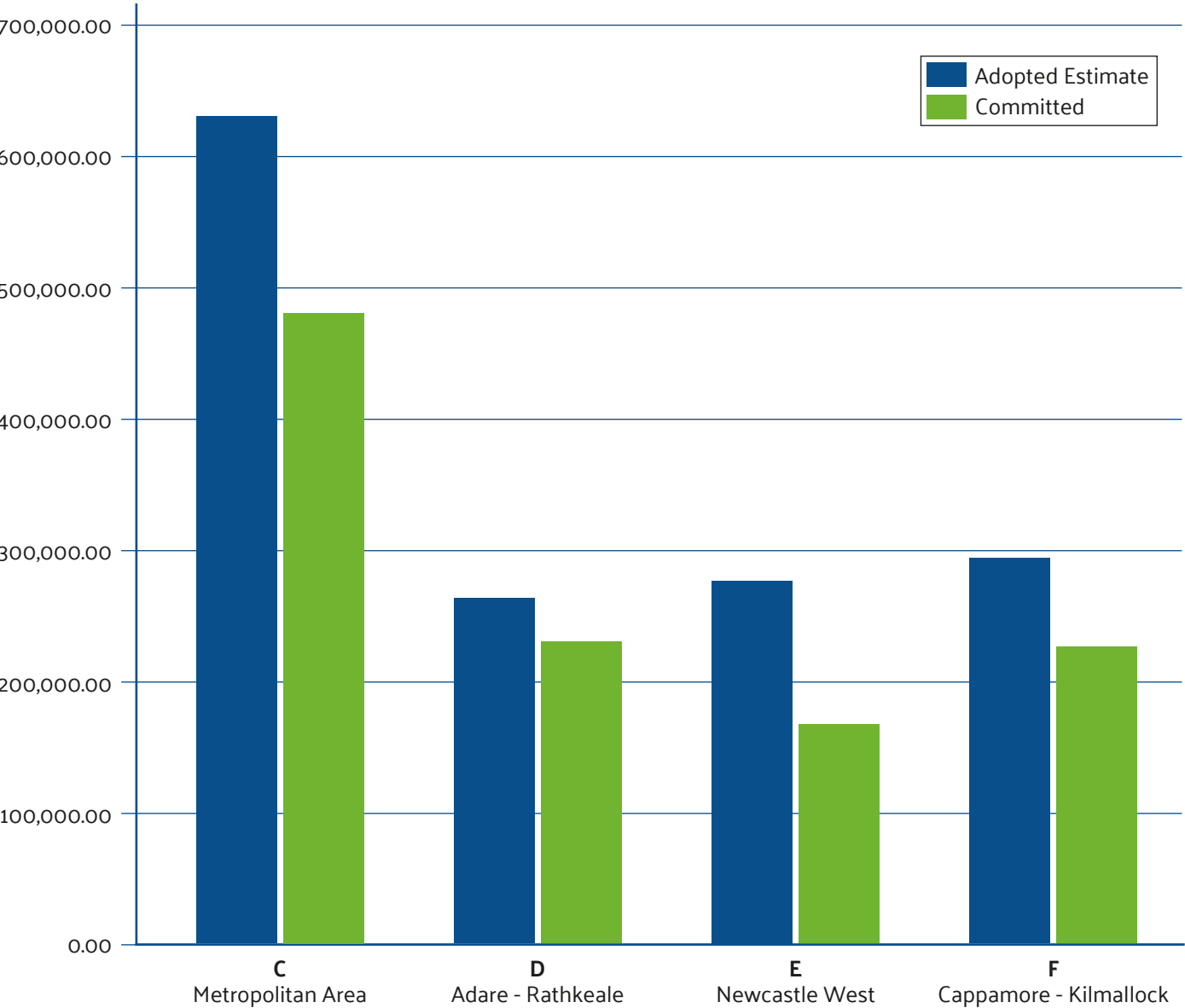

2. Trade and Investment

Home Instead Limerick announced that it will create 50 new positions for "CAREGivers" throughout the county, providing home care and company for older people who need it most.

Home Instead CAREGivers provide a range of non-medical services to older people from companionship to specialised dementia and palliative care. As well as helping keep older people safe and well, such care services can also facilitate early hospital discharge, or they can help prevent hospitalisations in the first place.

A new Limerick Gift Card was launched on 27 November at the Strand Hotel, Limerick as part of efforts to support local businesses by locking in spending and attracting new spending to the county. Backed by Limerick City and County Council and Limerick Chamber, the gift card is available as either a physical card or an e-card that can be added to digital wallets. Cards can be spent in the city and surrounding towns, including Newcastle West, Adare, Abbeyfeale, Kilmallock and Rathkeale. Over 140 businesses, including independent businesses and well-known Irish brands accept the new Limerick Gift Card.

Night Time Economy (NTE):

- Themed round table discussions were scheduled over two days, covering five key priority areas identified during earlier stakeholder consultations. During these discussions priorities and solutions were considered with key stakeholders and members identified for inclusion in the NTE Steering Committee.
- The NTE Advisor joined with the An Garda Síochána in delivering a safety update briefing to the business, retail and hospitality sector. This was following an earlier presentation during the year. A specific section of the briefing related to planned developments for safety under the NTE Action Plan.
- The NTE stakeholder engagement project was finalised with the development of a data report capturing outputs of consultations and review of existing relevant data.

- The initial meeting of the NTE Steering Committee was held with Mayor of Limerick John Moran as Chair. The draft plan was reviewed with minor changes to be adapted.
- The NTE Advisor finalised payments of the NTE Innovation Grant Scheme and other NTE initiatives; and prepared an overview of outcomes to the Department of Tourism, Culture, Arts, Gaeltacht, Sport and Media, to draw down funds.
- The newly launched Limerick Gift card scheme was partially funded by the NTE seed fund and NTE messaging incorporated in the marketing material.
- The NTE Advisor collaboratively worked with the other NTE pilot locations to develop a presentation to the NTE Taskforce committee and attended a meeting with the Department of Tourism, Culture, Arts, Gaeltacht, Sport and Media and NTE Taskforce Representatives. The focus was on progress of the NTE initiative and discussion on the emerging topic of meanwhile use which will see additional national supports in due course.

3. Digital Services

This month, Limerick City and County Council scooped the top award for Public Space and Planning at the 2024 KPMG Property Industry Excellence Awards.

This EU project was delivered through Go Green Routes Horizon 2020, funded by the European Union with a focus on enhancing the physical and mental well-being of urban residents.

GoGreenRoutes (2020-2024) is a €10.5 million international EU project. The focus of the project is to enhance the physical and mental well-being of urban residents by increasing their connection to nature. Limerick City and County Council chose the Castletroy Greenway as a brown site blank canvas to deliver a sustainable, inclusive, co-created design for both the community and nature. The landscape has been reshaped to create mounds covered in wildflowers and swales at low points and along paths.

The project provided the opportunity to create linkages between fragmented (sub)urban greenspaces and implement nature-based solutions that focus on contributing to green infrastructure in keeping with the principles of European Green Infrastructure Strategy. With a strong focus on natural play, the area has been remodelled to create a space of interest for young and old.

Limerick City and County Council's win highlights its role as a leader in sustainable urban planning and public space development. Congrats to all our staff involved on this exceptional EU Project.

4. Local Enterprise Office (LEO) Limerick

- On 12 November, LEO Limerick hosted an Export Business Seminar Conversation with Richard Curran at the Castletroy Park Hotel. There were over 50 business leaders from across Limerick City and County in attendance on the day, where opportunities for Business owners to win new business both domestically and internationally, was the theme of the event.
- The Advanced Management Development Programme came to a close on 22 November, after 10 successful weeks at the Woodlands House Hotel in Adare. This intensive programme, which was delivered on behalf of LEO Limerick, focussed on helping established businesses to plan and chart a course to grow and expand and their business.
- LEO Limerick ran 11 Training and Development programmes during November for Limerick based businesses, which were attended by 264 people from across the City and County.
- LEO Limerick also approved Green and Energy Efficiency supports for seven businesses during the month as well as four Trading Online Vouchers to assist Limerick companies who want to trade online and one Technical Assistance for Micro Exporters (TAME) grants to assist Limerick businesses with their exporting strategy.

Draft Limerick City and County Council Control of Stationless On-Street Shared E-Scooter Hire Services Bye-Laws 2024

The draft bye-laws have been placed on public display and submissions are invited from the public.

It is proposed to introduce Bye-Laws to manage and control the operation of Stationless On-Street Shared E-Scooter Hire Services in respect of the administrative area of the Metropolitan District of Limerick.

The Draft Bye-Laws cover the issuing of Operators' licences and provide for a permit fee for each individual e-scooter, in addition to specifying certain minimum standards for operators and e-scooter users / customers, together with the ability for the Council to prescribe streets/areas where e-scooters should or should not be deployed.

Limerick Road Safety Working Together Group Quarterly Meeting

The Quarterly Meeting of the Limerick Road Safety Working Together Group took place on 26 November. The annual review of the Limerick Road Safety Plan took place at the meeting.

The Road Safety Working Together Group is led and chaired by Limerick City and County Council and has representatives from An Garda Síochána, Transport Infrastructure Ireland, Health Service Executive – Ambulance Service, Limerick City and County Council – Fire and Emergency Services, Limerick Cycling Campaign and Limerick Pedestrian Network.

E-Scooter Awareness Campaign

During November, the Limerick Road Safety Working Together Group, led by Limerick City and County Council ran a public campaign to call for 'Responsible Use of E-Scooters'. The aim was to raise public awareness about the new regulations governing e-scooter use across Ireland and to encourage safe and responsible use of e-scooters in Limerick.

Golf Links Road

The Oral Hearing for the Golf Links Road Scheme was held on 06 November. Limerick City & County Council await the determination from An Bord Pleanála.

2. Active Travel

Projects on site:

Mill Road, Corbally, Limerick: Works continued to progress on site. Footpath construction continued. Kerbing at the Brookhaven Walk and The Hermitage junctions began. Drainage installation on the side-road adjacent to the Bishop's Field underway.

R510 Quinns Cross to Raheen, Limerick: Works continued to progress on site. Kerbing to footpaths from Raheen Roundabout to the Grange entrance completed. Landscaping works and installation of ducting ongoing.

Rósmor, Old Cork Road, Limerick: Works continued to progress on site. Remaining ladder tactiles installed at the entrance to the Rósmor Estate for enhanced pedestrian safety. 30 km/h slow zone signs and "Children at Play" signs reinstated to promote safer driving speeds and increased awareness of children in the area.

1. Rural

Rural Development

THRIVE - Town Centre First Heritage Revival Scheme is a programme co-funded by the European Regional Development Fund (ERDF) and the Government of Ireland and managed by the Southern Regional Assembly (the Managing Authority). With funding awarded to Limerick City and County Council to develop an Integrated Urban Strategy for Newcastle West and pipeline of town centre revitalisation projects, the Team in the Rural Development Department are pro-actively working with local stakeholders and people in Newcastle West. The purpose is to engage with them in co-creation of the strategy and identification of potential town projects. During the month, the engagement process involved promotion of participation in the online town survey, workshop-based consultations in locations in the centre of the town, one-to-one stakeholder meetings, and consultation workshop with young people in a school setting, a local multi-stakeholder meeting to feedback on key findings of the consultation/engagement process to date and gain additional insights and opinions. This was followed by hosting an online Think Tank meeting – again engaging with a wider group of local stakeholders from the public, business, community and voluntary sector including sport and arts and the creative sector and private individuals – and facilitated by an international team of consultants and Council staff. This process will continue to build up participation in co-creation of a vision of Newcastle West and guide the preparation and delivery to town centre projects.

Arts Office and Creative Ireland Programmes

Strategic Fund for Culture and Arts Scheme 2024

Limerick Arts Office manages the 2024 Strategic Fund for Culture and Arts Scheme. The purpose of the scheme is to support the maximising of the leveraging of funding into Limerick from national and international sources and to support a vibrant creative culture. In November four letters of support were issued. Funding to three applicants was approved by Council in November. The total award of €9,000 facilitated leveraging of €90,000 of Arts Council funding into Limerick City and County.

Contemporary Cities Project

Work continued in November under a new partnership between Limerick Arts Office and Hard Rain Soloist Ensemble, Belfast, with funding provided by Creative Ireland. Hard Rain is an excellent group of musicians dedicated to the performance of modern and contemporary music. The new 'Contemporary Cities' project aims to create partnership music projects between Limerick and Belfast.

On 15 and 16 November, the ensemble delivered workshops on contemporary music score reading, performance and composition, to students and teachers in Limerick School of Music. This project is funded under the Creative Ireland Creative Communities programme.

Castleconnell Autumn Concert Series (2024)

The Castleconnell Autumn Concert series takes place in All Saints Church in Castleconnell and is programmed by Limerick Arts Office, with financial support from the Arts Council and Creative Ireland. The concerts are presented in partnership with Love Castleconnell. The final 2024 concert took place on 26 November with Banbha String Quartet, under the National String Quartet Foundation. It was recorded for a future broadcast on RTE Lyric FM, The Full Score Programme with Liz Nolan.

Sing Cois Féile, Abbeyfeale

Plans to establish a community singing group in Abbeyfeale progressed in November, with the first 'taster' workshop on 26 November in St Ita's Community Hall under musician Fiona Walshe. Eighteen members of the Abbeyfeale community attended. This project is a long-term aim of Jim Dennison from Abbeyfeale and is being funded by the Creative Ireland Creative Communities Programme, and supported by West Limerick Resources and Limerick Arts Office.

Integration Supports

The Limerick Migrant Forum was established by Limerick City and County Council as part of the EU INTEgreat Project in partnership with Doras. The LAIT also continues to produce a weekly newsletter that is circulated to all accommodation centres in Limerick City and County. It informs residents on courses, employment and volunteering opportunities.

In mid-November the LAIT presented on its work to Limerick CYPSC (Children and Young Peoples Services Committee).

Regeneration, Sports and Recreation

1. Regeneration and Sports

Economic Regeneration

- The fourth Jobs Fair of the year was held in Southill Hub on 21 November. Over 20 employers, educational and training bodies had information stands and demonstration equipment available for members of the public to engage with. New employer representatives included Glanmore Foods and the Pharmacy Store. These events are key actions delivered under the Outreach to Employment Programme, aimed at assisting individuals to identify education and training opportunities suitable to their needs and assist employers to talk directly to potential employees.

Members of the Defence Forces were there to offer advice on how to enter the Defence Forces recruitment pathway. Staff from Southill Hub, Afterschool's and Tait House took the opportunity to raise awareness of vacant posts within their service areas.

- On the 6 November, staff from the Regeneration, Sports and Recreation Directorate, accompanied by representatives from Limerick Youth Service, visited TUS (Technical University of Shannon) Moylish Limerick Campus to learn more about the Access to Apprenticeship courses delivered on site. This programme supports young people (16–24-year-olds) from disadvantaged background transition to an apprenticeship scheme.
- A further visit took place to the Moyross Youth Academy to learn about the range of courses in place and to see the Limerick and Clare Education and Training Board (LCETB) campus delivering the Pathways to Construction Course.

- On the 13 November the Outreach to Employment Co-Ordinator visited the Probation and Linkage in Limerick Scheme (PALLS) building, located in Unit Two, Docklands Business Park. PALLS is an education and training centre which provides a supportive space for people (23 years and over) who are involved with the Probation Service and the criminal justice system. It aims to assist individuals to make positive changes in their lives by establishing connections and access pathways to employment and training.
- Staff from Moyross Community Enterprise Centre, Limerick Youth Service and Limerick City and County Council visited the Opera Site on the 22 November to get a first-hand understanding of the scale of the project.

This collaboration has seen a growth in engagement by over 20% from traditional medical signposting. This will lead to greater engagement and a reduction in repeat visits to the primary care centres.

Customer Services

The Customer Services Team continued to support our customers and Public Representatives at first point of contact by answering queries via telephone, email, MyLimerick and social media. Case creation, payments processing and generally facilitating applications for all Council services also continued throughout the month.

The following figures highlight the activity within the Contact Centre throughout the month of November:

- Customer Services call centre answered 11,540 calls. This represents an average of 550 per day, with the number of calls reaching as high as 664. A total of 78% of calls were handled at first point of contact.
- A total of 4,127 emails processed through our Customer Services email platform.
- 3,588 cases were created on Dynamics CRM, with 953 of these logged on behalf of Public Representatives. 3,439 cases were closed, with 836 of these being cases logged by Public Representatives.

- Of the 3,588 cases created, 66% were logged by the Customer Services team.
- The logging of cases through the MyLimerick portal continued, with a total of 356 cases being logged. Of these, 341 were submitted by Public Representatives.
- Customer Services continued to support the Housing Maintenance Department in creating service requests, and throughout the month, 97% of Housing Maintenance cases for the Limerick Metropolitan area were logged by Customer Services staff in the Dooradoyle and Merchants Quay offices.
- A total of 127 out of hours cases being created.
- Customer Services continued to provide other frontline services to the general public, such as processing applications for Residential Parking Permits, of which 95 were applied for and 71 issued.
- Customer Services staff welcomed a total of 2,282 customers at our Merchants Quay and Dooradoyle offices.

- Launched a five-week, multi-media campaign for 'Christmas in Limerick 2024', across social media, digital, TV, radio and print media channels.

- Produced a comprehensive Christmas in Limerick event guide, in digital print.
- Print flyers and table top tent card, complete with a QR code directing individuals to limerick.ie/Christmas were distributed to businesses throughout the city and county.
- Christmas in Limerick flags were created and erected on the bridges throughout the city.
