

**MINUTES OF PROCEEDINGS AT SPECIAL MEETING OF LIMERICK CITY AND COUNTY COUNCIL HELD IN THE COUNCIL CHAMBER, DOORADOYLE, AND ONLINE, ON THURSDAY, 19<sup>TH</sup> DECEMBER, 2024, AT 9.30AM.**

**1. Filling of Casual Vacancy by Co-option**

Circulated, report of the Senior Executive Officer, Corporate Services, Governance and Customer Services, dated 13<sup>th</sup> December, 2024.

Proposed by Councillor Leddin;

"That, Mr. Pdraigh Reale, Garryowen, Limerick, be co-opted to the Council to fill the casual vacancy consequent on the election of Councillor Conor Sheehan to Dáil Éireann."

As there were no other nominations, the Príomh Chomhairleoir declared Mr. Padraigh Reale co-opted as a Member of the Council for the Metropolitan District of Limerick and welcomed him as a Member of the Council.

Councillor Reale then took his seat in the Chamber.

The Príomh Chomhairleoir congratulated Councillor Reale on his co-option and wished him well in his role as an Elected Member for Limerick City and County Council. The Members congratulated and welcomed Councillor Reale, wishing him well in his new role and noted they looked forward to working with him during the term of this Council. Tributes were also paid to Deputy Sheehan on his election to Dáil Éireann and Members acknowledged all that he had achieved during his term as a Councillor.

The Director General, on behalf of the Management and Staff, joined in congratulating Councillor Reale and looked forward to working with him. He also congratulated Deputy Sheehan on his election to Dáil Éireann and wished him all the best.

Councillor Reale addressed the Meeting and thanked the Mayor, Príomh Chomhairleoir, Elected Members and Director General for their warm welcome. Councillor Reale congratulated his colleague Deputy Conor Sheehan and thanked him for the encouragement to take up this role, and outlined he hoped to carry out his functions in the same professional manner as Deputy Sheehan did. Councillor Reale acknowledged and thanked Councillor Leddin for proposing his co-option and Councillor Secas for seconding the nomination. Councillor Reale thanked his family for their unwavering support and looked forward to working and building new relationships with both the Elected Members and Staff for the betterment of Limerick.
