The Report of the Independent Investigation by retired Chief Justice Mr Frank Clarke into the tragic death of Aoife Johnston at University Hospital Limerick (UHL) in December 2022 was published on the 20th September 2024.

On foot of this report, the Health Information and Quality Authority (HIQA) has been asked to lead a review into urgent and emergency care capacity in the Midwest region, including to determine whether a second Emergency Department is required. HIQA published terms of reference for the review in August. An interim briefing is expected in February 2025 with a final report expected in Summer 2025. The final report will be published on HIQA's website.

I would like to begin by apologising for the delay in the response. The Department has received a large volume of correspondence over the past months, so I have not been able to respond as quickly as I would like to.

Thank you for your correspondence dated 28th May regarding emergency funding on roads due to ongoing bad weather across Limerick City and County.

The improvement and maintenance of regional and local roads is the statutory responsibility of each local authority in accordance with the provisions of Section 13 of the Roads Act 1993. Works on those roads are funded from local authorities' own resources and are supplemented by State Road grants. The initial selection and prioritisation of works to be funded is a matter for the Council.

Within the budget available for the regional and local road grant programme, the objective is to allocate funding to eligible local authorities on as equitable a basis as possible taking the length of the road network into account. The main focus of the grants continues to be the protection and renewal of the regional and local road network.

The 2024 regional and local road grants were notified to local authorities in February this year and Limerick City and County Council received an allocation of over €38 million for the maintenance and improvement of their regional and local roads network; this represents an increase of over €3.5m compared to their 2023 allocation. On 31st May 2024, I announced additional funding of €30 million to local authorities through Restoration Improvement (RI) Grants following persistent rainfall over winter and spring. Limerick City and County Council has been allocated €1,275,000 under this supplementary allocation.

It should be noted that Exchequer funding for regional and local roads is intended to supplement realistic contributions from local authorities' own resources. As the statutory road authorities for their area, it is open to local authorities to prioritise investment on regional and local roads.

In line with established practice, the Department emphasises to local authorities each year the importance of setting aside a contingency fund to manage severe weather events, including flooding and cold weather.

All exchequer funding for the Regional and Local Road programme for 2024 has been allocated at this time; however, each Council can liaise directly their assigned Departmental Engineer Inspector to discuss any unforeseen road deterioration in their region. The Department is fully committed to working with local authorities and helping them reprioritise work programmes as needed in order to retain a safe road network for all.

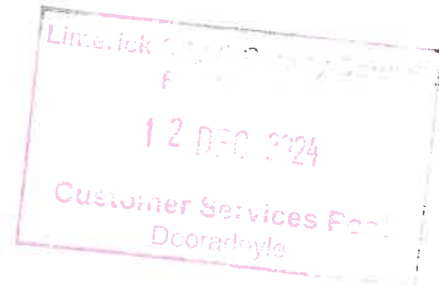

Thank you for your letter dated 27th November 2024 to the Minister for Rural and Community Development, Heather Humphreys, regarding the resolution adopted at a meeting on 25th November of Limerick City and County Council.

The Local Improvement Scheme (LIS) supports the improvement of non-public rural roads and laneways not usually maintained by local authorities. The Scheme is covered in legislation by the Local Government Act 2001, Section 81 part (3), which provides that;

(3) A road authority may assist by way of the carrying out of works, a financial contribution or otherwise towards the construction or improvement of a non-public road which —

(a) Provides access to parcels of land of which at least two are owned or occupied by different persons or

(b) Provides access for harvesting purposes (including turf or seaweed) for two or more persons or

(c) Shall, in the opinion of the road authority, be used by the public

The 2024 Scheme criteria were amended to ensure more families can now qualify for the Scheme. Eligible road projects are those that involve the construction or improvement of non-public roads which provide access:

1. to parcels of land, of which two or more are owned or occupied by different persons, one of which must be engaged in agricultural activities or
2. for harvesting purposes (including turf or seaweed) for two or more persons or
3. to at least one parcel of land owned or occupied by a person engaged in agricultural activities AND which separately provides access for harvesting purposes (including turf or seaweed) for at least one other person.


In addition, work can be carried out on Amenity Roads, which are non-public roads leading to essential community amenities such as graveyards, beaches, piers, mountain access points, or other tourist/heritage sites.

In April 2024, an amendment to the Scheme was announced which now stipulates that only one landowner must be involved in agricultural activity – however, the road should still provide access to two or more landowners/occupiers. As the Scheme is bound by legislation, local authorities must seek proof of ownership/occupation of land from at least two landowners/occupiers. Proof of agricultural activity is not solely limited to a herd/flock number - it can also refer to the practice of herding cattle, sheep, pigs, horses or poultry in a non-large scale commercial practice and can also include harvesting activity such as peat, seaweed, timber, fruit, vegetables or flowers - again in a non-large commercial scale.

While the Department of Rural and Community Development provides funding, local authorities administer the scheme and are solely responsible for selecting and prioritising eligible road projects. The Department recommends that parcels of land should be at least one hectare in size - however, this is a recommendation only, and local authorities have flexibility in this regard.
