

**MINUTES OF PROCEEDINGS AT ANNUAL MEETING OF LIMERICK CITY AND COUNTY COUNCIL
HELD IN THE COUNCIL CHAMBER, DOORADOYLE, AND ONLINE, ON FRIDAY, 21ST JUNE, 2024, AT
3.00 P.M.**

2. ELECTION OF PRÍOMH CHOMHAIRLEOIR:

Mayor Moran invited nominations for the Office of Príomh Chomhairleoir of Limerick City and County Council for the coming year.

Proposed by Councillor Sheahan (J);
Seconded by Councillor Collins (M);

“That, Councillor Dan McSweeney be appointed Príomh Chomhairleoir of Limerick City and County Council to hold office until the next Annual Meeting or until a successor has been elected.”

As there were no other nominations, Mayor Moran declared Councillor Dan McSweeney elected as Príomh Chomhairleoir and congratulated him on his election.

3. ELECTION OF LEAS-PHRÍOMH CHOMHAIRLEOIR:

Having taken the Chair, the Príomh Chomhairleoir invited nominations for the Office of Leas-Phríomh Chomhairleoir of Limerick City and County Council for the coming year.

“That, Councillor Noreen Stokes be appointed Leas-Phríomh Chomhairleoir of Limerick City and County Council to hold office until the next Annual Meeting or until a successor has been elected.”

As there were no other nominations, the Príomh Chomhairleoir declared Councillor Noreen Stokes elected as Leas-Phríomh Chomhairleoir and congratulated her on her election.

10. LIBRARY ASSOCIATION OF IRELAND:

The Meetings Administrator stated that Limerick City and County Council was required to consider the appointment of 1 Member to the Library Association of Ireland.

11. IPB INSURANCE CLG

13. GOVERNING AUTHORITY OF THE UNIVERSITY OF LIMERICK:

The Meetings Administrator advised that these appointments were now covered by legislation with the Minister making the appointments. Consequently, the Council was no longer required to fill these positions.

14. WEST LIMERICK RESOURCES CLG:

Circulated, correspondence from the Manager, West Limerick Resources, inviting Limerick City and County Council to nominate 4 representatives to the Board of West Limerick Resources CLG.

“That, Councillors Doyle, Sheahan (J), Stokes, O’Hanlon, Slattery, Teehy and Donoghue be appointed as the Council’s representatives on the Limerick and Clare Education and Training Board.”

As there were no other nominations, the Príomh Chomhairleoir declared Councillors Doyle, Sheahan (J), Stokes, O’Hanlon, Slattery, Teehy and Donoghue appointed as the Council’s representatives on the Limerick and Clare Education and Training Board.

27. AUDIT AND RISK COMMITTEE:

The Meetings Administrator advised that the Council was required to consider the nomination of 3 Members of Limerick City and County Council to the Audit and Risk Committee.

28. LOCAL COMMUNITY DEVELOPMENT COMMITTEE:

The Meetings Administrator advised that the Council was required to consider the nomination of 4 Members of Limerick City and County Council to the Local Community Development Committee.

“That, Councillors Conway, Keary, Pond and Carey be appointed to the Local Community Development Committee.”

As there were no other nominations, the Príomh Chomhairleoir declared Councillors Conway, Keary, Pond and Carey appointed to the Local Community Development Committee.

29. RURAL WATER MONITORING COMMITTEE:

The Meetings Administrator stated that the Council was required to consider the nomination of 3 Members of Limerick City and County Council to the Rural Water Monitoring Committee.

33. LECP STEERING GROUP:

The Meetings Administrator advised that the Council was required to consider the nomination of 2 Members (Chair of Economic Development, Enterprise and Planning SPC, together with one Member) to the LECP (Local Economic and Community Plan) Steering Group.

Proposed by Councillor Sheahan (J);

Seconded by Councillor Collins (M);

“That, Councillor Doyle, Chair-Designate of the Economic Development, Enterprise and Planning SPC be appointed to the LECP (Local Economic and Community Plan) Steering Group.”

As there were no other nominations, the Príomh Chomhairleoir declared Councillor Doyle, Chair-Designate, Economic Development, Enterprise and Planning SPC, appointed to the LECP Steering Group.

The appointment of the second nominee was deferred to the July Meeting.

The Príomh Chomhairleoir congratulated Mayor Moran on his election as Mayor of Limerick and Councillor Stokes on her election as Leas-Phríomh Chomhairleoir. He paid tribute to the outgoing Mayor, Gerald Mitchell, on his achievements over the last 12 months. He congratulated his fellow Councillors on their re-election to the Council and welcomed the 10 new Councillors to the Chamber and wished them every success and happiness in their new roles. He said he looked forward to working with Mayor Moran and all Members over the next five years for the betterment of Limerick.

All Members associated with the Príomh Chomhairleoir's comments. Councillors O'Donovan, Leddin, Benson, Teefy and O'Donoghue J spoke on behalf of their respective parties and assured Mayor Moran of their full support.

The Director General wished Mayor Moran, the Príomh Chomhairleoir, Leas-Phríomh Chomhairleoir and all Members the very best of luck and said he looked forward to working with them in the future.
