As discussed, we won't be able to make that meeting unfortunately due to clashing commitments.

There was a stakeholder information event held in the Limerick Strand Hotel on 20 February where updates were provided to interested parties on the Foynes Line project as well as other rail proposals in the Limerick area.

I was unable to attend but the Irish Rail Chief executive was there, as well as the management team from the Foynes Line project. I presume the Councillors were invited.

In summary the project is progressing well and we are nearing completion on the installation of new trackwork along the whole corridor.

The next phase of work will involve fitting out public road level crossings and installing the signalling system along the route. This will run throughout 2025 and into 2026 with a target date for the line in October 2026.

We are grateful for the support received to date from the elected representatives in the Adare Rathkeale district.
