March 2025 Council Meeting

- Correspondence received on 11th February, 2025, from the Meetings Administrator, Sligo County Council, outlining resolutions adopted by the Council as follows:
 - (i) calling on the Government not to implement the proposed VAT increase on electricity costs.
 - (ii) calling on the Government to abolish any plans to introduce further Carbon Taxes.
 - (iii) calling for the re-instatement of the Tenant-in-Situ Scheme.
 - (iv) calling for the implementation of an Eviction Ban in cases where tenants are abiding by the letting contract.
 - (v) calling for a fixed penalty fine of €10,000 for retailers or persons selling or providing children under 18 with e-liquids, vape kits or nicotine-containing products.
- Letter received on 13th February, 2025, from the Meetings Administrator, South Dublin County Council, outlining resolution adopted by the Council supporting calls for a Fossil Fuel Non-Proliferation Treaty.
- Email received on 14th February, 2025, from Chief Superintendent Derek Smart, Henry Street Garda Station, in reply to resolution adopted by the Council “to write to the Chief Superintendent of Limerick Garda Síochána, considering the absence of an ISPCA Inspector in Limerick, to urge the creation of a dedicated Garda Animal Welfare Unit in Limerick to combat the rising incidents of animal cruelty and to further address seizure processes related to the impending ban on XL Bully dogs.”
- Letter received on 14th February, 2025, from the Office of the Taoiseach in reply to resolution adopted by the Council “requesting an extension until June for the State-sponsored Ukrainian accommodation in Limerick and for those with pets to be accommodated in temporary accommodation as required.”
- Letter received on 14th February, 2025, from the Office of the Taoiseach in reply to resolution adopted by the Council “(a) calling on Uisce Éireann to install generators at every pumping station in the country; (b) calling on the ESB to cut back/cut down on trees and/or branches in danger of damaging infrastructure and (c) calling on the Government to set up a special emergency phone no. to be activated prior to and manned during all Orange and Red weather alerts.”

- Correspondence received on 18th February, 2025, from the Meetings Administrator, Roscommon County Council, outlining resolutions adopted by the Council as follows:
 - (i) calling for an incentive for landowners to move trees off the roadside.
 - (ii) calling for all emergency frontline services to be allowed to use any network available during major emergency events.

I wish to acknowledge receipt of your correspondence dated 7th February 2025 and note the resolution that was adopted at the January meeting of Limerick City and County Council.

I am to confirm that the Department for Agriculture, Food and the Marine have primary responsibility for the welfare of all animals. I reference Minister McConalogue's Dáil response to Deputy Willie O Dea on 20th September 2023, (Question 787) in which he stated *'Since the introduction of the Act over 1000 department officials have been designated as authorised officers. A large number of these authorised officers are based in my Departments network of Regional Veterinary Offices throughout the country, including the Regional Veterinary Office in Limerick.'*

I would also draw your attention to Sec 37 of the Animal Health and Welfare Act 2013 and in particular section 37(2) which states;

(2) The manager of a local authority for the purposes of enforcing this Act in the functional area of the with *subsection (6)(b)*, may, appoint in writing, such officers of the authority as he or she considers appropriate for the exercise of all or any of the functions conferred on an authorised officer under this Act in the functional area of the authority in accordance with *subsection (6)(b)*, specified in the appointment.

While members of An Garda Síochána are authorised under the act, we are not the primary agency charged with this function and implementation. Due to the limited resources at my disposal I cannot and will not be creating a dedicated Garda Animal Welfare Unit. I can however assure Council members that where An Garda Síochána become aware of cruelty and neglect cases in the course of their duties, these matters are pursued vigorously through the courts. Our commitment to this area is further underlined by our collaborative working partnership with the National Parks & Wildlife Service (NPWS) focusing on a number of recent complaints received in respect to animal welfare matters.

At a recent Plenary Meeting of Roscommon County Council, the following motion was agreed by the Members:

In light of over 40 trees falling during Storm Darragh, damaging power lines and leaving homes and businesses without power for days, I propose this Council writes to Nicholas Tarrant, MD of ESB Networks, and Keith Leonard, Head of the National Emergency Coordination Group. They should ensure compliance with wayleaves and exclusion zones near overhead powerlines, requiring forestry owners to meet clearance standards. ESB Networks should take pre-emptive measures ahead of storms to prevent similar outages. Additionally, compliance with the DAFM Standards for Felling & Restoration near public roads must be enforced to prevent road safety hazards during extreme weather.

Subsequent to the submission of this motion the events of Storm Éowyn have further highlighted to need for action on this matter.

I have been asked by Mr. James Browne T.D., Minister for Housing, Local Government and Heritage, to thank you for your letter dated 5 February 2025, in connection with the Housing Adaptation Grants for Older People and Disabled People scheme, in respect of private houses. The suite of grants, which include the Housing Adaptation Grant for Disabled People, the Mobility Aids Grant and the Housing Aid for Older People Grant, are funded by the Department with a contribution from the local authority.

The Housing Aid for Older People Grant scheme provides grants of up to €10,700 to assist older people living in poor housing conditions to have necessary repairs or improvements carried out. Qualifying works include structural repairs or improvements, upgrading unsafe electrical wiring, drylining, repair or replacement of windows and doors and the repair or provision of central heating (where no central heating exists or the existing system is broken or beyond repair).

Households which are reliant on a fossil fuelled back boiler system can avail of the Housing Aid for Older People Grant if an Occupational Therapist states that the applicant is unable to manage the existing system. In such cases the local authority can provide grant funding for a more suitable central heating solution which would not require a high level of physical input from the applicant. For applications approved on or after 1 January 2025, grant funding cannot be provided for the purchase of a new standalone fossil fuel boiler (Article 17(15) of Directive (EU) 2024/1275 of the European Parliament and of the Council of 24 April 2024).

Any applications for grant funding in respect of the purchase of a new fossil fuel boiler (oil or gas), which were received and approved by a local authority prior to 1 January 2025 can still be paid to applicants after 1 January 2025. The grant scheme continues to be available for applications approved after 1 January 2025 in respect of costs relating to the repair of an existing fossil fuel boiler by a qualified contractor (oil or gas) or the purchase and installation of a second hand fossil fuel boiler by a qualified contractor (oil or gas).

Notwithstanding the above, grants may continue to be paid after 1 January 2025 in respect of the repair or replacement of all other parts of a central heating system such as new radiators, oil tanks or pipework, regardless of connection to an existing fossil fuel boiler (oil or gas). Grants may also continue to be paid in respect of electric or biomass heating solutions e.g. wall mounted electric heaters or wood pellet stoves etc.,

where either are deemed to be a suitable option in line with applicant's circumstances. The detailed administration of the schemes is the responsibility of the local authorities, therefore the qualifying works is a matter for consideration and decision on a case-by-case basis by the local authority within the scope of the grant scheme.

Grant funding for insulation works or the installation of heat pumps or air to water heating solutions are more appropriate to the schemes available from the Sustainable Energy Authority of Ireland (SEAI). An applicant seeking funding specifically for a heat pump would normally be referred by local authorities to the SEAI to check if funding is available. However, if the SEAI assesses the application and determines that a heat pump is not suitable given the condition of the house, then it is unlikely to be considered under the Housing Aid for Older People Grant scheme.

I trust this information will be of assistance to you.

I am writing to you today regarding your correspondence on behalf of the Members of Limerick Council, regarding provision of generators.

Your Uisce Éireann reference number for same was 31778.

I am pleased to advise that my colleagues in our Communications Team at Uisce Éireann have reviewed your query and the following response has become available:

Uisce Éireann met with Minister Browne and provided a comprehensive update on the extensive efforts of our staff to manage the impact of Storm Éowyn on communities throughout Ireland. Uisce Éireann did so both as part of the National Emergency Co-ordination Group where we agreed and aligned our response with partners at national level, and through our own incident management and response processes and structures.

Working in this manner, Uisce Éireann focussed on minimising customer impact and protecting public health to the greatest extent possible. Through pre-emptive deployment of backup generators, the supply to c.146,000 premises (395,000 customers) was maintained with onsite generation. While the storm did cause disruption to water supplies for some homes and communities, Uisce Éireann was able to restore services for the majority of homes and businesses within a short period of time.

Uisce Éireann informed the Minister that post incident reviews are now underway to examine a range of areas where there can be greater preparedness in the future. As part of this review, Uisce Éireann has committed to procuring additional generators, will accelerate its programme to ensure that at-risk plants and other assets (e.g. pumping stations) are generator-ready and will also examine other options for alternative power solutions.

We will also continue to work with all the relevant Government and state agencies to ensure the appropriate levels of readiness for extreme weather events. Uisce Éireann appreciates the support of Minister Browne regarding our response to Storm Éowyn and looks forward to working with him and his team as we prepare for future weather-related events

Thank you for your recent correspondence on behalf of Limerick City and County Council.

Local authorities are designated as the lead agencies for coordinating a response to flooding and severe weather emergencies.

All local authorities have an established Severe Weather Assessment Team in place, monitoring Met Éireann weather warnings, High Tide Advisories and European Flood Awareness System (EFAS) advisory warnings. Local authorities also have Severe Weather/ Flood Plans in place to support the response to weather emergencies.

My Department undertakes the Lead Government Department role, as set out in the Strategic Emergency Management (SEM) Framework (2017), in relation to the coordination of national level responses to severe weather and flooding emergencies, where warranted. The Department's National Directorate for Fire and Emergency Management undertakes this role and works closely with local authority Severe Weather Assessment Teams and Met Éireann.

Since 2009, my Department has made financial support of over €100 million available to assist local authorities in meeting the unbudgeted costs of clean-up and necessary immediate works, including for exceptional overtime payments, the hire of plant and heavy machinery, the purchase of materials required for the clean-up and the hire of contractors associated with significant severe weather emergency events.

This is in recognition of the exceptional nature of the activities carried out by local authorities in responding to these types of emergencies and the fact that the costs of these un-programmed activities could not be foreseen in annual expenditure planning. This practice is considered a vital enabler of the local authority action, providing the assurance that availability of resources is not a limiting factor in providing a very effective local response.

In the context of Storm Éowyn and the exceptional nature of the response activities carried out by local authorities, clearly the costs of these activities were not budgeted for within existing resources. As always, my Department, in consultation with the Department of Public Expenditure, Infrastructure, Public Service Reform and Digitalisation, will

work with local authorities to support them over the coming months, as they co-ordinate recovery and restoration works.

It should be noted that funding of repair of public infrastructure is undertaken by the relevant Department in line with its sectoral responsibility. Capital costs associated with infrastructural damage, for example damage to the roads network and coastal protection infrastructure (where relevant), are funded under relevant sectoral arrangements.

RE: Proposal for consideration regarding chimney removals in local authority housing and measures to increase the use of wood fueled appliances in domestic homes

Dear Elected Representative,

The recent weather damage has highlighted the risk of Irish homes becoming over reliant on electricity for all energy needs. Many residents experienced power outages extending beyond a week, leaving them with no way to heat their homes.

There are of course simple and cost-effective ways to address lack of heating during power outages, the traditional method has been with open fires, while the modern option is to use efficient solid fuel stoves. Modern stoves are regulated under the Ecodesign directive to be efficient and clean burning, when coupled with renewable fuel such as firewood can also reduce greenhouse gas emissions. Stoves work in any home, regardless of age and level of insulation. To those ends, the Irish Bioenergy Association (IrBEA) has been working with our members for over two decades to provide quality woodfuels, while also advocating for the use of modern wood burning stoves. The combination of quality woodfuel and modern woodfuel stoves has been conclusively shown to provide cost-effective, clean combustion and to decarbonise domestic heating demand.

IrBEA wishes to highlight two related matters for your attention and consideration.

1. At the moment, when upgrading housing stock, many local authorities are permanently removing chimneys and completely electrifying heating systems. IrBEA notes the recent motion passed by representatives of Kerry County Council which calls for the council to cease removing chimneys from their housing stock. IrBEA encourages you to consider a similar motion in your county.

IrBEA and its members suggest that all Local Authorities should consider updating housing stock by replacing all open fires with Ecodesign wood burning stoves and boilers. These work at far higher efficiencies than open fires and will reduce fuel demand by as much as two thirds and eliminate carbon emissions. These stoves are efficient, simple to operate, and provide a higher level of heat for a given quantity of wood fuel.

2. Policy from the last government has been to encourage widespread deployment of electrified heating and actively discourage heating by solid fuels, this has led to a general perception that planning consent is difficult to achieve where a home builder wishes to incorporate a chimney or flue. IrBEA requests that all Local Authorities clarify that chimneys and flues are acceptable in new houses as long as they comply with building regulations. This action will encourage the adoption of a wider range of resilient and renewable heating systems for homeowners including woodfuel appliances.

All Ecodesign stoves sold in Ireland since 2022 must comply with the current Ecodesign (2015/1189) Regulation. This regulation sets requirements for clean combustion to greatly reduce emissions. Ecodesign stoves are 75% efficient (compared to open fires at approximately 25%) and reduce particulate emissions (smoke) by up to 90%, and relatively cheap to install and operate. Ecodesign wood stoves also displace carbon emissions from combustion of fossil fuels such as coal, oil and gas.

All solid fuels sold in Ireland must be compliant with the Solid Fuel Regulations 2022 to prevent the sale of smoky fuels such as bituminous coal and wet firewood. Local Authority enforcement officers are tasked with enforcing the regulations. Using low smoke fuels is critical to protect air quality. Firewood must be sufficiently dry to ensure clean and efficient combustion.

The Irish Bioenergy Association (IrBEA) is the representative body for the bioenergy industry in Ireland has membership spread across biomass, biogas, biofuels, biochar, energy crops and wood fuels. Further details can be found at www.irbea.org. The association administers the Wood Fuel Quality Assurance (WFQA) scheme. The WFQA certifies wood and biomass fuels supplied by over 100 suppliers around the country. Our organisation works with the EPA, Local Authority enforcement officers and fuel suppliers to assist in compliance with the Solid Fuel Regulations.
