


Executive Report

The month's highlight was Mayor John Moran hosting his first Mayor's Charity Dinner on 02 May at the Limerick Strand Hotel. Over 400 guests attended the ball with The Marie Keating Foundation the chosen charity partner for the event. Guests on the night included members of various charity groups from across Limerick, civic leaders and the Lord Mayors of Belfast and Cork.

Limerick's international engagement continued with the hosting of diplomatic representatives, including the Ambassadors of Finland and Barbados, alongside productive meetings with a delegation from Chengdu, China. These meetings highlight Limerick's growing reputation as an attractive destination for international cooperation and investment.

On the national stage, the Mayor was honoured to deliver speeches at significant commemorative events, including the National Commemoration of the Great Famine in Kilmallock and the wreath-laying ceremony for United Nations Peacekeepers' Day.

Infrastructure development remained a key priority for the Mayor this month, with the official opening of the Bloodmill Road extension representing further progress in the transportation network.

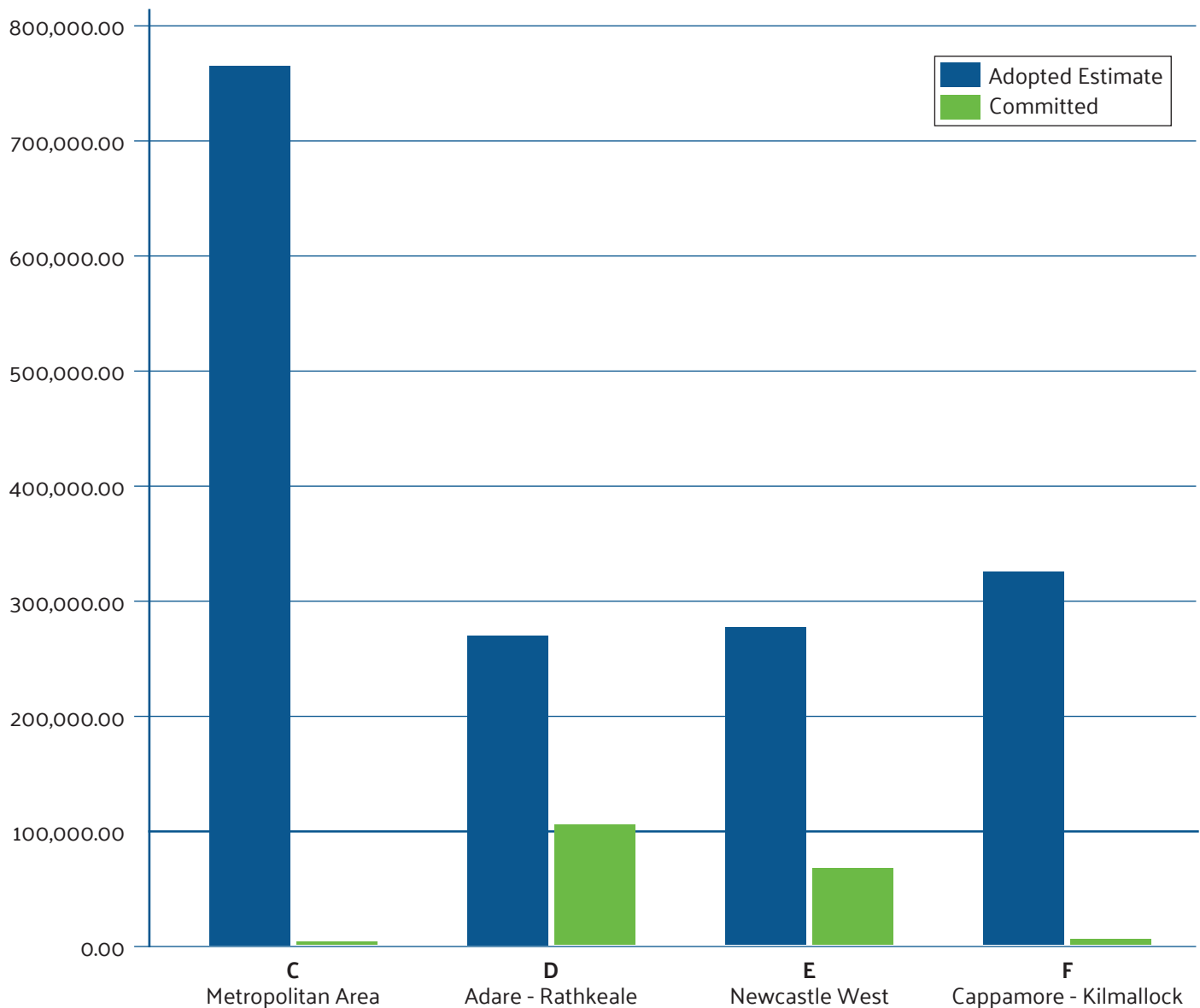

2. Trade and Investment

Asia Now – The New Dynamics of Global Business

Trade and Investment facilitated a significant business summit in Limerick, in partnership with the University of Limerick, on 15 and 16 May. The summit highlighted the current opportunity to deepen ties with Asia.

Ambassadors from Indonesia, Saudi Arabia, Pakistan, the United Arab Emirates, joined by colleagues from China, India, Japan and Singapore, spoke of the window now for bilateral trade and their commitment to grow investment and business partnerships with Limerick. The programme of events included meetings with a delegation from the Chengdu High Tech Zone.

Draft Small and Medium-sized Enterprise (SME) Action Plan for Limerick

Trade and Investment is working with the Mayor's Small and Medium-sized Enterprise (SME) Expert Group to deliver a new SME Action Plan for Limerick City and County. Its purpose is to provide a framework which would lead to a stronger business ecosystem, conducive to sustained commercial success by SMEs. As part of this process, 12 SME-specific focus groups were held between 20 May and 29 May to get the views of SME owners.

- Voza Skin Health/Laser Clinic and coffee hub opened on Henry Street.
- Babylon coffee shop and restaurant opened on Lower Glentworth Street across from the Glen Tavern.
- Turkmen Grill takeaway/sit-in food outlet opened a premises on 13 William Street, Limerick. It currently has a second takeaway on No. 2 Parnell Street, Limerick.
- A member of the Trade and Investment team attended Miconex's first ever Irish Town and City Gift Card Conference in Mullingar, Co. Westmeath, on 15 May.

- The Trade and Investment senior team attended the Retail Retreat 2025 Annual Conference hosted by Retail Excellence Ireland in Kilkenny on 27 May.

EU Projects

Two projects were successful in Phase 1 of the Interreg (North-West Europe) NWE funding application process and are now progressing to Phase 2:

- Tourism: SLOW TOUR - Unlocking Heritage Opportunities for Slow Tourism. This will assist Limerick City and County Council in developing Food Festivals in the city.
- Environment and Climate Action: URBAN - Understanding Recovery of Biodiversity and Animal Network. Participating in this project will assist Limerick City and County Council in meeting the objectives of the Climate Action and Biodiversity Plan.

Night Time Economy (NTE)

In May, the Night Time Economy officially launched the first instalment of Twilight Thursday, bringing together 35 different events and offerings across the City on 29 May. Partners - Live 95, Spin Southwest and The Limerick Post - covered the event, as well as some national press in the form of The Irish Examiner. Uber and FreeNow provided 40% off taxis; the Night Time Economy advisor continues to explore opportunities with new travel partners to make Limerick City more accessible for people to come from other counties.

3. Digital Services

Digital Services and Marketing and Communications successfully launched a refreshed version of the award-winning website www.limerick.ie, delivering a more modern and user-friendly design. Significant updates were made to the homepage of the Council section at www.limerick.ie/council, aimed at improving user navigation and access to key services. Enhancements include a redesigned layout for easier exploration of Council services and local offerings, improved search functionality for specific services or information, and the addition of tabs that highlight the most frequently searched items. These improvements reflect the team's commitment to providing a streamlined and accessible online experience for all users.

4. Local Enterprise Office (LEO) Limerick

- LEO Limerick ran seven Training programmes and Business Advice Clinics for Limerick-based businesses, which were attended by 87 business owners from across the City and County.

Local Enterprise Office Limerick approved:

- Three Digital for Business supports to help Limerick businesses incorporate digitalisation strategies into their business models.
- One Green for Business programme was provided to Limerick enterprises to assist them to map out their sustainability journey.
- 22 One-to-One mentoring sessions with LEO Limerick Business Consultants.
- The LEO Limerick Business Advisor Roadshow commenced on 27 May with the first clinic, which was fully subscribed and held at the Doon Social Farm.
- On 22 May, the National Enterprise Awards were held in the Round Room of Dublin's Mansion House, where 31 enterprises from each Local Authority area competed in this prestigious competition. Limerick

City and County was represented by Sarah O'Sullivan of SOS Cookies, based in the Milk Market. The LEO Limerick team was delighted to see SOS Cookies take home the Regional Award Winner for the Mid-West Region; a very deserving recognition of the amazing work being done by Sarah and the SOS Cookies team.

6. Innovate Limerick Designated Activity Company

Enterprise Infrastructure

- **Lease agreement signed** with Entara group to commence upgrades on existing sheds in The Old Bank, Abbeyfeale, to convert them into functional creative spaces.
- **Preparation of scope and funding strategy** for the Digital Accelerator Building progressed significantly during the month.
- **Tenant relationship management** was actively maintained throughout May across Engine, Engine Collaboration Centre, N21 Rathkeale Enterprise Centre, and The Old Bank Abbeyfeale as part of routine operations.
- **Building upkeep and maintenance** were proactively managed for all hubs, including interior cleaning, painting, and exterior cleaning to ensure facility standards.

This event served as a platform to connect angel investors with promising start-ups from various sectors, including ClimateTech, BioTech, and Green Technologies and many more.

Limerick Chamber and the Local Enterprise Office (LEO) Limerick co-hosted a significant event at the ENGINE Collaboration Centre. The event was organised by Limerick City and County Council in collaboration with Limerick Sports Partnership and Limerick Cycling Campaign. The cycle started at King John's Castle and followed the iconic Three Bridges route. Free bikes were provided for adults and children. Following the cycle, everyone returned to Nicholas Street and enjoyed an ice-cream.
- On 17 May, bike maintenance clinics were held at the Parkway Shopping Centre and at Castletroy Town Centre. A bike mechanic was in attendance and carried out free bike checks and fixes for people of all ages.
- Schools around Limerick had the opportunity to apply for funding support to run bicycle-related events throughout the city and county. A variety of events and promotions with staff and students were held, including cycle to school days, bike parades, cycle skills sessions, bling your bike competitions.
- A number of workplaces in Limerick got involved in Bike Week by holding cycling promotions.
- A number of inclusive cycle events were also held throughout the week with various groups from around Limerick.

Car Club Scheme

Procurement has commenced to secure the provision of a Car Club Scheme for Limerick City and Environs.

Sustainable Urban Mobility Planning (SUMP) Training

This month, members of the Team undertook a two-day training course on Sustainable Urban Mobility Planning.

Road Services Training Group/Department of Transport Conference

Members of the Team attended the annual Road Services Training Group/Department of Transport Conference in Mullingar, Co. Westmeath, and gave a presentation on the Coonagh/Knockalisheen Distributor Road.

Bloodmill Road Extension

The Bloodmill Road Extension was officially opened on 23 May, marking the completion of a major infrastructure project aimed at promoting sustainable transport options and enhancing connectivity for residents and visitors alike.

The scheme realigns the existing Bloodmill Road to connect with the newly developed Link Road to the east, significantly improving accessibility to the Educate Together Secondary School, the upcoming Bon Secours private hospital and Medical Diagnostics development, and the Lidl retail unit on the surrounding zoned lands.

The primary aim of the Bloodmill Road Extension Scheme is to encourage sustainable travel options by offering safer and more efficient infrastructure for vulnerable road users. With enhanced Active Travel measures, the project delivers high-quality pedestrian and cyclist facilities, designed to support a shift away from private car use towards walking, cycling, and public transport. As a critical element of the National Transport Authority BusConnects Project for Limerick City, the new extension ensures seamless integration with public transport routes, promoting environmentally friendly commuting solutions.

The completion of the Bloodmill Road Extension unlocks the development potential of the zoned lands to the east, supporting economic growth and improving transport options for both residents and businesses. The road's transformation from a rural link to a modern, accessible route exemplifies Limerick's dedication to building a sustainable urban environment.

Limerick Museum

- The exhibition '*Shaped by the Shannon*' explored how central the River Shannon was to Limerick's foundation and growth, from the early Viking settlement through Medieval Englishtown and Irishtown, to the city as we know it today.
- Using photographs, ephemera and artefacts from the Limerick Museum collection, it examined how Limerick profited from its position at the mouth of the mighty Shannon and evolved with the river, enjoying its bounty. Curated by Museum staff, '*Shaped by the Shannon*' formed part of the wider celebrations of Riverfest across Limerick city.
- On 08 May, an *Exhibition of Art Works* by Geraldine Sadlier and Brian McMahon opened. Limerick native, Geraldine Sadlier, was educated at the Salesian Convent, Fernbank, and graduated from the Limerick School of Art and Design. She has been living in Nice for the last 12 years and regularly returns to her native city Limerick. Her paintings and drawings have been exhibited in France and Ireland and can be viewed all year round in her gallery in Nice. Brian MacMahon is a well-known Limerick artist who studied at Limerick School of Art from 1973 to 1977. After moving to Dublin in 1979, he quickly developed a reputation as a portrait painter which led to a number of exhibition opportunities and solo shows. Brian moved back to Limerick in 1998. He has a studio in Limerick, lives near the city and takes every opportunity to explore new vistas around the country.
- On 13 May, an exhibition, *The Great Famine in Limerick*, opened in Kilmallock Library, Áras Mainchín Seoighe, Kilmallock. It was curated by the Museum Curator and examined the Great Famine in Limerick, one of the

most significant turning points in the history of both the city and the county. It used objects, images, books, and documents to tell the story of this most tragic period in our history. The exhibition formed part of the National Famine Commemoration 2025, a state event which Limerick City and County Council was honoured to host, and which was led by the Department of Arts, Media, Communications, Culture and Sport.

- On 20 May, the Opera in Limerick exhibition opened in the Museum. It was curated by Museum staff and Ger Reidy, Director of the Limerick Opera Festival, of which it formed part of. It featured objects from the permanent collection of Limerick Museum and items on loan from private collectors. They demonstrated the high quality of Limerick's musical life over the past two centuries and reminded us of some of the great venues that the city boasted such as the Theatre Royal on Mallow Street and the Savoy Theatre on Bedford Row. The exhibition showed how Limerick punched above its weight in the world's musical culture in the past 200 years.
- On 17 May, Limerick Museum collaborated with St. John's Brass and Reed Band in a commemorative event marking the Band's 160th anniversary. It featured a special anniversary exhibition and concert in Dance Limerick, at the historic Old St. John's Church, John's Square, tracing the Band's remarkable journey since its founding in 1865. The exhibition and concert were officially opened by Councillor Kieran O'Hanlon, Cathaoirleach of the Metropolitan District of Limerick.

- Turin's food policy lab effectively integrates stakeholders from government, private sector, and community organisations. Understanding their collaborative approach will inform how Limerick Food Partnership fosters multi-sectoral partnerships in Limerick.

National Older People's Council Convention, South Dublin

Comhairle na nÓg Steering Group Meeting

- Comhairle na nÓg consists of local councils for young people between the ages of 12-17, allowing young people to get involved in decision-making both locally and nationally. The Limerick Comhairle na nÓg Steering Group, chaired by the Age Friendly Programme Manager, met on 23 May. The group received a presentation from Alison McCarthy, National Activities Co-ordinator with the Alzheimer Society of Ireland. Alison gave the group a presentation on "Creating a Dementia Inclusive Generation - Youth Programme." Members of the Steering group include representatives from Limerick Youth Services, West Limerick Resources, Foróige, Limerick and Clare Education and Training Board and the Chairperson and Vice-Chairpersons from Limerick's Comhairle na nÓg committee.

Irish Physical Activity Research Collaboration

- On 28 May, the Age Friendly Limerick Programme Manager took part in a half-day workshop with the Irish Physical Activity Research Collaboration and Limerick Sports Partnership. The workshop aimed to learn how best to adapt and implement existing evidence-based physical activity programmes to improve their population reach and their effectiveness in the real-world setting. The target group selected for inclusion in the workshop was Older Adults, and the geographical location prioritised was the Northside of Limerick City.

University of Limerick Age Inclusive Symposium

- Limerick's Age Friendly Programme Manager was invited to a symposium hosted by one of its Age Friendly Alliance partners, the University of Limerick. 5. Tourism

Tourism General

Limerick City Walking Tour – ‘Explore Limerick: Stories, Streets and Heritage’

- Following an Expression of Interest process, on 27 May the Tourism Department appointed Limerick Civic Trust to provide a walking tour seven days a week in Limerick City from June to September.

Food Festival for Limerick

- On 02 May, the Tourism Department appointed Neon Agency as the successful tenderer in relation to the ‘Provision of Services for the Delivery of a Food Festival in Limerick in 2025.’
- A kick-off meeting was held between Limerick City and County Council and Neon Agency on 27 May, with planning for the festival underway.

Virtual Mapping of Limerick Greenway

- Global Virtual Asset Management Ltd. conducted a virtual reality mapping exercise of Limerick Greenway in May. The project is currently 70% complete.
- On 23 May, Limerick Greenway featured in Episode 3 of RTÉ’s popular travel series, Tracks and Trails. Host, Doireann Ní Ghlacáin, Broadcaster, Musician and Podcaster, was accompanied by former Munster and Ireland Rugby Player and frontman of Hermitage Green, Barry Murphy. The episode began with a cycle along the 40km Limerick Greenway, starting in Abbeyfeale and winding through Barnagh, Newcastle West and Ardagh, before reaching Rathkeale. Highlights of the journey included visits to the Desmond Castle Banqueting Hall and the site of the famous Ardagh Chalice discovery.

Limerick Greenway – Marketing and Social Media

- Limerick Greenway’s marketing campaign continued throughout May and included the following:
 - Limerick Greenway featured in the RTÉ One series, Tracks and Trails, and also in articles in the Irish Independent, RTÉ.ie, Leinster Express, Limerick Leader, Westmeath Examiner, RTÉ Guide and the Irish Daily Star.
 - Limerick Greenway also featured in The Kerryman, Weekly Observer, Live95, and Run Republic highlighting the Limerick Greenway Wellbeing Series.

- **Limerick Greenway Hubs and West Limerick Tourism Hub, Fullers Folly, Newcastle West: Interpretation Design Services** – On 30 May, the Tourism Department published a Request for Tender in relation to interpretation design services required at the Limerick Greenway trailhead sites. - **Children's Run for Fun and Great Limerick Run**

The Children's Run for Fun and Great Limerick Run took place on 03 and 04 May respectively, during the Riverfest weekend, and saw record-breaking numbers of 18,000 for the Great Limerick Run and over 2,000 for the Children's Run for Fun.

- **The Limerick Opera Festival**

The Limerick Opera Festival had a wonderful line-up of events on 03 May for the Riverfest Weekend. The festival brought Opera to the streets of Limerick with performances at Colbert Station, Hook & Ladder on Sarsfield Street, and on Lower Thomas Street. A particular treat was a special mini-Carmen concert at The People's Park Bandstand.

- **Fleadh By the Feale 2025**

The annual weekend-long event took place in Abbeyfeale from 01 – 05 May. Traditional entertainment was showcased in every corner of the town, including a Trad Disco, local Comhaltas Groups, Sliabh Luachra musicians and Polka, to name but a few. There was great traditional entertainment provided by young people from schools within the vicinity, as well as storytelling and different live performances in the Town Square.

- **Hear Say International Audio**

The annual festival attracts audio makers from all over the world to join their peers in the village of Kilfinane and be inspired by the beautiful surroundings. Now in its 11th year, the festival has become a hub for International Artists who work with film sound, audio features sound art or radio drama to explore the Co. Limerick countryside and share their experiences and stories as contributors to the festival, which this year ran from the 26 May to 02 June.

- **Maigue River Festival**

The Maigue Rivers Trust River Festival took place at Croom Town Park on 31 May. There was a lovely mix of events lined up for the day, including 'Life in the Maigue' where Geoff Hunt (Heritage in Schools) gave a talk about the food cycle of the river and had a display of a selection of aquatic invertebrates and fish. Other events included Folklore talks with Brian Collopy, Aquatic Insects with Colum Walsh of the Local Authority Waters Programme (LAWPRO) and fly-fishing workshops.

1. Regeneration, Sports and Recreation

Economic Regeneration

- Members of the Outreach to Employment Project Team collaborated with Limerick and Clare Education and Training Board in providing a work placement opportunity to one of the students in their Pathways to Construction Course. The programme is delivered in the Moyross Youth Academy, Moyross. The student started the five-week placement with Limerick City and County Council in May. The purpose of the placement is to provide on-the-job work experience. It has created a template for other students to follow.
- Evaluation and feedback from this year's Northside Regeneration Skills Fair took place throughout the month. Feedback was sought from the participants, including employers, training and education providers, service providers etc. Preparations are underway for the delivery of the Southside Skills Fair.

King's Island

Ballinacurra Weston

- The Community Companions Team at Our Lady of Lourdes Community Services Group (OLOL CSG) has introduced a new Zumba class in collaboration with the Limerick and Clare Education and Training Board. Held every Thursday evening in the community hall, the class has already proven popular and is fostering social connection through physical activity.
- The Ballinacurra Weston Community Law and Mediation Clinic, in collaboration with Limerick City and County Council, took place at OLOL CSG on 27 May.
- The Lunch Club continued to thrive with growing attendance each week. OLOL now provides transport to ensure that local seniors can travel safely to the Centre where the lunch event has evolved into a valued weekly social gathering.
- The Afterschool Service has successfully completed registration with Tusla. This milestone secures the continuation of the current service and allows for an extension of operating hours to better support families whose children attend.

- OLOL CSG Board of Management formally approved and endorsed the implementation of the BESTON Model. This is a programme funded under the Economic and Social Intervention Fund (ESIF). It is aimed at celebrating and promoting positive behaviours within the community in Weston. The model was presented by Maria O'Dwyer and has been adopted as the strategic framework for an integrated community response going forward.

Customer Services

The Customer Services Team continued to support customers and Public Representatives at first point of contact by answering queries via telephone, email, My Limerick and social media. Case creation, payments processing and generally facilitating applications for all Council services also continued throughout the month.

The following figures highlight the activity within the Contact Centre in May:

- Customer Services Call Centre answered 9,540 calls. This represents an average of 454 per day, with the number of calls reaching as high as 561 on one particular day. 81% of calls were handled at first point of contact.
- A total of 3,636 emails were processed through the Customer Services email platform.
- 2,369 cases were created, with 700 of these logged on behalf of Public Representatives. Customer Services staff logged 67% of the cases created.
- 3,160 cases were created, with 783 of these being cases logged by Public Representatives.
- The logging of cases through the MyLimerick portal continued, with a total of 95 cases being logged. Of these, 85 were submitted by Public Representatives.
- Customer Services continued to support the Housing Maintenance Department in creating service requests. 99% of housing maintenance cases for the Limerick Metropolitan District were logged by Customer Services staff in the Dooradoyle and Merchant's Quay offices.
- A total of 114 out-of-hours cases were created.
- Customer Services processed applications for Residential Parking Permits, 86 were applied for and 51 issued.
- Throughout May, Customer Services staff welcomed a total of 2,726 customers at both the Merchant's Quay and Dooradoyle offices.
