

**MINUTES OF PROCEEDINGS OF ANNUAL MEETING OF THE MUNICIPAL DISTRICT OF
CAPPAMORE-KILMALLOCK HELD IN ARÁS MAINCHÍN SEOIGE AND ON-LINE, ON TUESDAY

1. Welcome

The Cathaoirleach welcomed everyone to the meeting and thanked the Members for their support and hard work in the activities of the Municipal District during the previous 12 months. He noted that the Members had worked well together on behalf of the District and that this was key to delivering on the many objectives across the Municipal District.

He also thanked the management and staff of Limerick City & County Council for their engagement during the previous 12 months. In particular he acknowledged the work of the staff, both indoor and outdoor, working in the Municipal District and thanked them for their efforts during the past year. He outlined how working on behalf of the Municipal District had been an honour and privilege. He also wished to acknowledge his Leas Cathaoirleach, Cllr Conway, for his support and assistance during the year.

The Members congratulated Cllr Ryan on his year as Cathaoirleach, and acknowledged the fair and impartial manner he conducted meetings and discussions with the Members and staff.

2. To elect a Cathaoirleach of the Municipal District of Cappamore-Kilmallock to hold office until the next Annual Meeting or until a successor has been elected.

The outgoing Cathaoirleach, Councillor M Ryan invited nominations for the Office of Cathaoirleach for the coming year.

Proposed by Councillor O'Sullivan;
Seconded by Councillor N Stokes;

"That Councillor Greg Conway be appointed Cathaoirleach of the Municipal District of Cappamore-Kilmallock to hold office until the next Annual Meeting or until a successor has been appointed".

As there were no other nominations, the Elected Members declared Councillor Conway elected as Cathaoirleach of the Municipal District of Cappamore-Kilmallock.

Cllr Conway stated that it was an honour for both himself and his family to be elected as Cathaoirleach of the Municipal District. He thanked the outgoing Cathaoirleach for his guidance and assistance during his first year as a newly elected Councillor, which he said was a learning process for all new Councillors in particular.

He also thanked the management and staff of Limerick City & County Council for their help and assistance during the previous 12 months, and he looked forward to working with everyone as Cathaoirleach in the year ahead.

3. To elect a Leas-Cathaoirleach of the Municipal District of Cappamore-Kilmallock to hold office until the next Annual Meeting or until a successor has been elected.

The newly elected Cathaoirleach then invited nominations for the office of Leas-Cathaoirleach of the Municipal District of Cappamore-Kilmallock for the forthcoming year.

Proposed by Councillor Stokes:
Seconded by Councillor M. Ryan:

"That Councillor O'Sullivan be appointed Leas-Cathaoirleach of the Municipal District of Cappamore-Kilmallock to hold office until the next Annual Meeting or until a successor has been appointed".

As there were no other nominations, the Cathaoirleach declared Councillor O'Sullivan elected as Leas-Cathaoirleach of the Municipal District of Cappamore-Kilmallock and wished him well for the forthcoming year.

The Members congratulated the newly elected Cathaoirleach and Leas Cathaoirleach on their election and wished them well for the twelve months ahead. They agreed on the importance of all working constructively together in the Municipal District.

A suggestion was made by some Members that in the fifth year of the term, that consideration could be given to electing a Cathaoirleach outside of current political arrangements. However, some Members noted that the election of Cathaoirleach was based on the results of the 2024 Local Elections and that the current arrangement for nomination and election of positions would stand.

The Senior Executive Engineer, on behalf of management and staff, congratulated the Cathaoirleach and Leas Cathaoirleach on their election and wished them well for the year ahead.
