2. Description and Location of Property


The subject land measuring 0.0098 Acres (0.0040 Hectares) is located at Fairhill, Rathkeale, Co. Limerick. The land forms part of Limerick City and County Councils folio LK24751F.

3. History of Property

The area of land in question is registered to Limerick City and County Council. LCCC received a request from Mr Slattery's solicitors to dispose of this land to Mr. Slattery. Mr. Slattery has had possession of these lands for over 12 years and is now making an application to regularise title.

4. Executive Recommendation to Council.

The proposal before the Members is to note the proposed disposal of 0.0098 Acres (0.0040 Hectares) of land at Fairhill, Rathkeale to Mr. Roger Slattery for a consideration of €2,000. All legal costs incurred by Limerick City and County Council will be discharged by Mr. Roger Slattery.
