Dog Breeding Establishment Act 2010. Standard Conditions

- 1 The establishment shall be operated and managed in full compliance with the requirements of the Dog Breeding Establishments Act 2010 and the Dog
- 2 Breeding and Sales Records are to be maintained at all times.
- 3 Each hound on the premises shall be identified by means of tattoo and registered on your Hunt Club Register, or, alternatively implanted with a micro-chip.
- 4 Under the requirements of the Microchipping of Dogs Regulations 2015 (S.I. 63 of 2015) all dogs over 12 weeks of age are now required to be micro-chipped
- 5 All pups to be micro-chipped on or before 8 weeks of age or before leaving the premises
- 6 An adequate number of purpose built kennels, with impervious flooring shall be provided within 12 months of issue of certificate and by dd/mm/yyyy
- 7 Records relating to all retired breeding bitches & stud dogs to be maintained to include microchip number, disposal date & name/address of receiver

- Standard Condition 1: All DBEs
- Standard Condition 3: All Hunt Clubs
- Standard Condition 4: All DBEs (for information)
