## “Section 38”

Active Travel Limerick are planning to carry out proposed Section 38 works at **Hyde Road Park, (R-858), Limerick City.**

# Safe Routes to Schools

## “Patrickswell”

Active Travel Limerick Safe Routes to Schools has commenced works in **Patrickswell, (L-1442), Co. Limerick** the funding for this project is made up of funds from Active Travel and GMA (General Municipal Allocation).

The works will include the following road amendments adjacent to **Patrickswell National School**:

- A raised pedestrian crossing.
- Build outs for traffic calming purposes.
- Footpath widening.
- New bus bay.



# Safe Routes to Schools

## “Athea”

Active Travel Limerick Safe Routes to Schools are continuing works in **Athea (R-523)**.

The works will include the following road amendments adjacent to **Athea National School**:

- Introduction of chicanes/build-outs on eastern approach to village, as a traffic calming measure.
- Addition of one streetlight plus re-positioning of another one.
- Re-positioning of pedestrian crossing nearer to school gates.
- Reconfiguration of parking spaces outside cemetery.
- Re-positioning of bus bay and Accessible parking space at front of school.
- Introduction of ‘School Zone’ road markings and pencil bollards.



# Safe Routes to Schools

## “Murroe”

Active Travel Limerick Safe Routes to Schools are continuing works in **Murroe (R-506, L-1127 & L-1161)**.

The works will introduce the following road amendments adjacent to **Scoil Mhuire Murroe**:

- Enlarged build-out areas/footpaths adjacent to school gates. Introduction of formalised “Type C” raised pedestrian crossing adjacent to school.
- Introduction of two blue badge accessible parking spaces at front of school.
- Reconfiguration of traffic flow around island junction to a one-way system.
- Widened footpath on western approach to junction, with accessible bus stop and shelter.





# TUS Moylish to City Centre Scheme

The following works are anticipated to be carried out as part of the TUS Moylish to City Centre Scheme over the coming weeks:

- Continue the extension of existing footpaths from **Thomond Park** towards **Hassett's Cross**.
- Proceed with the installation of ducting and pods for new street lighting along the newly constructed footpaths.
- Ongoing pouring of new footpath sections in the direction of **Hassett's Cross**.
- Commence block laying for the construction of new boundary walls at both **Mayorstone Garda Station** and **Thomond Park**.
- Begin road opening works at the junction near **Mayorstone Garda Station**, followed by kerbing and concrete installation.

**Note: Two way traffic will be maintained, apart for very short intervals where plant & material will be going into the works area via the site access points, flagmen will be present during these operations.**



# Mill Road Scheme

The works at Mill Road is now substantially complete.

The following works will be taking place over the next few weeks:

- Continue snagging works throughout the scheme.
- Installation of “No Parking” signs along selected areas of the shared pedestrian/cycle track.





# Towns and Villages Schemes

Note: The Active Travel team are tasked with providing new and upgraded pedestrian infrastructure across Limerick City & County Council's Metropolitan and Municipal districts.

The following works at **Blackthorn Drive, Caherdavin** are completed which included footpath improvement and associated works.
