The proposed works involves the following road amendment on Convent St, Abbeyfeale, Co. Limerick. Proposed extension of the existing paid parking bye-laws from The entrance to the Secondary school 'Colaiste Ide & Iosef' to a point just beyond the commercial premises of 'Greyhound and Pet World'.

Road Authority Recommendation
