## AGENDA

1. To consider the Mayor's Draft Budget of Limerick City and County Council for year ending 31<sup>st</sup> December, 2026, and subject to the provisions of Section 103 of the Local Government Act, 2001, as amended by the Local Government Reform Act, 2014 and the Local Government Rates and Other Matters Act 2019 and Local Government (Mayor of Limerick) and Miscellaneous Provisions Act 2024 and to pass a resolution adopting the Draft Budget for 2026 with or without amendment.
2. Subject to Section 6 of the Local Government Rates and Other Matters Act 2019 as amended and Local Government (Mayor of Limerick) and Miscellaneous Provisions Act 2024 and in accordance with the Budget adopted, determine, the Annual Rate on Valuation (ARV) applicable in the calculation of the amount of the rate under Section 3 of the Local Government Rates and Other Matters Act 2019 as amended and Local Government (Mayor of Limerick) and Miscellaneous Provision Act 2024.

3. To consider the Capital Programme 2026 to 2030 in accordance with Section 135 (2) of the Local Government Act, 2001, as amended by the Local Government Reform Act, 2014 and Local Government (Mayor of Limerick) and Miscellaneous Provisions Act 2024.

4. That Limerick City and County Council makes a Scheme for the abatement of rates due to it by liable persons, or classes of liable persons, in respect of vacant properties in accordance with the provisions of Section 9 of the Local Government Rates and Other Matters Act 2019, as amended and Local Government (Mayor of Limerick) and Miscellaneous Provisions Act 2024. Such a scheme in respect of vacant property will provide for an abatement of 0% of rates due to Limerick City and County Council by a liable person for the financial year ending 31 December 2026.

5. To consider the adoption of the Vacant Property Refund Scheme 2026 to encourage the beneficial use of commercial property in accordance with Section 66 of the Local Government Act, 2001, as amended by Section 43 of the Local Government Reform Act, 2014 and Local Government (Mayor of Limerick) and Miscellaneous Provisions Act 2024.
