

Dear Ms Farrell,

I refer to your correspondence of August 7th to Mr James Browne, TD and Minister for Housing Local Government and Heritage regarding the resolution passed by Limerick City and County Council with regards to the revision of the Wind Energy Development Guidelines.

Firstly, I want to thank you and the elected members for your correspondence and raising the concerns contained therein.

The Department of Housing, Local Government and Heritage (DHLGH) is currently undertaking a focused review of the 2006 Wind Energy Development Guidelines. The review is addressing a number of key aspects of the Guidelines including noise, setback distance, shadow flicker, community obligation, community dividend and grid connections.

The Department, in conjunction with the Department of Climate, Energy and the Environment (DCEE), which has primary responsibility for environmental noise matters, has been working to advance guidance on the noise aspect of the Guidelines, which is highly technical in nature. The two Departments have been engaging on proposals regarding the measurement and assessment of noise from wind turbines to ensure they are robust and fit for purpose having regard to, inter alia, the revised 2030 target to generate up to 80% of our electricity from renewable sources.

Further to this engagement, DCEE, in the context of its environmental noise remit, appointed noise consultants in May 2023 to inform any amendments to the noise aspect of the Guidelines. This work is now substantially complete.

The Department, in conjunction with DCEE, will make any further changes to the draft Guidelines which are deemed necessary or appropriate in the wake of this work to ensure that the finalised Guidelines, once issued, are fit for purpose to provide guidance in line with renewable energy and climate targets, whilst having appropriate regard to the impacts of wind energy development, including in relation to noise annoyance.

The evolving policy and technical context including the new Planning and Development Act 2024 (the 2024 Act), and the recent revision of the National Planning Framework (NPF) reinforces the need to ensure that the finalised Guidelines, once issued, are fit for purpose.

In addition to this work, and in line with EU Directive requirements, a strategic environmental assessment (SEA) is being carried out on the draft Guidelines as part of the review process. In this regard, the Department intends to undertake a public consultation on updated draft Guidelines as part of the SEA process whereby all interested parties will have an opportunity to submit observations on the draft Guidelines. Finalised Guidelines will be prepared following detailed analysis and consideration of the submissions received during the consultation phase.

The Department notes the commitment in the recently published *Programme for Government 2025 – Securing Ireland's Future* to prioritise the publication of the Wind Energy Development Guidelines, having regard to international best practice and standards. In light of this commitment, the Department is working towards concluding the finalisation of review of the Guidelines as a matter of priority, having regard to the intended public consultation and the finalisation of associated reforms and reviews including the revision of the NPF.

When finalised, the revised Guidelines will be issued under section 28 of the Planning and Development Act 2000, as amended or, subject to commencement of the Planning and Development Act 2024, as a National Planning Statement, as appropriate. The current 2006 Wind Energy Development Guidelines remain in force, pending the finalisation of the review. The Department has no plans to place a moratorium on planning applications for wind energy developments pending the finalisation of the revised Guidelines.

As Chief Superintendent of the Limerick Division, I am committed to “Keeping People Safe” working in partnership with our communities and stakeholders to identify problem areas that require action and put in place asserted policing response to address these concerns.

The Limerick Division have a dedicated Divisional Drugs Unit which I can confirm are extremely active. I would encourage members of the public to report any drug related issues / suspicions to their local Garda Station or alternatively via the Garda Confidential Line at 1800 666 111 and this information will be actioned from my office.

With regards to the Drug Units in County Limerick being reestablished, this remains under constant review with members of my senior management team. The reestablishment of any specialised unit is dependent on additional Garda resources being allocated to the Limerick Division, and resourcing needs at that time between community engagement and crime functional areas.

I refer to your recent correspondence regarding the retirement age for school bus drivers.

The School Transport Scheme is a significant operation managed by Bus Éireann on behalf of the Department of Education and Youth.Â

TheÂ retirement age for school bus drivers has been set by Bus Éireann at 70 years of age, which also applies to all Bus Éireann road passenger services.Â

The policy and criteria also apply to drivers nominated by private operators who operate services as part of the School Transport Scheme, provided they hold the requisite license and satisfy an annual medical examination until they retire at age 70.Â

The Road Safety Authority, under the remit of the Department of Transport, committed to reviewing the upper age limit of drivers as it relates to larger vehicles/school buses.Â This review is now complete.Â


Under the new Programme for Government, a commitment has been made toÂ "Carry out an independent assessment on the feasibility of removing the exclusion of drivers aged over 70 from the School Transport Scheme".Â My Department continues to engage with both the Department of Transport and Bus Éireann to advance this commitment.Â

To address such persistent issue, a taskforce was established which is chaired by the Department of Transport.Â Â Â

The Department of Transport has advised that the aim of the taskforce is to work collaboratively to identify contributing factors to the recruitment issues and put forward recommendations and measures to create a pipeline of workers to address these issues.Â In line with the Department of Transport PfG commitment, this taskforce is currently examining all challenges and opportunities to ensure a fully resourced transport workforce, such as drivers, mechanics, and craftworkers. All factors impacting issues such as recruitment, training and retention will be considered as a part of the taskforceâ€™s work programme.Â

Bus Éireann has actively sought to recruit more contractors and drivers for the School Transport Scheme. A national and local media campaign was launched earlier this year to attract professional drivers. Further information can be found at: [Bus Éireann | Becoming a School Transport Provider](#)



Thank you for your submission on the National Development Plan and health services in the wider Mid-West region.

This Government is fully committed to improving services in the Mid-West region. There has been significant investment to increase capacity at University Hospital Limerick (UHL). A package of wide-ranging measures is being implemented which are aimed at increasing capacity as well as reforming the health system in the Mid-West, including increased staffing levels and further implementation of safe staffing.

Investment in the hospitals in the region has increased from €370 million in 2019 to over €689 million in 2024. The UHL budget has increased from €265 million to over €507 million in the same period. This investment has enabled staffing across the region to grow by 42% from 4,140 Whole Time Equivalents (WTE) in 2019 to 5,873 WTE in April of this year. Almost €142.2 million in capital investment was drawn down in the region between 2020 and 2023.

Since January 2020, 182 new beds have opened in acute hospitals in the Mid-West region with 140 of these beds in UHL. The Minister was delighted to officially open the first of two planned 96-bed blocks at UHL this week, with a commitment to deliver 572 new inpatient beds in the region between 2020 and 2031.

In May 2024, HIQA was requested by the then Minister for Health to conduct a review of urgent and emergency care in the mid-west region with the primary objective of ensuring safe quality acute care in the region.

On 30 September, HIQA published its independent and expert review of urgent and emergency healthcare services in the HSE Mid-West Region.

The HIQA report clearly identifies that the lack of sufficient acute inpatient beds in UHL and the Mid West region is the core issue that needs to be addressed urgently.

The report presents three options for how to best address the capacity gap in the Mid-West:

- Option A: expansion of capacity at UHL on the Dooradoyle site;
- Option B: the extension of the UHL hospital campus to include a second site in close proximity under a shared governance and resourcing model;
- Option C- the development of a Model 3 hospital in HSE Mid-West, providing a second emergency department (ED) for the region.

The Report, advice and supporting documentation are being considered in full, and the Minister will report back to Government as soon as possible.

I wish to advise that at the October Meeting of Galway City Council held on Monday 6th October, 2025, the Members passed the following resolution:

"Extension of Free Fares for Under-9s to Commercial Bus Operators

That Galway City Council supports the immediate inclusion of Commercial Bus Operators (CBOs) in the Child Leap Card Scheme, which provides free bus travel for children under nine.

Council notes:

CBOs are an essential part of Ireland's public transport network, already delivering the Young Adult Leap Card and the Department of Social Protection's Travel Pass.

Their exclusion from the under-9 scheme creates unfairness, particularly for rural families who depend on them, and risks a two-tier bus system.

Extending the scheme would cost just €1 million, a modest sum that would support families during the cost-of-living crisis and encourage sustainable travel habits among children.

Therefore, Galway City Council calls on the Minister for Transport and the National Transport Authority to:

1. Urgently include CBOs in the Child Leap Card Scheme.
2. Ensure a fair and consistent transport policy that treats all children equally, regardless of geography or bus service used.

I note that you have also directed your request to the Garda Commissioner. The establishment of any Garda unit is an operational matter for the Commissioner who, under Section 33 of the Policing, Security and Community Safety Act 2024, determines the distribution of Garda personnel throughout the State.

The Minister has no role in these independent functions and is unable to direct the Commissioner on the deployment of resources.

I am advised that, as of the end of August 2025 (the latest date for when figures are available), there were 17 Garda members of all ranks assigned to the Limerick Divisional Drugs Unit. This is an increase of almost 21.5% since the end of 2015, when there were 14 members assigned.

Thank you for your recent correspondence in relation to the request from Limerick City and County Council calling for the urgent prioritisation and full delivery of the Rathkeale to Limerick City Greenway in advance of the Ryder Cup in 2027, the contents of which I have noted.

As Minister for Transport, I have responsibility for overall policy and exchequer funding in relation to greenways. The planning, design and construction of individual National and Regional Greenways is a matter for Transport Infrastructure Ireland (TII), in conjunction with the relevant local authority.

My officials have advised Greenway schemes are currently being progressed between Rathkeale and Patrickswell and Patrickswell to Colbert Station by TII in conjunction with Limerick City and County Council. Both schemes are at Phase 1 Concept and Feasibility of the TII's Project Management Guidelines – Timelines for completion of such projects is current unknown due to the uncertainty associated with progressing such projects through the statutory process and it will not be possible to achieve full delivery of the "Rathkeale to Limerick City Greenway" in advance of the Ryder Cup in 2027.

My Department is supportive of these schemes which received €350,000 in funding in 2025.

Thank you for raising this matter with my Department.

Thank you for contacting me about Ash Dieback. Since the first finding of Ash Dieback disease in Ireland, my Department has provided support to owners of ash forests impacted. Currently, a package of measures to assist ash forest owners, including financial aid as outlined within an Action Plan approved by the Government in April 2024, offers relief and incentives to ash forest owners to deal with this important issue. The overall financial aid for ash dieback potentially amounts to €237 million, including the €79.5 million Climate Action Performance Payment.

A Taskforce was established in 2024 with responsibility for overseeing the implementation of the Ash Dieback Action Plan. This Taskforce is a forum comprising of officials from my Department and stakeholders including ash forest owners. Useful clarifications have been made and actions agreed to progress the implementation of the Plan to date. The role of the Taskforce is to ensure that the Plan is implemented in an effective way, with a coordinated response and resolution of obstacles to implementation.

The Action Plan was welcomed by many stakeholders and interest in the package is reflected in an increase in interest in the reconstitution scheme since the announcement.

I outline below some of the details of the enhanced financial package now available to ash forest owners.

- 100% increase in the site clearance grant rate, from €1,000 to €2,000 per hectare.
- Enhanced replanting grant rates under the new Forestry Programme 2023-2027; depending on forest type. For conifer forests (FT12) that amounts to €3,858/ha. If you choose to replant with native trees, that rate is €6,744/ha, and it is €8,555/ha for agroforestry. In addition, grants of €2,880/ha are also available for Deer Fencing in respect of Forest Type 1 to 11.
- In addition, the Climate Action Performance Payment (CAPP) entitles ash forest owners who clear their sites and replant to a further €5,000 per hectare.

I refer to the recently adopted resolution by the elected members of Limerick City and County Council of 30 September 2025 pertaining to affordable and social housing income limits.

To note, eligibility criteria vary for affordable schemes differ from scheme to scheme with many not subject to any minimum income limits.

Local Authority Affordable Purchase Scheme

For affordable homes purchased under the Local Authority Affordable Purchase Scheme (LAAPS), purchasers pay a price for their new home in accordance with their purchasing power, calculated as outlined in Affordable Housing Regulations of 2023. Homes made available under LAAPS will have a minimum sales price. There are no specific income thresholds for this scheme.

First Home Scheme

The First Home Scheme is also a shared equity scheme and makes home ownership achievable by bridging the gap for first-time buyers and other eligible homebuyers between their deposit and mortgage, and the price of their new home within regional price ceiling which are available at <https://www.firsthomescheme.ie/about-the-scheme/property-price-ceilings/>. There are no specific income thresholds for this scheme.

Local Authority Home Loan

The Local Authority Home Loan (LAHL) is a Government-backed mortgage for first-time buyers and certain other eligible applicants who have been refused a mortgage or have received an insufficient loan offer through a regular mortgage lender. To qualify for LAHL an applicant must have an annual gross income of not more than €70,000 for a single applicant and €85,000 for a joint applicant.

Cost Rental Homes

In the case of Cost Rental homes, in August 2023 the Government increased the income thresholds for new tenancies, with net household income limits rising to €66,000 in Dublin and €59,000 elsewhere. These were introduced across the Cost Rental sector from 1 August 2023, replacing the former national net income limit of €53,000. The increased thresholds broadened the cohort of people eligible to avail of cost rental.

Other measures such as the Vacant Property Refurbishment Grant, Local Authority Purchase and Renovation Scheme, and the Ready to Build Scheme are also available to help make home ownership more affordable. These measures under Housing for All are primarily aimed at supporting affordability constrained households, first-time buyers and Fresh Start applicants. These supports are regularly reviewed by my Department. None of these additional measures have income limits.

In relation to social housing, the 2011 Social Housing Assessment Regulations prescribe maximum net income limits for each local authority, in different bands according to the area concerned, with income being defined and assessed according to a standard Household Means Policy. The 2011 Regulations do not provide local authorities with any discretion to exceed the limits that apply to their administrative areas.

Under the Household Means Policy, which applies in all local authorities, net income for social housing assessment is defined as gross household income less income tax, PRSI, Universal Social Charge and Additional Superannuation Contribution. The Policy provides for a range of income disregards, and local authorities also have discretion to decide to disregard income that is temporary, short-term or once-off in nature.

The determination of whether an applicant household meets the income criteria is based on a calculation of their preceding 12 months' net average income prior to the date of receipt of application. This ensures that the most comprehensive picture of a household's current and previous income is available at the point of carrying out the assessment.

It remains open to a household to apply for social housing support at any stage, subject to meeting the eligibility and need criteria at the point at which they apply. This ensures households experiencing changed circumstances prior to or since a previous assessment, including material changes in income, can be reassessed in light of such changes. However, such reassessments must also take account of the household income for the 12-month period prior to reassessment.

Housing for All includes a commitment to review income eligibility for social housing. From this review, completed in November 2021, it was recommended moving five local authorities from Band 3 to Band 2, ensuring the income eligibility thresholds better reflect housing costs in those counties. Government also agreed to increase the baseline income thresholds by €5,000 for all local authorities with effect from 1 January 2023. The thresholds thus increased to €40,000, €35,000 and €30,000 for bands 1, 2 and 3 respectively.

The review further recommended the commissioning of research to develop options for a revised or new social housing income eligibility model. The Department received this detailed research, commissioned by the Housing Agency. The scope of the research included examining the existing income limits in the context of current market and population conditions and the suitability or otherwise of the current framework having regard to the significantly changed landscape since the standardised income limits were introduced.

The Department's examination of the report is ongoing. This detailed examination will include consultation with stakeholders and will look at, *inter alia*, how the social housing income limits system interacts with other housing supports and ensure that they continue to target households correctly.


