


Executive Report

October 2025 has seen further activity in the Mayor's Office committed to action and delivery for Limerick.

The Mayor visited Rotterdam in the Netherlands, having been invited to a conference by the European Urban Initiative to engage in a focused policy lab, which involved key discussions around Limerick potentially accessing European funding.

The Mayor also visited London to partake in the inaugural class of the Bloomberg London School of Economics (LSE) European City Leadership Initiative. This is the first-ever professional leadership and management programme designed specifically for Mayors and municipal officials. The Mayor is one of 30 Mayors and city officials who hail from 17 countries, serving over 21 million residents, selected to participate.

The new 96-bed block at University Hospital Limerick was opened on 14 October, which the Mayor attended, along with meeting Minister for Health Jennifer Carroll MacNeill.

A Mayoral Reception celebrating the 30th anniversary of the Irish Chamber Orchestra's presence in Limerick was held. The Irish Chamber Orchestra (ICO) first relocated to Limerick from Dublin back in 1995 when the Irish World Academy was being established at the University of Limerick. The ICO has since toured the world, recording and showcasing local and national creativity on a global stage.

On the international front, the Mayor was pleased to welcome Ambassadors from both Chile and Ukraine to City Hall for bilateral discussions.

Delivery on the Mayoral Programme continues, with the Limerick Mayoral Advisory and Implementation Committee convening for its seventh meeting this month.

The Mayor, along with members of Limerick City and County Council's Executive Team, also travelled to Dublin in October for the second Limerick Mayoral and Government Consultative Forum. Chaired by Minister for Housing, Local Government and Heritage, James Browne TD, the meeting was attended by the Mayor of Limerick John Moran, Minister

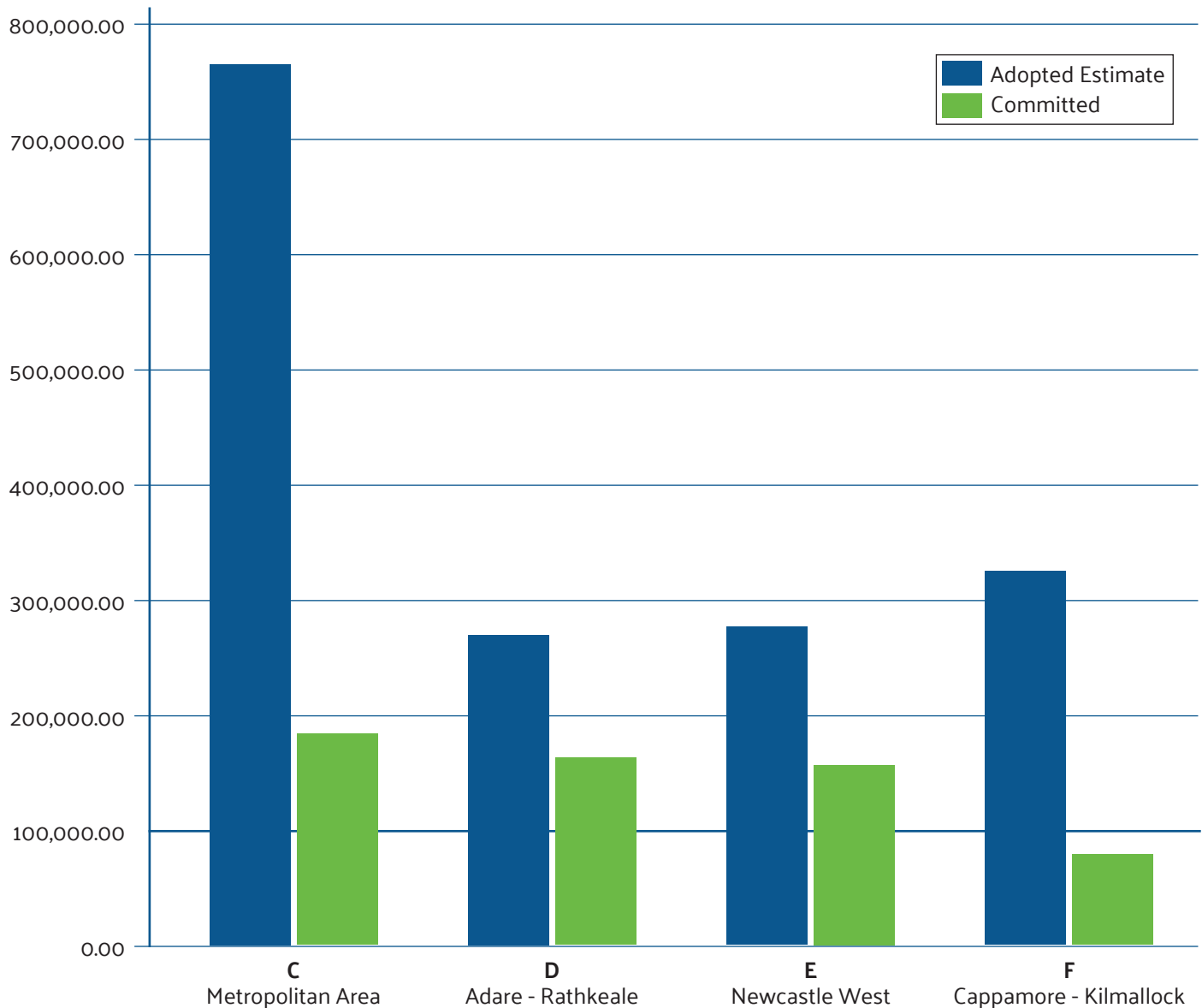

Enterprise Infrastructure

Pathway to Innovate

Innovate Limerick is a lead partner in the Pathway to Innovate Midwest programme and plays a central role in weekly project management meetings with key partners - Skillnet Ireland, Skillnet Innovation Exchange and Industry Research and Development Group (IRDG).

The organisation also oversees advertising, marketing, and event management activities related to the programme. A key aspect of Innovate Limerick's contribution is driving participant engagement and attendance. Notably, Innovate Limerick achieved the highest attendance rate among all participating partners, including Research Development Innovation (RDI) Hub, Kerry; Ludgate Hub (West Cork), Platform 94 (Galway), Republic of Work (Cork), Advancing Innovation in Manufacturing (AIM) Centre (Sligo).

National Innovation Summit

On 23 October Innovate Limerick was represented at the Innovation Summit in Galway. The event was organised by Skillnet Innovation Exchange, and it brought together 250 innovators and business leaders focused on innovation, digital transformation, sustainability, talent and leadership. This was a hugely successful event and covered topics such as:

Exciting Progress on Coonagh to Knockalisheen Road Scheme: Partial Opening of Dual Carriageway

Limerick City and County Council and the Department of Transport were pleased to announce the opening of a new section of dual carriageway from the Tesco Roundabout at Coonagh to the newly constructed roundabout on Cratloe Road on 07 October. This partial opening represents a significant step forward in improving connectivity and traffic flow in the area. While substantial completion of the full dual carriageway cannot take place until the entire route between Coonagh and Knockalisheen is finished, this development will provide immediate benefits to road users and the local community.

2. Active Travel

Net Zero Cities Twinning Learning Programme

Active Travel in Limerick City and County Council recently hosted a delegation from Tampere, Finland, for a two-day visit on 09 and 10 October.

The Tampere delegation met with Council teams, community representatives and local stakeholders to exchange experiences and best practices and discuss how each city is supporting a transition to more inclusive, people-centred mobility. Presentations and workshops focused on areas such as behavioural science, communications and the design of accessible walking and wheeling routes across Limerick.

Limerick Cordon Report 2024

The Limerick Cordon Report 2024 published by the National Transport Authority (NTA) this October presents a detailed snapshot into inbound traffic flows into the city on weekdays between 07:00 and 19:00.

Key findings:

- Cycling and walking are up: Since 2022, inbound cycling trips increased by 31% (from 838 to 1,100 in 2024) and pedestrian trips grew by 37%.
- Sustainable travel is increasing: The total share of sustainable journeys (walking, cycling, bus and rail) rose from 23% in 2022 to 27% in 2024.
- Busiest routes: Thomond Bridge was the busiest route for cyclists, followed by Sarsfield Bridge and Shannon Bridge Roundabout.

4. Rural Development

Limerick City and County Council has been awarded funding for two large-scale rural regeneration and development projects in Rathkeale and Kilmallock, under the Rural Regeneration and Development Fund (RRDF Category 2, 2025), Department of Rural and Community Development and the Gaeltacht (DRCDG). The funding award was announced in October 2025. A grant of €346,480 is awarded for conservation and re-purposing of the former Bank of Ireland on Main Street Rathkeale, to bring the project to "shovel-ready" stage. This grant will fund a conservation-led integrated design team to fully develop the project design and bring it through the planning process. It will then seek funding for the capital works to restore and re-purpose the former bank as multi-functional space for co-location of enterprise, community and civic activities and services.

A grant of €886,176 was awarded to the historic Merchant's House building, a Medieval House, which has been long-term derelict and the site around the Merchant's House on Sarsfield Street, Kilmallock. The grant is to bring this large-scale project to "shovel-ready" stage including design, planning and other consents so that the project is ready for funding for capital works. The final project will conserve the heritage buildings, renovate and re-develop parts of the buildings and expand economic, community, civic, heritage and tourism-related activities on this site. The project will be delivered by Limerick City and County Council in collaboration with the Office of Public Works, which is responsible for the care of the Medieval House fronting onto Sarsfield Street, and the National Monument Service, the Department of Housing Local Government and Heritage, the Guardian/Owner of the heritage building. This is a transformative project for the revitalisation and development of Kilmallock town centre - one of Limerick's most important heritage towns.

Tourism General

Limerick City and County Council's Tourism Plan (2025 – 2030)

- Limerick City and County Council's Tourism Plan (2025 – 2030) and associated documents were published on the Limerick.ie website on 15 October.
- This Plan will now be in place until 2030, providing the guiding framework for the future development of tourism, within the remit of Limerick City and County Council.
- This plan is a roadmap built on creativity, sustainability, and collaboration to shape the future of tourism in Limerick city and county.

- At the heart of the Plan is the concept of 'ReThinking Tourism' - a commitment to telling the Limerick story in new and creative ways, building on Limerick's reputation for innovation, authenticity, and memorable experiences.
- The Plan introduces 'Project 10', a strategic roadmap comprising of ten key focus areas that will guide the development of tourism across the city and county.
- These projects will be delivered collaboratively across multiple Council directorates and with external partners, ensuring that tourism reflects the aspirations of both the local community and the wider industry.

Limerick City Walking Tour – 'Explore Limerick: Stories, Streets and Heritage'

- A review of Limerick City and County Council's 90-minute walking tour (which was available seven days a week in Limerick City between June and September 2025) was organised with the Limerick Civic Trust.
- Led by expert guides from the Limerick Civic Trust, this immersive experience took participants through the heart of the city, exploring iconic landmarks such as King John's Castle, St. Mary's Cathedral, the Treaty Stone, Arthur's Quay Park and the scenic River Shannon.
- This initiative provided visitors with a fantastic opportunity to explore the city and uncover its rich history with the tour providing centuries of stories and landmarks, thereby enabling tourists to discover how Limerick's unique quarters have evolved over time.

Virtual Mapping of Limerick Greenway

Halloween 2025

In 2025, the city and county of Limerick staged an expanded and ambitious Halloween celebration. The Festivals and Events Department worked with creative organisations and communities to deliver a month-long programme of activities blending folklore, fire-arts, storytelling and family fun. The programme included funding from Fáilte Ireland's "Ireland, Home of Halloween" Pilot Destination Scheme which enabled the scale of offering to increase. Highlight events included interactive theatrical experiences, fire shows, storytelling sessions steeped in Samhain tradition, a city-pumpkin patch and countryside hubs around the county.

The Limerick Home of Halloween programme featured the following:

- Magic and Mortality: Halloween at the Hunt Museum.
- Harvest Festival and Urban Pumpkin Patch at the Limerick Milk Market.
- Curious State Theatre's Morbid and Sons Street Performances at Little Catherine Street and Bedford Row.
- ROGU Arts LTD Mobius: Story of the Book of Fire at Lough Gur and Desmond Castle, Newcastle West.
- Newsail's Night-time Kayaking Experiences.
- Halloween Carnival and Trick or Treat Trail at Wickham Way.
- Barnagh Halloween Festival.
- Halloween at Lough Gur.
- Ghoul Acting at Treaty City Brewery.
- Spooktastic 82nd birthday of Irish Coffee at Foynes Flying Boat Museum.
- Haunted House Tours by Limerick Civic Trust at The People's Museum.
- Samhain Tales by the Limerick Fireside at King John's Castle, Kilmallock Library, Desmond Castle Newcastle West, The People's Museum and The Hunt Museum.
- Halloween Screams at The Belltable.
- Newcastle West Halloween Festival.

The programme also featured the return of the gigantic 23-foot mythical figure Con Mór (a creation by Macnas) which appeared at King John's Castle in Limerick from 18 October and included five nights of illumination

and entertainment. Families, thrill-seekers and folklore enthusiasts were invited to immerse themselves in the city's dark textures of myth, fire and creativity. The programme sought to reinforce Limerick's reputation as a cultural event destination rooted in a modern reinvention of the ancient Samhain tradition.

Another apex event as part of Halloween in Limerick was the Fire and Shadows Procession by Lumen Street Theatre. The procession transformed the medieval streets of Limerick into a spectacle of illuminated mythological beings, supernatural characters and theatrical fire-art. The theme 'Some bones won't stay buried' referenced the legendary figure of Patrick Sarsfield, portrayed as the 'Bonelord' astride his skeletal steed, leading the parade through the city centre. The route included the medieval quarter of Limerick: starting around King John's Castle/Convent Street, via Bridge Street and Patrick Street, across quays and culminating at Merchant's Quay/Potato Market where a dramatic fire-show presentation took place. This event invited the public to dress up in costume and embrace the ancient Samhain atmosphere. Thousands of spectators lined the route, drawn by the spectacle of lanterns, fire-actors and a blending of folklore, performance and community spirit.

Other highlight events as part of Halloween in Limerick included the very popular Scare Factory, Castleconnell Halloween Frightfest, Curraghchase Pumpkin Patch, Liskennett Halloween Farm and Witch Hattie O'Goodspell's House at the Jetland Shopping Centre, Headless Horseman of Rathkeale Parade and Woodlands Pumpkin Patch.

Halloween in Limerick Marketing Campaign

- A competition ran in conjunction with the Absolute Hotel to drive traffic to our dedicated "HalloweenInLimerick" social media channels.
- Radio advertising campaign rolled out across local and national stations – Live 95, Spin South West, Beat, Today FM and 98fm to amplify the messaging that Limerick was going big for Halloween this year. Come to Limerick – the Home of Halloween!
- Feedback on Halloween in Limerick campaign has been very positive, the depth of programming this year was enhanced, and the public have bought into this, with a lot of events that were sold out, demonstrating a strong appetite for families in particular to embrace Halloween in Limerick.
- The Festivals and Events team also hosted two influencers on behalf of Fáilte Ireland, bringing them around Limerick to Halloween-themed events to give them a flavour of Halloween in Limerick and the Home of Halloween in Limerick 2025 programme. Feedback from both influencers was very positive and the hope is that this will translate to positive exposure for Limerick when they post about their experiences. One of the influencers (Kelly Prince Wright) has a following of 1.3 million followers on Instagram alone, so it was a fantastic opportunity to showcase Limerick to her and tap into her audience of international followers.
- Press release was circulated from the Communications Department to highlight the launch and a follow up PR was issued on the 14 October to keep the momentum building towards key programming events.
- Web Content went live with the full list of programming events scheduled to take place over the five-week campaign.
- The launch was supported with tangible collateral – maps and tent cards that were distributed to pubs, hotels, visitor attractions and libraries across the city and county.

Christmas in Limerick 2025

- The theme for this year's campaign is Together for Christmas in Limerick, this will be woven into all content, Press Releases, Digital Guide, Social Media posts, Competitions, etc.

The Festivals and Events Department supported the following festivals and events:

Bualadh Bos Children's Festival

The 11th Bualadh Bos Children's Festival took place from 01 to 11 October at the Lime Tree Theatre and Belltable, plus schools, libraries and community venues across Limerick. The Bualadh Bos [Children's Festival](#) is an annual arts festival in Limerick for young audiences, featuring professional theatre, dance, music, and workshops. It is the only festival of its kind in the mid-west and aims to make world-class arts accessible to all children and families in the city and county. The festival also included community collaborations, school programmes, and initiatives like the Pay It Forward campaign to ensure wider participation.

Some highlights of this year's festival were:

- Revisiting the Banshee – new film project by artists Michael Fortune and Aileen Lambert featuring stories told by children from Limerick schools.
- Shimmer – immersive theatre piece for very young audiences by Anna Newell Theatre Adventures.
- Leaves – show by Branar about an old oak tree and a young sapling.
- The Little Prince – adaptation for children and families by The Egg (UK).

Ballyhoura Walking Festival and Joyce Brothers Music Festival

The 29th Ballyhoura Walking Festival and Joyce Brothers Music Festival, the longest-established Walking Festival in Ireland, ran from 02 to 05 October. For the fifth consecutive year the walking festival was held in tandem with the Joyce Brothers Music Festival, which brings a strong cultural and music dimension alongside the

outdoor activity. The combined event emphasises nature, outdoor exploration, heritage, community, music and local culture.

The 2025 programme was diverse – catering for seasoned walkers, families and those looking for gentler experiences. Some highlights included:

- The Sunrise to Sunset Ballyhoura Challenge: over 42km, 12+ hours, 1,500m+ elevation gain.
- Early-morning Dawn Chorus Sunrise Walk to Seefin to the summit of Seefin.
- Moonlight Walk on Saturday evening for atmospheric forest and historic-site exploration.
- Yoga Walk, Alpaca Walks and Farm Activities.
- Guided heritage and landscape walks: e.g. medieval town of Kilmallock, Lough Gur tours, the Annes Grove Gardens and Doneraile Park.
- Opening Gala Night of the Joyce Brothers festival.
- Traditional concerts, workshops (instrument master-classes, singing, sean-nós dancing), pub sessions, heritage walks connected to the Joyce Brothers legacy.
- Intercultural Food Fair in the town of Kilfinane: local-resident participation, global flavours.
- Bug Safari for families at Griston Bog and other nature-based family activities.

Cook Medical Mini Marathon

The 2025 Cook Medical Mini Marathon took place on 05 October at the University of Limerick, attracting over 3,500 participants for the 5km and 10km races. The event featured participants of all ages and abilities, raising over €60,000 for local and national charities through participants' chosen charities via the Give2you platform. Dymphna Ryan was a notable winner, finishing first in the 10km women's race and Karl Fitzmaurice won the overall 10km race with a time of 31:28. Notable individual fundraisers included Megan O'Donnell (€3,179.94 for the Irish Lung Fibrosis Association) and Rebecca Moynihan (€2,366.00) for Milford Care Centre. The Festivals and Events Department proudly sponsor the Mini Marathon.

Rose Fitzgerald Kennedy Autumn School

The 4th Rose Fitzgerald Kennedy Autumn School, an annual event held in Bruff and its surrounding area, took place from 24 – 26 October. This year is the 30th anniversary of the death of Rose Fitzgerald Kennedy (mother of President John Fitzgerald Kennedy). Inspired by the local roots of the Fitzgerald-Kennedy family, the school explores the life of Rose Fitzgerald Kennedy and the broader history of Irish-American emigration, with a special focus on women's experiences. The three-day event features discussions, talks, music, and cultural events at locations like the Thomas Fitzgerald Centre and Lough Gur. Some of the key events from the 2025 Festival included talks from speakers including Kathleen Kennedy Townsend and American historian Barbara Perry with host Marty Morrissey and a session on the impact of America on Irish female identity, a session on the 1998 Good Friday Agreement, a Fitzgerald Community Breakfast in the Honey Fitz Theatre, an arts exhibition, a local folklore project at Lough Gur on the Magic of Lough Gur including a parade led by the City of Limerick Marching Band, and a concert. The event concluded with a concert in the Thomas Fitzgerald Centre on Sunday evening, featuring the Bruff Branch of Comhaltas Ceoltóirí Éireann, and closing remarks by the school director, Declan Hehir.

Irish Open Draughts Championship

The Irish Open Draughts Championship was held at the Great National South Court Hotel in Limerick City from 25 to 27 October. The Three-Move restriction tournament was played over eight rounds, with three sections, Masters, Seniors and Intermediates. The tournament was officially opened on Saturday morning by the Minister of State for Older People and Housing, Limerick's Kieran O'Donnell TD. The overall winner was Nadiya Chyzhevska, Restricted Three-move Women's World Champion 2024. The Festivals and Events Department proudly sponsored the Irish Open Draughts Championship 2025.

EVA International

The 41st EVA International, which ran from 29 August to 26 October 2025, in Limerick, was titled "It Takes a Village" and explored themes of social justice, state and government, and the environment through exhibitions at thirteen venues across the city. Curated by Eszter Szakács,

the biennial featured new commissions and existing works by Irish and international artists, focusing on topics like anti-colonialism, the climate crisis, and communal alternatives for property and economy.

Key themes and focus were:

- Social justice and political issues: The biennial engaged with themes of state and government, Palestine, Europe, war, and conflict.
- Environmental concerns: Several works addressed the climate crisis, land, and the interconnectedness of humans and non-humans.
- Community and alternatives: The program explored collaborative partnerships and communal alternatives for the economy and property.

Programme highlights included:

- Guest Programme: Titled It Takes a Village, this was a central part of the exhibition, featuring artists like Marwa Arsanios, Ana Bravo Pérez, Yazan Khalili, and Anikó Loránt.
- New commissions: The event included new works commissioned by EVA International, along with existing pieces from acclaimed artists.
- Irish and international artists: A significant portion of the participating artists were from Ireland.
- EVA Platform Commissions: These commissions focused on artists' developing practices, with recipients like Olivia Normile receiving support for their work.

This edition marked the implementation of EVA's new Strategic Plan (2025-2030), prioritizing national and international engagement, local impact, and organizational sustainability.

Industry Event – Linz Learning Journey

The Chief Executive Officer (CEO) Discover Limerick DAC and General Manager, King John's Castle attended an International Learning Journey to Linz, Austria. Supported by Fáilte Ireland the objective of the trip was to strengthen the leadership and creative direction of King John's Castle by investing in the professional development of its management team.

Linz has been identified as a city with notable similarities to Limerick—both are riverside cities with rich medieval heritage, strong cultural identities, and a growing focus on creative placemaking and experiential tourism.

This learning journey exposed the management team to internationally recognised models of visitor experience, with a particular emphasis on animation, storytelling, and immersive heritage interpretation. By engaging with best-in-class attractions and cultural institutions in Linz, the team gained valuable insights into how similar cities have successfully activated historic spaces, increased footfall, and attracted family audiences through innovative programming and performance.

The ultimate goal is to inspire and equip the King John's Castle team to elevate the site's animation offering, optimise the use of its courtyard and medieval architecture, and lead the development of a more engaging, high-quality visitor experience that reflects international best practice.

Industry Event – Avea Conference

On 13 and 14 October the CEO, Commercial Manager, and Sales and Business Development Manager from Discover Limerick DAC, along with the General Manager of King John's Castle and Acting Manager of Adare Heritage Centre, attended the two-day Association of Visitor Experiences and Attractions (AVEA) Conference in Waterford.

The annual event gathered over 220 leaders from across Ireland's tourism and hospitality sectors to spotlight the country's thriving visitor economy and the vital role attractions play in shaping Ireland's tourism offering.

Clare Limerick Network Event

The CEO, Sales and Business Development Manager, and General Manager of King John's Castle attended the Fáilte Ireland Industry Networking Event at the Strand Hotel, Limerick.

Organised by Fáilte Ireland in collaboration with Limerick City and County Council, the event brought together over 100 tourism businesses from Clare and Limerick to foster collaboration and joint promotion of the region. Noise

- Presented the Environment Section's approach to reviewing noise for planning applications relating to proposed new wind energy developments at a workshop for the elected members on 20 October.
- Limerick City and County Council has won a highly prestigious acoustics accolade at the John Connell Awards 2025 at Westminster Palace, London, (22 October).

The Council, in partnership with Noise Consultants Limited, were awarded Highly Commended in the John Connell Soundscape Award 2025 for their Castletroy Greenway Pilot Acoustic Study, funded by the Department of Climate, Energy and the Environment.

The Pilot combined innovative sound measurement and analysis, and citizen engagement to investigate the Castletroy Greenway's acoustic environment to inform recommendations for improvements such as strategic tree planting to enrich natural sounds.

The study was acknowledged for developing a new model for the assessment of tranquil and vibrant sound environments which is being used to investigate green spaces under the Council's Limerick Agglomeration and County Limerick Noise Action Plans 2024-2028. The Executive Scientist collected the award on behalf of Limerick City and County Council.

Customer Services

The following figures highlight the activity within the contact centre throughout the month:

- Customer Services Call Centre answered 9,885 calls. This represents an average of 429 per day, with the number of calls reaching as high as 669 on one particular day. 85% of calls were handled at first point of contact.
- A total of 3,921 emails were processed through our Customer Services email platform.
- 3,678 cases were created, with 821 of these logged on behalf of Public Representatives. Customer Services staff logged 65% of the cases created.
- 3,698 cases were closed, with 788 of these being cases logged by Public Representatives.
- The logging of cases through the MyLimerick portal continued, with a total of 179 cases being logged. Of these, 170 were submitted by Public Representatives.
- 98% of Housing Maintenance cases for the Metropolitan District of Limerick were logged by Customer Services staff in the Dooradoyle and Merchants Quay offices.
