


Executive Report

December was a particularly active period for the Mayor despite being a “short month”. The busy diary reflected a strong focus on delivery before the year end, stakeholder engagement, civic leadership, and negotiations with Government to ensure that funding already secured for Limerick was not lost. The Mayor was particularly pleased to hand over a donation of €30,000 to the Marie Keating Foundation coming from the proceeds of the annual Mayoral charity dinner.

Throughout the month, the Mayor continued to advance the objectives of the Mayoral Programme. This included the usual monthly engagement with Council management and officials, Government Departments, statutory agencies, community organisations, international partners, and the wider public. Work was also progressed to get legal clarification on how governance changes to enhance delivery might operate in a local authority with a directly elected Mayor.

A lot of work was taking place behind the scenes. This included getting contracts signed, plans and strategies advanced for launch in early 2026 and implementing new approaches to sorting out how to improve delivery for 2026. After the successful agreement of the 2026 Budget negotiations moved to the national level to secure funds to help deliver the Mayoral Programme items for 2026.

Reducing risk of loss of funding was a key priority in December. A significant part of the Mayor’s work in December therefore involved active intervention to resolve remaining delivery risks before year end. It was important to get as much done or advance optional projects to reduce the risk of the loss or reallocation of funding away from Limerick. In parallel, by engaging directly with Government, the Mayor secured that €6 million of unspent capital funding remained available to Limerick. An interesting optional use of the funds was to buy a new mechanical sweeper for active travel routes in Limerick City West which was delivered just in time for Christmas.

Projects advanced showed innovation in the use of funding. This approach was evident in areas such as proposed land acquisition at Patrickswell, the use of roll over funds to retain critical CCTV services and related jobs in Limerick. Also, alternative uses of the Urban Regeneration and Development Fund (URDF) funding was agreed to advance the €21 million Granary refurbishment at Opera Square.

December also saw significant positive news and progress on future health capacity for Limerick. Key was the Government’s decision following the publication of the Health Information and Quality Authority (HIQA) report. The Mayor especially welcomed that the Government adopted all solutions and especially “Option 3” for a new hospital while he asked that minds remain open on whether that hospital should be a Level 3 as suggested in the report or be upgraded to a new Level 4 and University Hospital Limerick (UHL) transition to a Level 3 for the future. Crucially, preparatory work at Limerick City and County Council regarding new site options had already been led by the Mayor during 2026 even in advance of the publication of the HIQA report and Government decision.

December focus continued to advance major capital and regeneration projects. These included housing construction, transport infrastructure, city-centre regeneration, and public realm investment.

The Mayor exercised statutory authority through the signing of Mayoral Orders. These included progressing land acquisition especially for new housing, appointing design and construction teams, and advancing key contracts, including the Foynes Road scheme beyond Adare. €50,000 was advanced from the Mayoral Fund to ensure the “All we Have are Days” festival returned to Limerick for 2026.

Internal governance changes were also progressed recognising that 2025 had been disappointing from a delivery point of view. Agreement was reached with the Director General about the need to hire a new Programme Manager. The second meeting of the newly created Mayoral Programme Delivery Board was chaired by the Mayor. The Mayor identified his top priority areas for 2026 which were circulated to top management to initiate the development of a quarterly delivery matrix for 2026 with clear ownership and timelines across the organisation. January will see the finalisation of this in time to better assist this year the allocation of the 2026 Mayoral Funds. Board selection and changes at all three of the main Designated Activity Company (DAC) boards and the selection of a new Chief Executive Officer (CEO) for Limerick Twenty Thirty (LTT) were finalised or progressed and just before Christmas a communication was received from James Brown T.D., Minister of Housing, Local Government and Heritage's office on the question of Councillors serving on DAC's and the Mayor wrote back to both the Minister and Councillors rapidly to move to progress to the next stage.

Finally, the month reflected visible civic leadership across both the city and the county. The Mayor, supported by other Councillors, fulfilled sustained representation at community, cultural, sporting, and seasonal events, alongside targeted funding support for local initiatives. A new Mayoral Fund funding scheme for community Christmas events was heavily oversubscribed and in the event a decision was taken by the Mayor to double the allocated funds to €40,000. New light up celebrations and events took place in Cappamore, Kilfinane, Kilmallock and Newcastle West. These engagements reinforced the already successful Christmas celebrations taking place in the city centre and other neighbourhoods right across the county.

As the year came to an end, we know that 2026 must now be the year to move from groundwork to momentum.

December – Key Actions

- **Health Capacity Planning:** Progressed post-HIQA engagement with Government and the Health Service Executive (HSE), building on pre-report site identification work to ensure Limerick is positioned to move quickly on future hospital capacity.
- **Land Acquisition:** Drove contract negotiations for the €4 million acquisition of some 70 acres of lands at Patrickswell as a credible, spend-ready alternative option so as to argue to protect funding and maintain delivery momentum.
- **Opera Square:** Implemented the switch of the use of URDF funding to the Granary project and finalised contractual arrangements for the Office of Public Works (OPW) building which will be the next phase of Opera Square development.
- **Housing Construction:** Advanced social housing delivery through construction contracts in locations including Bruff, Ballyhahill, Barnakyle and Patrickswell.
- **Housing Activation:** Progressed the Limerick Mayoral Housing Plan and Short-term Modular Affordable Rental Transition (SMART) Homes programme, completing the initial customer survey phase, appointing design teams for the first five sites and having the initial design meeting the week before Christmas.
- **Market Quarter:** Appointed design engineers to advance the Market Quarter regeneration project into its next delivery phase.
- **Public Transport:** Engaged with Irish Rail and BusConnects partners at the Limerick Project Ireland 2040 Delivery Board, including frank discussions on the emerging gap between our ambition and national funding plans.
- **Active Travel and Public Realm:** Held in-depth internal engagement on the city centre transport strategy design and public realm improvements to support residential and commercial vitality.
- **Closed-circuit Television (CCTV) and Community Safety:** Secured continuation of the CCTV programme through rollover arrangements, ensuring no loss of funding or service.
- **Community Wardens:** Community Wardens finally deployed and garda van once more secured for Christmas on the streets of the city centre as part of a wider safer, cleaner city initiative.



2. Housing Assistance Payment Shared Services Centre (HAP SSC)

- There were 49,663 active HAP tenancies nationally, managed by the HAP SSC at the end of December.
- A weekly average of 123 HAP tenancies have been set-up during 2025.
- The December landlord payment run was €50.803 million.
- The weekly tenant charge at the end of December, was €3.029 million.
- The Debt Management Unit of the HAP SSC collected a total of €156.28 million in differential rent to end of December.
- The HAP tenant rent collection rate at the end of December was 99%.
- The Debt Management Unit issued 103,562 HAP debt reminder letters in 2025 including 5,305 HAP debt reminder letters issued in December.

Contract B – Sitewide Basement and Parcel 1

- The Parcel 1 building and entire basement achieved Practical Completion. This concludes the second Contract on Opera Square and marks a significant milestone for the Development. Works were concluded under budget, with over 1.2 million manhours completed, accident free.

Limerick City and County Council's Tourism Plan (2025 – 2030)

- In December, Limerick City and County Council's Tourism Department continued the implementation of the Action Plan pertaining to Limerick City and County Council's new Tourism Strategy.
- The Tourism Department held a meeting with the Limerick Museum on 02 December to discuss the action plan, possible collaboration opportunities and the implementation of the strategy over the next five years. Furthermore, the Tourism Department held an internal meeting on 10 December to discuss the implementation of the Plan throughout the course of 2026. This Plan will now be in place until 2030, providing the guiding framework for the future development of tourism, within the remit of Limerick City and County Council and is a roadmap built on creativity, sustainability, and collaboration to shape the future of tourism in Limerick city and county. At the heart of the Plan is the concept of 'ReThinking Tourism' - a commitment to telling the Limerick story in new and creative ways, building on Limerick's reputation for innovation, authenticity, and memorable experiences. The Plan introduces 'Project 10', a strategic roadmap comprising of ten key focus areas that will guide the development of tourism across the city and county and these projects will be delivered collaboratively across multiple Council directorates and with external partners, ensuring that tourism reflects the aspirations of both the local community and the wider industry.

Flavours of Limerick Food Festival 2025

- Stage 1 and Stage 2 payments to suppliers and service providers continued to be processed by the Tourism Department throughout the month. Follow-up emails were issued in relation to all outstanding payments. The Tourism Department are currently awaiting a response from specific suppliers whose payment will be processed accordingly thereafter.

Limerick City Walking Tour – “Explore Limerick: Stories, Streets and Heritage”

- In December, the Tourism Department drafted a Request for Quotation (RFQ) for the continuation of Limerick City and County Council's 90-minute walking tour throughout the summer of 2026. Service providers are requested to provide walking tour services for Limerick City which will be scheduled seven days per week from mid-May to mid-September (inclusive). This will ensure a continuation of the walking service provided in 2025 which took participants through the heart of the city, exploring iconic landmarks such as King John's Castle, St. Mary's Cathedral, the Treaty Stone, Arthur's Quay Park and the scenic River Shannon.

Virtual Mapping of Limerick Greenway

- Global Virtual Asset Management (VAM) Ltd. (in conjunction with the Tourism Department in Limerick City and County Council) have conducted a virtual reality (VR) mapping exercise of Limerick Greenway. The project is now 100% complete.
- 360-degree imagery of the top locations and attractions in Limerick County was captured by Global VAM Ltd. as part of this project and this content has been reviewed and finalised by the Tourism Department.
- Planning for the official launch event in relation to this new tourism product and offering continued throughout the month of December with a cost-benefit analysis being completed in conjunction with a review of the 'Key Performance Indicators (KPI's)' and 'Risk/Mitigation Measures' for this project.

Limerick Greenway – Marketing and Social Media

Christmas in Limerick 2025

The theme for this year's Christmas was "Together for Christmas in Limerick", a six-week destination experience offering over 150 programmed events.

Christmas in Limerick kicked off with the switching on of the Christmas lights with a spectacular Christmas themed procession by renowned street spectacle company LUXe Theatre Company. This format of switching on the lights by incorporating a street theatre procession was a first for Limerick. The procession proved hugely successful

attracting 12,000 people to Limerick city centre. Other firsts this year included a wonderful four weeklong projection of children's artwork onto Bank of Ireland on O'Connell Street and an interactive light and sound installation at the band stand on Howley's Quay. The light and sound interactive installation titled "Making Spirits Bright" featured the work of two Limerick based artists Catherine Ireton and Jose Luis Berna Moya.

The Festivals and Events Section partnered with The Milk Market to ensure there was a city centre Santa Experience. Festivals and Events grant-aided the procurement of a Santa Grotto for the Milk Market which was very well received by the public and will be available to the Milk Market in future years for Christmas at the Iconic Milk Market. Festive favourites like the Toots - Christmas Train, Limerick On Ice and Fossetts Christmas Circus enthralled young and old over a six-week period driving footfall and dwell time in the city. Street shows and costumed seasonal walkabouts entertained city centre shoppers on the weekends. Limerick and Clare Education and Training Board (LCETB) brought live music to Limerick on the community stages.

Christmas in Limerick and Marketing Campaign:

- Seven Press Releases were circulated over the duration of the campaign - from the "teaser" release on 03 November to the final one on 22 December highlighting the Christmas to New Year (Twixmas) period.
- Online digital guide went live in tandem with the launch and the updated version of the guide went live on 01 December, encompassing a list of Night Time Economy themed events happening around the city in December.
- With over 150 events programmed over the duration of the six-week campaign, both city and county wide, Christmas in Limerick 2025 was bigger and better than previous years. The Night Time Economy element was a new initiative this year also and this helped bolster the depth of programming, especially over the Christmas to New Year (Twixmas) period which is an important trading time for many stakeholders around the city.

- A robust social media campaign was actioned - underpinned with weekly competitions to win a night's stay at a local hotel, some paired with tickets to events. We also boosted posts, meaning that we could geo-target specific locations to attract visitors from neighbouring counties to come to Limerick over the festive season. The competitions also incorporated a €500 Limerick Gift Card, response was very positive as seen in online engagement rates - likes/shares/tags, and so on.
- We engaged two Influencers as part of our social media campaign - Emma O'Leary (Life with Tiny Humans) who has over 80,000 followers on Instagram was invited to come to Limerick and capture content on her socials of a 'family fun day out in Limerick'. Her curated itinerary saw her meet Santa at the Milk Market, attend street shows in Cruises Street and visit Limerick on Ice with her family. Our second Influencer Sinead O' Brien (Sinead's Curvy Style) was hired to promote the launch of the "Making Spirits Bright" interactive light and sound installation situated at the boardwalk at Harvey's Quay. Feedback was positive and it secured front page coverage in the Limerick Leader on the Monday edition, 15 December.
- The Children's Art Projections went live on the same night, 10 December - with artwork from Limerick schoolchildren projected onto the Bank of Ireland building on O'Connell Street, Limerick. This initiative was a novel first for our campaign and acted as another pull-factor to attract families into the city over the festive season.
- Tangible branding and collateral in the form of tent cards and Christmas in Limerick flags were actioned, leading to greater visibility and brand awareness around the city.
- A strong radio advertising campaign was executed with media partners Live95 and Spin. This included competitions with Limerick Gift Cards as the prize. These advertisements were also translated to the Irish version and broadcast As Gaeilge, ensuring compliance with our Irish language requirements.
- We also ran a "12 Days of Christmas" competition with Clare FM, giving away €100 Limerick Gift Cards over 12 consecutive days, helping drive campaign awareness in neighbouring County Clare.
- Print media adverts ran throughout the campaign - with four full page adverts featuring in the Limerick Post highlighting Christmas in Limerick events.
- A photographer was hired to capture images from our key events, these will be used as a means of building up a strong asset bank of images that can be used in future campaigns, promotional material, press releases, etc.
- Furthermore, a videographer captured live footage from some of our flagship events, and this formed the basis of a highlights video that was circulated on social media to mark the end of the campaign on 30 December, bringing down the curtain on what was a very successful Christmas in Limerick 2025!

Migrant Support Forum

Throughout December 2025, the Limerick Local Authority Integration Team (LAIT) continued its proactive engagement with migrant communities across Limerick City and County. The team delivered a broad range of supports aimed at enhancing social inclusion, improving access to services, and strengthening community participation for residents living in accommodation centres and in the wider community.

LAIT conducted six visits to accommodation centres, providing residents with direct access to information, guidance, and practical assistance.

The team facilitated two group information clinics, offering structured sessions on life in Ireland, available supports, and community engagement opportunities. These group settings enabled residents to share experiences, ask questions, and learn collectively in a supportive environment.

LAIT also delivered 37 individual information clinics, providing tailored one-to-one consultations. These sessions addressed a wide variety of needs, including documentation queries, integration challenges, employment pathways, and onward referrals to specialist agencies.

The LAIT coordinated the Solidarity Walk, organised under the Limerick United Against Racism (LUAR) campaign as part of the #DiversityIsStrengthLK initiative. Supported by the Migrant Integration Steering Group (MISG), the event served as a public demonstration of collective commitment to supporting individuals and communities affected by racism and xenophobia. Beginning at Limerick City and County Council's offices at Merchant's Quay, the walk progressed across the city's three iconic bridges, symbolising connection, resilience, and the shared responsibility to promote an inclusive and welcoming Limerick.

LAIT, in collaboration with DORAS, also hosted two immigration procedures advice clinics, offering residents clear, reliable information on immigration processes, status updates, and rights and responsibilities under Irish immigration law.

Two English Conversation Clubs were held at the Fernbank accommodation centre, providing residents with a safe, friendly, and supportive environment to practice spoken English.

The conference convenes policymakers, researchers, industry leaders, civil society, and EU project representatives to discuss how to turn strategy into action.

- This solidarity walk, organised by the Limerick United Against Racism (LUAR) campaign is an initiative of the Migrant Integration Steering Group (MISG), which is a network of statutory agencies, community and voluntary organisations and migrant representative and support groups.

- The Community Integration Forum (CIF) end of year meeting took place on 09 December at The Strand Hotel. The Integration Health and Wellbeing Team made a presentation to the CIF of all the works carried out, by the team at Limerick City and County Council during 2025 and gave an update of the situation to date, comparing numbers with previous years.
- Healthy Ireland supported a home cooking session which took place at The Tait Kitchen with residents of Pier One Hotel. This was delivered by the Limerick Food Partnerships Community Food and Nutrition worker who facilitated both cultural food preferences and basic cooking and nutrition skills. It allowed participants to prepare good healthy wholesome meals for their families, while at the same time giving them the opportunity to save money by being able to 'batch cook'. We would hope to explore some more of these facilities in 2026.
- Attended the culture night at Wickham Way as part of the 'Twilight Thursdays' campaign with the Night Time Economy (NTE) team.

Sláintecare Healthy Communities

In December, programme delivery continued across Sláintecare Healthy Communities with a focus on physical activity for health, health equity and literacy, and community engagement.

The MoveWell programme provided targeted supports for mobility and wellbeing through four sessions:

- Pilates for Chronic Pain and Arthritis at St. John's Pavilion -11 participants
- Breathe Well at Moyross Community Centre - 11 participants
- Move Steady at Moyross Community Centre - 11 participants
- Move Steady at Southill Hub - nine participants.

The Period Equity initiative maintained its delivery and provided additional menstrual products to Ruhama, Athlunkard Rowing Club, Perinatal Mental Health Service Users, and Limerick Mental Health Café to provide additional support to service users over the Christmas period. These actions complement

ongoing education events and community vending machine provision, supporting Sláintecare objectives for equitable access to menstrual resources.

Community engagement was further supported through the Winter Rose Gathering, delivered in partnership with Doras. This workshop explored cultural traditions contributing to inclusive health promotion within migrant communities.

Town and Village Renewal Scheme 2025

On 22 December, the Department of Rural and Community Development and the Gaeltacht announced the four successful applications under the 2025 Town and Village Renewal Scheme. Limerick City and County Council was successful in securing a total of €895,699.

Two projects were approved for funding under the Project Development Measure, which, allows projects to be advanced to a shovel ready stage, and these included:

- Cappamore – Design plan for multi-use community green space (€49,815)
- Croom – Design of public realm and redevelopment of the former Post Office (€50,000).

Under the Main Scheme, two projects were approved for funding for capital works and these included:

- Adare – public realm enhancements, focused on improved access (€300,000)
- Athea – redevelopment of a community building into a modern energy efficient multi-purpose hub (€795,884).

Faith Communities Biodiversity Project

As part of the "Return to Nature" project, Limerick City and County Council distributed pollinator-friendly spring bulbs to participating parishes. Supported by the Heritage Council, this initiative involves 10 church grounds across Limerick promoting pollinator-friendly practices and enhancing biodiversity.

Limerick Wildlife Walls

Island Road in Limerick now features two new murals as part of the Limerick Wildlife Walls project. Created by Draw Out's artist-in-residence Louise Keely, the murals depict the Lesser Horseshoe Bat (Crú-ialtóg bheag) and the Green Hairstreak Butterfly (Stiallach Uaine). These join other biodiversity-themed artworks, such as dragonflies at Grove Island and the fox mural on Athlunkard Street, turning the cityscape into a celebration of nature. This project is funded in collaboration with the National Parks and Wildlife Service.
