**Data Protection Privacy Statement for**

*Submission of personal information in advance of, and/or during workshop(s) for:*

***Limerick Laneways Public Realm Enhancements Project***

**Who we are and why do we require your information?**

Limerick City and County Council seeks to promote the economic, social and cultural development of Limerick City and County and in doing so contribute significantly to improving the quality of life of its people. The delivery of high quality services, tailored to meet the needs of all our customers, remains one of Limerick City and County Council's core objectives and is included in our Corporate Plan. This quality service includes not only the level and quality of service given to our customers, but also the quality of our decision-making processes, the efficiency and effectiveness of our corporate operations, standard of our facilities and our ability to adapt in an ever-changing environment. In order to provide the most effective and targeted range of services to meet the needs of the citizens, communities and businesses of Limerick City and County we will be required to collect, process and use certain types of information about people and organisations. Depending on the service being sought or provided, the information sought may include 'personal data' as defined by the Data Protection Acts and by the General Data Protection Regulation (GDPR) and may relate to current, past and future service users; past, current and prospective employees; suppliers; and members of the public who may engage in communications with our staff. In addition, staff may be required, from time to time, to collect, process and use certain types of personal data to comply with regulatory or legislative requirements.

**Why do we have a privacy statement?**

Limerick City and County Council has created this privacy statement in order to demonstrate our firm commitment to privacy and to assure you that in all your dealings with Limerick City and County Council that we will ensure the security of the data you provide to us. Limerick City and County Council creates, collects and processes a significant amount of personal data in various multiple formats on a daily basis. Limerick City and County Council's commitment is that the personal data you may be required to supply to us is;

- Obtained lawfully, fairly and in a transparent manner
- Obtained for only specified, explicit and legitimate purposes
- Adequate, relevant and limited to what is necessary for purpose for which it was obtained
- Recorded, stored accurately and securely and where necessary kept up to date
- Kept only for as long as is necessary for the purposes for which it was obtained.
- Kept in a form which permits identification of the data subject
- Processed only in a manner that ensures the appropriate security of the personal data including protection against unauthorised or unlawful processing.

**Data Protection Policy**

Limerick City and County Council has a detailed Data Protection Policy, which outlines how we as a public body are committed to ensuring the security of any personal data you provide to us.

## **What is the activity referred to in this Privacy Statement?**

This statement refers to the processing of personal data in respect of submissions made by members of the public subsequent to, and during a workshop, or workshops, for Theatre Lane public realm enhancements under the Limerick Laneways Project.

Written submissions in relation to the consultation should state the name, address, telephone number and email address, if any, of the person or body making the submission.

LCCC do not publish any other personal data on MyPoint, or any other website, for general public viewing.

This statement also refers to the processing of personal data in respect of submissions made by members of the public to various Limerick Laneways Project questionnaires/surveys.

Written responses in relation to these surveys may include the name of the person or body making the submission.

## **What is the basis for making the processing of personal data in this activity lawful?**

In accordance with Article 6.1 (e) of the GDPR, processing is necessary for the performance of a task carried out in the public interest or in the exercise of official authority vested in Limerick City and County Council for the Theatre Lane enhancement scheme under the Limerick Laneways Project.

Please be advised the Limerick Laneways Project is supported within the current Limerick Development Plan 2022 - 2028. The requirement for public realm upgrades to the laneways is supported by existing policies and objectives at European, National, Regional and Local level. Objective LL O1/Pg 70 of Volume 1 of the Development Plan which deals with Place-making, Universal Design and Public Realm states: "*It is an objective of the Council to: a) Promote reuse of vacant buildings and support existing uses within the City Centre; b) Improve connections and maintain linkages within and through the City Centre; c) Promote high design quality and improve the public realm.*". The processing of information will support the implementation of national policy and identify opportunities within the public realm for projects, which will attract funding from the National Development Plan 2021-2030.

## **We require your contact details**

In order to communicate with you, you will be asked for contact details. You do not have to provide all contact details but providing more, such as email, phone, address, makes it easier to communicate. Please note that to help protect your privacy, we take steps to verify your identity before granting access to personal data. These contact details may also be used to verify your identify.

## **What other items of personal data do we need to undertake this activity?**

We do not require any further personal data to undertake this activity.

## **Is the personal data submitted as part of this activity shared with other organisations?**

Limerick City and County Council may, to fulfil statutory or regulatory obligations or in the public interest, from time to time, have to share personal data with other organisations or entities (in Ireland or abroad). Where this is required Limerick City and County Council shall have regard to the security and integrity of the data and will minimise the data shared.

In this process, the data will be shared with the following recipients:

No. Following the workshop(s), the Place-Making Department will create a report listing all the submissions received. In the event of sensitive information being provided as part of the submission, it will be treated as confidential and will not be made public. It will be redacted prior to publication and likewise from any public element of the consultation process.

In this activity, if the personal data is to be transferred to a different country, it will be transferred to the following countries (if there are no countries listed, it is not intended to transfer the personal data abroad):

### **How long is this personal data held by Limerick City and County Council?**

Limerick City and County Council has a detailed record retention policy which goes in to more detail of the time period for which your personal data will be retained by Limerick City and County Council and what will happen to it after the required retention period has expired.

The data processed as part of this activity will be retained for the following period(s):

In accordance with Article 5 (1) (e) of the General Data Protection Regulation and the National Retention Policy for Local Authority Records, data will kept for no longer than is necessary. Records of public consultation, surveys and pre-Part 8 reports will be retained for the duration of the project + 2 years, then they will be destroyed. The final public consultation report will be retained as part of the Part 8 planning file for 20 years, then offer to Archivist. Click [here](#) for further details.

### **What will happen if the requested personal data is not provided?**

All input is welcomed, even if personal data is not recorded.

### **Your Rights**

You have the right to request access to personal data held about you, obtain confirmation as to whether data concerning you exists, be informed of the content and source of data and check its accuracy. In addition, if the data held by us is found to be inaccurate you have the right to change, remove, block, or object to the use of, personal data held by Limerick City and County Council. You also have the right to data portability. In certain circumstances blocking access to data may delay or remove access to a service where the data is required by law or for essential purposes related to delivery of a service to you.
