REPLY:

The preferred option for the Athea Flood Relief Scheme (FRS) was submitted to OPW for formal option approval (PR3) on 15 August 2025. Since then, Limerick City and County Council (LCCC) has regularly requested updates from OPW on the status of this approval process. OPW has responded that the scheme remains under review with no current timeline advised for a decision.

LCCC will now write directly to the Minister of State with responsibility for the Office of Public Works (OPW) to request a formal update on the status of the scheme.
