In the context of this request, the above matter will be given immediate consideration and available locations within the Demesne will be inspected for the areas most suitable for the placing of extra benches.

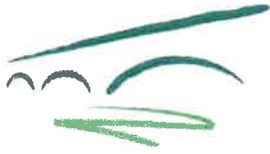
Proposals will be developed and the Environment Section will revert to the members and advise them of proposals prior to any benches being placed in the Demesne.
